Who is West Carrollton?

- Approximately 3900 students
- 410 regular certified and classified staff
- Three communities: West Carrollton, Moraine, Miami Township
- 10 square miles in size
- 59% students Free & Reduced
- 16% special needs students



Who is West Carrollton?, cont'd

- 7 Buildings: 1 Early Childhood; 4 ES including 1 year round; 1 Middle; 1 High School
- Sponsor the West Carrollton Secondary Academy (Community School)
- District wireless WAN independent of ITC provider (3rd party)
- Recipient of Ohio Partnership for Excellence
 Award, 2004 and MBNQA Applicant, 2009

Student Enrollment

- West Carrollton is a Central Enrollment District
- Began process in the 2004-2005 school year
- Purpose was to regain control of the data in an effort to assure data quality
- All students are enrolled at the district central office, and parents or guardians are able to enroll their children year round on a walk-in basis

Immediate Results

- Reduced salaries at the building level, which enabled hiring of a fulltime Enrollment Specialist at Central Office: bottom line, no increase in payroll cost
- Locked down the student management system so that only 4 staff members district wide had (have) complete access
- Restricted views of student information by secretarial staff and unnecessary staff

Immediate Results, cont'd

- Eliminated the "New Student Enrollment Week" immediately prior to first day of school
- Standardized the information parents receive (at enrollment) about the buildings/district
- Eliminated the need for parents to travel to more than one building to enroll students
- Created the "single point of data entry" and thereby established data consistency

Results Over Time

- Enhanced the quality of Data submitted to ODE
- Able to regularly involve Enrollment Specialist in training opportunities
- Developed a resource desk that can resolve legal and ethical issues prior to enrolling students
- Added a Central Withdrawal process to the position

Ongoing Benefit

- Standardized the message, so that we could
- Assure the quality of the data which
- Reduced the amount of time necessary to correct information during every reporting cycle, allowing every building to
- Better utilize staff so that
- We can continuously improve the PROCESS

Our Customers

- Enrolling students is a process, and it is not just completing paperwork, but asking the questions as well:
 - Are they residents?
 - Are they homeless?
 - Are there custody issues?
 - Is there an IEP?
 - Are there language barriers?



Are They Residents?

- Students are considered residents if they live within the geographical boundaries of the school district. These students are considered "active" in all data management systems
- Parents/Guardians must provide Proof of Residency at the time of enrollment. Ohio Revised Code 3316.64 allows for districts to determine residency criteria

Are They Residents?, cont'd

- By definition RESIDENCY is:
 - "A place where important family activity takes place during significant parts of each day; a place where the family eats, sleeps, relaxes, or plays. It must be the place, in short, which can be called "home'."



Are They Residents?, cont'd

- Utility bills (including power, phone, cable, satellite)
- Insurance policies (home, renters, automobile)
- Leases or mortgage documentation
- Other (2 documents with same address, ex. Pay stub and checking account)
- If nothing, then...
- Residency Affidavit (30 day), No Renewal

Are They Resident?, cont'd

- They could be Open Enrolled. Districts are not required to provide Open Enrollment options for students (ORC 3313.98)
- West Carrollton began Open Enrollment this school year (2013/2014) and currently is educating 109 OE students
- Open to students statewide via an application process

Are They Residents?, cont'd

- Parents/Guardians still must provide proof of residency so that funding will flow from correct school district
- Students must be reenrolled every year
- Number of open enrolled students allowed each year is determined by grade level space available and by staffing levels.

Are They Residents?, cont'd

- Districts are still accountable for resident students they do not educate:
 - Foster placed in another district
 - Incarcerated
 - Group home
 - Special needs students
 - ESC placed students
 - JVS students
 - Alternative Education Placements



Homelessness

- Children are homeless if:
 - Sharing housing (doubled up and have no decision making authority in residence)
 - Living in motels, temporary trailer parks or camping grounds
 - Living in a shelter
 - Primary nighttime residence is a private or public space not designed for residency

Living in cars, parks or abandoned buildings

Homelessness, cont'd

- All school districts nationwide are required to follow provisions of the McKinney-Vento Act which defines how homeless children are to be educated.
- Children must be enrolled immediately, even without important documentation
- May attend previous school district of enrollment or district where temporary residence is located

Homelessness, cont'd

- All school districts must employ a Homeless
 Liaison to guarantee unrestricted educational
 opportunities for these children
- District educating must provide education (districts can agree to mutual cooperation)
- Districts are eligible to apply for special assistance grants (block grants) made available to all states

Who Is The Parent?

- Many of our students are from non-traditional family units
- If it is determined at enrollment that a child is from a single parent environment it is imperative that custody be determined
- Who is the RESIDENTIAL parent?
- Who can enroll the child?
- What rights does the OTHER parent have?



Who Is The Parent?, cont'd

- Court orders in MOST cases, specify the residential parent for school purposes
- The real issue arises when parents have never been married and there are no court orders
- The MOTHER is always the default custodial parent
- What happens when the father attempts to enroll children in this situation?

Who Is The Parent?, cont'd

- The role of the birth certificate
- "So, I asked my sister to take care of my kids for me. I gave her a notarized letter I wrote that said it was okay."
- "My EX was a poor excuse for a parent so I threw him out. I don't want him to know where my kids are going to school."
- Grandparents raising children and what they need to know



There Is An IEP In Place

- Students enrolling in a new district with an IEP cannot be excluded from enrolling, even if services for that child cannot be provided
- Special Ed event records must be added as well as recording related service information
- The district of RESIDENCE must provide transportation to the district where education can be provided
- Students are active or considered residents out depending on the educating district

Language Barriers

- Students who are non-English learners cannot be prevented from enrolling in their residential district
- These students can be separated into different classrooms that will provide better learning opportunities
- Districts are required to assess ELL students via the OTELA and are required to participate in OAA and OGT assessments. Home Language survey is completed at enrollment. They are an AMO sub-group on the report card



They're Enrolled; Now What?

- They are assigned an SSID number
- A determination is made about their eligibility for Free and/or Reduced lunch
- If in preschool their poverty level is established
- If in high school, the year the student entered 9th grade is entered
- But what about unusual enrollment circumstances?

Are They Ours, or Yours?

- It is important to realize that state funding flows to school districts based on student information reported to ODE via the October Count Week reporting period (K)
- Ohio counts kids based on ADM

 Average Daily Membership (approx. \$1150.00/day/student)
- With ADM, districts account for all resident children, regardless of their educating district, for days between July 1 and the last day of count week, whether or not they are enrolled or withdrawn



Counting Kids Next Year

- ADE (My acronym) Average Daily Enrollment
- Three Counting Periods and will include absent and unexcused absent just as CS's
 - October Students enrolled between July 1 and the end of October count date
 - March Students enrolled between July 1 and end of February count date
 - June Students enrolled between July 1 and end
 of school year

Variables In Counting

- Duplicate SSID numbers exist at State 3rd party level
- Different enrollment and withdrawal dates between districts
- Different "withdrawn to" information
- Students over 18 years of age dropout
- Inability of courts to keep up with documentation



We Count Everyone Scenario #1

- Student A, a 7th grader, attended resident
 District 1 and was foster placed in District 2
 April 2012
- He was WD to District 3 in June 2012
- Was WD to District 4 in Oct 2012 and then
- WD to District 5 in Feb 2013 and then was
- WD back to District 4 in May 2013

We Count Everyone Scenario #2

- Student B is a resident of District 1
- Student is Foster Placed in District 2 and is
- Open enrolled in District 3 where he is WD at end of school year
- And is Open enrolled back into District 1 for next school year and is WD in Jan 2013 to attend online Community School



We Count Everyone Scenario #3

- Student C is in 9th grade & resident of District 1
- Student Foster Placed in District 2 on 8/17/12
- Returns to District 1 on 8/28/12
- FP back in District 2 on 9/13/12
- Returns to District 1 on 10/11/12
- FP to District 2 on 11/15/12
- Returns to District 1 on 11/26/12

Scenario #3, cont'd

- FP to District 2 on 12/20/12
- Returns to District 1 on 1/7/13
- FP to District 3 on 4/4/13 where he finishes the school year
- 5 different foster placements in less than 8 months
- Resident District must use court documents to reconcile funding



The Issue of Attendance

- Legitimate reasons for "breaks in enrollment"
- Students do quit school and "vanish"
- Resident districts are required to pursue truancy if a student drops out of a CS
- Parents/guardians do not always withdraw children from school
- Many students are withdrawn every year to return to native country
- Issues related to the "revolving door" concept in education

Full Academic Year

- Students are counted in their attending district for testing purposes as long as they have had a continuous enrollment in that district from the last day of October count week through the first day of OGT/OAA testing (the former "120 day" rule)
- Withdrawals for whatever reason, as long as they occurred during this timeframe, are considered a break in enrollment



Assessments

- Pre-School Assessments and the KRA-L are reported to ODE in the October and Year End reporting periods. Beginning this year the 3rd Grade Reading assessments are reported at both times as well.
- The OGT for grades 11 and 12 and the OAA for 3rd grade Reading are reported in October
- The Spring OGT and OAA assessments are reported in year end submissions to ODE

Data Reconciliation

- October Count Week reporting lasts approximately 3 ½ months
- All student enrollments and withdrawals are reported and must be reconciled with other district submissions in order for a district to receive full funding for each student
- Verification and data correction are completed by each district and resubmitted to ODE on a regular basis

In Conclusion

- Districts work with other districts to resolve issues related to enrollments/withdrawals
- Students who do not "belong" to a district for a portion of the full academic year belong to the State for report card purposes
- Districts are required to document and maintain student withdrawals as part of student folders
