as a director on the board of the National PTA. He currently is a director on the board of the New York Says Thank You Foundation.

In addition to his work in the legal field and with schools, Massey has served his community in a variety of ways, including football coach, CPR instructor, emergency medical technician and firefighter. During that time, he served as a Model United Nations adviser. Conference held in the Netherlands.

During his time at Jefferson, Patterson was active in the Jefferson Area Teachers' Association. He has been recognized as an Ashtabula County Teacher of the Year, Ashland Oil Teacher of the Year, Jefferson Village Citizen of the Year, Kent State Ashtabula Alumnus of the Year and

University. He has taught undergraduate courses at Kent State and taught graduate courses at Gannon University.


