If the offense was a felony, at least five years have elapsed since the applicant was fully discharged from imprisonment, probation, or parole or the applicant has had the record of his/her guilty plea, finding of guilt or conviction sealed or expunged. If the offense was a misdemeanor, at least five years have elapsed since the date of conviction or the applicant has had the record of his/her guilty plea, finding of guilt or conviction sealed or expunged.
- The applicant is not a "repeat offender" of any of the offenses listed in 3319.39(B)(1) or 3319.31. A sealed or expunged conviction shall not be counted for purposes of this paragraph. See OAC 3301-20-01(E)(2)(c) for a definition of "repeat offender."

 - e. The conduct and work activity of the applicant before and after the criminal activity;
 - f. Whether the applicant has completed the terms of his probation or deferred adjudication;
 - g. Evidence of rehabilitation;
 - h. Whether the applicant fully disclosed the crime to the state board, the department and the district;
 - i. Whether employment or licensure will have a negative impact on the local education community;
