Teen pregnancy rates have fallen significantly, research shows

In the past decade, teen pregnancy has seen an impressive 55% decline, according to a report by the national research organization Child Trends. This is an acceleration of a larger drop over the past 30 years: In 1991, 61.8 out of every 1,000 females between the ages of 15-19 had given birth, but by 2021, that number was only 14.4 births per 1,000. ODE releasing district Special Education Profiles for 2023

The Ohio Department of Education (ODE) announced last month that it will soon release its 2023 Special Education Profiles, which evaluate school districts on a list of indicators established by the Individuals with Disabilities Education Improvement Act of 2004 (IDEA). The profiles provide schools with useful data for meeting IDEA compliance improvement goals. These indicators encompass areas such as achievement, college readiness and equity. The profiles will be released in two phases, with indicators that require action from schools announced first. The second release, planned for May, will include additional studentoutcome indicators that do not require action. Study hints at broader benefits of arts education

A study of 42 Houston-area elementary schools recently published in the Journal of Policy Analysis and Management provides a glimpse of what further research into arts education might reveal. Researchers were able to measure significant improvements in crucial skills like writing and social empathy and saw less need for disciplinary intervention among students who had access to art, music and other creative disciplines during the school day. 

Follow your vision, mission and goals

A vision statement isn't just a slogan for letterhead or building signage. If you have only thought of a vision in the context of something to "put on stuff," you are missing an opportunity to put your district's vision statement to work.

Districts that have a vision statement are already one step ahead. Usually a result of an organizational assessment and strategic planning process, a vision statement is the "why" of the work. Most employees know how their jobs affect student achievement, but they don't always know what the district's vision is.

Vision is where you want to go, mission is how to get there

A vision statement reflects what you would see if you imagined a perfect outcome. A mission is a statement of the work you need to do to move toward the vision.

For example, the vision of a vacation is lounging on a white, sandy beach. The mission is the work needed to get there — arranging travel, packing and more. Vision inspires; mission motivates.

Why every district needs a vision

Many districts don't have a vision statement because they have not thought of creating one. Mission statements and strategic plans are standard planning tools, but adding a vision statement can inspire and unite.

The process of creating a vision statement should include input from stakeholders. Gather feedback from staff, parents, business partners and community members.

If all district staff know the vision, the team is more unified, especially if there are agreements about how to measure and visualize organizational progress toward the vision. It is essential for staff members to see and get excited about the vision so they can share their enthusiasm and generate support for students and schools.

Communicate your vision

After the district defines its vision, tell people what it is and ensure they know it is driving the work of the district. Add it to your internal communication plan as a goal to ensure that all staff know the district vision and how to measure progress in reaching that goal. Staff members are an important audience because they are a primary source of credible information about trust in the district.

Include staff input as you



develop your plan and revise it as needed. Start by raising awareness among staff with internal communication channels, including employee newsletters and weekly bulletins from the district office. Let people know what the vision statement is and that it was developed by district staff, not communications staff or consultants.

Ask that all employees use the vision statement if they have a regular signature on their email. Provide instructions about proper formatting, font and placement of the vision statement in email signature lines. The result will be a consistent, attractive reminder to internal and external audiences.

Develop talking points for the superintendent and other district-level administrators to use in staff meetings at the beginning of the year. Principals should receive guidance for discussions with building staff. The messages should be consistent with previous communications, but the in-person presentations allow deeper discussions of the meaning of the

vision and its importance.

To help cement the new vision, distribute feature stories, web content and videos to show how someone in the district lives the vision through their work with students or in support departments.

Generate excitement about the new vision

Continue to educate staff and build enthusiasm by adding student voices. Consider hosting a student video contest, which can connect the vision to student achievement and instructional programs. Give students the chance to show how their school is moving them toward the vision of graduation and a successful life. Seek prize sponsorships from local business partners to incentivize student participation and feature the entries on the district website and social media channels and in local newspapers.

The videos can be a rich source of content for community presentations and events. They provide a glimpse of the vision in practice as well as student perspectives and voices.

Evaluate results and update as needed

Use your review and audit processes to ask department leaders and staff about the vision during their routine evaluations. Consider hiring an outside audit firm to do a baseline assessment.

After the launch and the work to promote it, employees should be able to recite the vision, how their work contributes to it and how it measures whether the district is moving in the right direction.

This provides staff members with clarity and direction for their work and pride in being on a team working toward a common vision.

LEGISLATIVE REPORT

General Assembly priorities discussed

Senate President Matt Huffman (R-Lima) recently announced that the overhauling of the Ohio Department of Education is a top priority for him in the coming months. His goal is to begin hearings as early as next week and send the bill to the Ohio House by late February. The Senate later introduced Senate Bill (SB) 1 sponsored by Sen. Bill Reineke (R-Tiffin), this general assembly's version of the education restructuring bill.

Sen. Andrew O. Brenner (R-Powell) recently attended the organizational meeting of the State Board of Education on which he serves as an ex-officio member due to his role as chair of the Senate **Education Committee. During** that meeting, Brenner shared with the board plans to hold a hearing on SB 1 in the Senate Education Committee very soon. Brenner shared that the bill includes the same language contained in SB 178 during the lame duck session except for the provisions related to vaccine mandates and the participation of transgender students.

Brenner also shared that the Senate is working on legislation to deregulate local schools. He stated that he has heard from school leaders that state requirements sometimes block them from solving challenges, particularly staff shortages. This bill has not yet been introduced.

Activity will most likely move along slower in the Ohio House where a split within the Republican caucus still exists. Traditionally, the House Republican caucus holds a retreat at the beginning of a new general assembly. This retreat is a chance for the full caucus to gather and discuss their policy priorities as well as learn of their committee assignments. It has been reported that the full Republican caucus retreat has yet to occur.

In fact, on Tuesday of this week Rep. Derek Merrin (R-Monclova Township) called for a meeting of the 45 House Republicans who had not supported Speaker Stephens during the speaker's election. Of those 45 members, 43 had supported Rep. Merrin and two were absent from the session where the vote occurred. The agenda for the meeting listed goals and procedures, House rules governing the 135th General Assembly, working with the Republican-led

Senate and policy discussion. Reportedly, 38 Republican members attended.

Rep. Brian Stewart (R-Ashville) told Cleveland.com ahead of the meeting, "I think the plan tomorrow is just to allow a group of like-minded members to get together and talk about policy (and) talk about what is likely to happen in the House in the year ahead."

A spokesperson for Speaker Stephens issued a statement sharing that "Speaker Stephens has always stood for the constitutional right to freedom of assembly. His focus remains on unifying the House Republican caucus and working on behalf of the people of Ohio."

Following today's meeting, Merrin told reporters, "A lot of relationships have been hurt through this but there are many good people over there. For the purpose of this meeting, it was important for us to organize and talk about the future." He further stated, "I am the leader of the House Republicans. Jason Stephens is the Speaker of the House."

Rep. **Phil Plummer** (R-Dayton), a supporter of Rep. Merrin, shared his thoughts with reporters as

Columbiana students, city employees collaborate on projects

Students in **Columbiana EV**'s Columbiana High School entrepreneur class have been working with Columbiana city employees on a number of projects to improve the city.

Recently, the class helped spruce up a parking lot, and City Manager **Lance Willard** told a local newspaper that students want to highlight a shopping plaza that houses a local bakery.

The students, who are led by teacher **Trisha Missos**, also have

been working on a video presentation in which they will invite Gov. **Mike DeWine** to visit the school.

Willard said the class's presentations have been so good that it was invited to present at Carnegie Mellon University in Pennsylvania.

"It will be a neat experience, and we are really happy that the school is interested in participating," Willard told Columbiana City Council during a December meeting.

"They are getting a lot of experience. It's pretty neat. They are doing a great job."

The city and school district are also working together on other projects not related to the entrepreneur class, including a project to put 40 bird houses throughout a park and cemetery.

The city will construct the bird houses which will then be painted by students and placed in locations all around the public area.

Speaker Stephens told Gongwer News Service, "My focus remains on unifying the House Republican caucus to get to work. After meeting with dozens of House members this past week, I am confident the House can move forward and deliver real results for the people of our great state."
