## State department encourages schools to welcome international students

U.S. Secretary of State **Anthony Blinken** and U.S. Secretary of Education **Miguel Cardona** issued a letter to high school superintendents March 13 encouraging them to consider hosting international students or starting a foreign exchange student program. In it, they describe high school student exchanges as a key way for citizens to participate in U.S. diplomacy and promote peace and understanding among different nations and cultures. They also explain that the state department has several programs offering international students a path to spend some of their high school career in the U.S., each of which seeks participation from school districts. ## Pandemic learning loss related to pandemic sleep loss, CDC reports

The National Center for Chronic Disease Prevention and Health Promotion, a division of the Centers for Disease Control and Prevention, released a study last month showing that students who slept less than seven hours each night during the COVID-19 pandemic were more likely to struggle to complete schoolwork, with two-thirds of respondents who reported short sleep duration also reporting "increased difficulty" in school. Lack of adequate sleep affected a significant majority of students — 76.5% of respondents, who represented a diverse range of demographics and backgrounds. Short sleep duration was also found to be related to poor mental health, another predictor of academic issues. The large and nuanced study, which can be viewed at <http://links.ohioschoolboards.org/cdc>, suggested that addressing short sleep among adolescents could be an important step toward reversing the current youth mental health crisis and post-pandemic decline in academic performance.

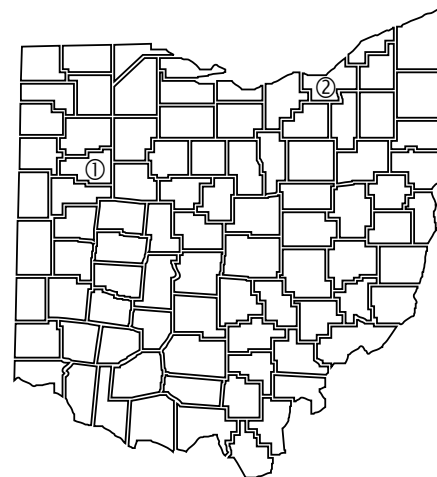

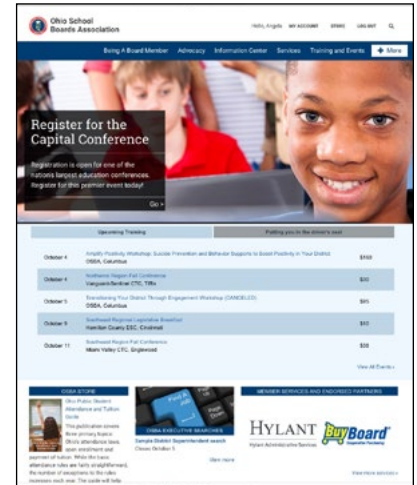

# LEGISLATIVE REPORT

## More education bills introduced

The General Assembly continues to see new bill introductions, with several relating to education:

### House Bill 135

HB 135, sponsored by Reps. Thomas Hall (R-Madison Township) and Rodney Creech (R-West Alexandria), would require schools to provide an excused absence for students to participate in 4-H and FFA programs or events. The bill would require a 4-H or FFA advisor to submit written documentation to the principal or attendance officer as proof of participation in the activity or program. Districts would be required to allow students to make up any missed schoolwork due to this type of absence. HB 135 would explicitly prohibit principals from granting an excused absence for this purpose if the absence occurs during scheduled state assessments or during a period when the student has been disciplined, suspended or expelled. HB 135 is pending in the House Primary and Secondary Education Committee.

### House Bill 137

HB 137, sponsored by Reps. Adam Mathews (R-Lebanon) and

Phil Plummer (R-Dayton), would require the Ohio Department of Education to study the feasibility of implementing a program similar to the Kentucky Bluegrass Challenge Academy (BCA). The bill would require ODE to submit their findings by June 30, 2024.

BCA is a voluntary program established in Kentucky in 1999 to serve at-risk students aged 15 ½ to 18 who are not progressing in a traditional high school. The program is operated through a cooperative agreement between the National Guard Bureau and the State of Kentucky funded by state and federal dollars with no cost for the student.

It is a two-part program that focuses on academic rigor while teaching life skills. The program begins with a 22-week residential phase where students live on site at BCA, located on Fort Knox. During the residential phase, students attend Eminence Independent High School, receive individual and group counseling and have round the clock supervision.

The residential phase is a highly structured quasi-military format that emphasizes self-discipline, personal responsibility and positive motivation. During this phase, students are referred to as

cadets and must meet military grooming standards, wear military type uniforms and observe standard military customs. The first two weeks of the residential program are called the acclimation phase. The goal of the acclimation phase is to identify the students who have the desire to succeed in the program and the discipline to complete the program. The next phase of the residential program is referred to as the challenge phase. During this time, students focus on the “Eight Core Component” curriculum and must show improvement in each of the following components:

- Academic Excellence
- Leadership and Followership
- Life Coping Skills
- Job Skills
- Service to the Community
- Responsible Citizenship
- Health and Hygiene
- Physical Fitness

Following the residential program, students enter the 52-week second phase of the program, where each student works with an adult role model in a one-on-one mentoring relationship. Mentors provide students with advice, guidance and support with the goal of helping students continue the

success and direction they saw during the residential phase.

HB 137 is waiting for committee referral in the House.

### House Bill 140

HB 140, sponsored by Rep. Richard Brown (D-Canal Winchester), is a reintroduction of HB 70 from the 134th General Assembly. This bill would require the bureau of motor vehicles to display a printed card with graphics instructing drivers to stop and yield to a stopped school bus when it is loading or unloading passengers. The bill would also increase the penalty for failing to stop for a stopped school bus from \$500 to \$1,000 and increase possible license suspension from up to one year to a range of three months to two years. Under the bill, if an offender had a prior violation within the last five years, the base fine would be \$2,000 and the license suspension would range from six months to three years.

The bill would also make changes regarding the use of cameras on buses by requiring the Department of Public Safety to adopt rules regarding the construction and design of school bus camera equipment to provide images or video of a motorist who passes a stopped school bus. The bill would also clarify that districts can install cameras for the sole purpose of capturing photo or video of motorists who pass a school bus. HB 140 would also allow law enforcement to use those photos or videos, as long as they are sufficiently clear, to identify the offender.

HB 130 is waiting for committee referral in the House.

### Senate Bill 99

SB 99, sponsored by Sen. Catherine Ingram (D-Cincinnati), is a reintroduction of HB 606 from the last General Assembly. This bill would require districts to create an individualized seizure action plan for each student with a diagnosed seizure disorder. The

action plans must include the following:

- a written request from a parent or guardian approving the plan and giving permission for the administration of seizure medication;
- a written statement with the name and purpose of the medication, prescribed dosage, route and frequency of administration and circumstances when it should be administered;
- a written notice to staff and volunteers responsible for the direct supervision of the student, describing the seizure action plan and the person who has received training.

The bill would also require that the school nurse or another district employee coordinate epilepsy and seizure disorder care at the school. This employee would be required to ensure that all school staff are trained every two years in the care of students with seizure disorders.

SB 99 is waiting for committee referral in the Senate.

**Annette Drake, Brookeville Local's (Montgomery) Brookeville Intermediate School,** is an Ohio science finalist.

The Presidential Awards for Excellence in Mathematics and

Science Teaching are the nation's highest honors for mathematics and science teachers.

The program recognizes teachers for their contributions to instruction and learning, as well as their ability to help students make progress in mathematics and science.

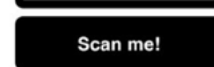
Awardees serve as models for their colleagues, inspiration to their communities, and leaders in the improvement of mathematics and science education.
