## Save the date for 2023 Ohio School Safety Summit

## Raffles may return after update to rules

Last September, an amendment to Ohio Revised Code 2915.092 — which deals with the legality of raffles as fundraisers for various institutions — removed public schools from the list of entities permitted to conduct raffles without a bingo license. Since then, the General Assembly passed an amendment reinstating the words “public schools” to the list, and as of April 7, schools can once again count on the ability to legally conduct raffles. The submission deadline is May 31. The platform guides OSBA’s advocacy efforts and informs legislators, policymakers, the public and the media where OSBA stands on a variety of public education issues.

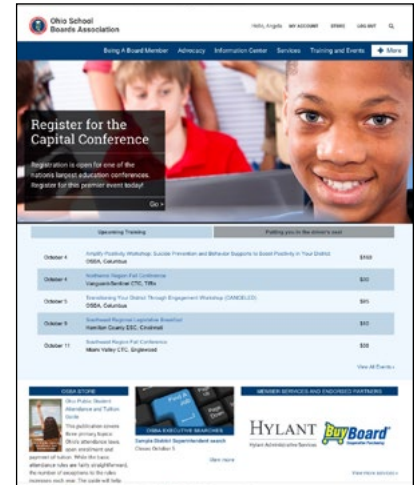

### Legislators meet Ohio's public school leaders at annual State Legislative Conference

Vouchers, property tax valuations and the restructuring of the State Board of Education (SBOE) were among the key issues discussed at the 2023 State Legislative Conference, which was held March 21 at the Sheraton on Capitol Square.

The conference provides school board members and district leaders an opportunity to meet their legislators in person and share questions and concerns about education policy. This year, the conference opened with a welcome speech from Gov. **Mike DeWine**, in which he thanked school board members for their service and discussed investments in education within his office's current budget plan, describing the focus of his administration as ensuring "every child... and adult in Ohio lives up to their potential." The plan is currently awaiting revision in the House.

These investments include an expansion of the Help Me Grow early childhood assistance program, \$516 million in "wellness dollars" over the biennium for school health services, a proposed \$200 million for career technical education, and expanded scholarship eligibility for state and community college students. He

described the budget process as "on track and on schedule."

DeWine said that the budget also seeks to address the state's relatively low third grade literacy — about a third of Ohio's third-graders read below grade level. In DeWine's budget plan, each district would receive funds for "science of reading aligned" instructional materials and professional development stipends for teachers to train to use them.

These measures tie into the governor's vision for the state's overall economy. Ohio is an "attractive" state for supply chain businesses, he said, and investing in students who might work for those businesses "happens to coincide with what is the right thing for this state."

Following the governor's speech, lobbyists from OSBA, the Ohio Association of School Business Officials (OASBO) and the Buckeye Association of School Administrators (BASA) reviewed bills affecting education which are being decided in the current legislature.

**Nicole Piscitani**, OSBA lobbyist, provided an overview of House Bill (HB) 33, the biennial budget. Piscitani outlined the proposed funding formula changes as well as

the proposed education policy changes in the bill. She also highlighted the need to have the inputs in the funding formula updated to Fiscal Year 2022 data and the need for a comprehensive study on the needs of Ohio's economically disadvantaged students.

OASBO Deputy Executive Director **Katie Johnson** spoke on HB 1, which proposes modifying Ohio's property and income tax laws to lower income tax and raise many types of property taxes, shifting costs and changing how residential and agricultural properties are valued for tax purposes. Johnson explained that this will affect school districts differently, with district residents seeing either an increase in their property taxes or a loss of local funding for the district.

Dr. **Paul Imhoff**, director of governmental relations at BASA, presented information on the three bills proposing changes to the EdChoice voucher program, all of which OSBA, OASBO and BASA oppose. Imhoff drew applause with a succinct rationale for this opposition: "We cannot expand vouchers any further until we fund the 90% of students in this state

who attend public schools.” He also stressed the importance of transparency in both public and private schools and families’ ability to make informed decisions about their children’s education. Current law does not require the same documentation, such as report cards, yearly audits and five-year forecasts, of private schools as public schools.

OSBA Director of Legislative Services **Jennifer Hogue** reviewed the companion bills Senate Bill (SB) 1 and HB 12. These bills seek to roll back the involvement of the SBOE and create a governor-appointed cabinet department, the Ohio Department of Education and Workforce (DEW), to oversee most decisions related to Ohio’s education system.

Hogue explained that if the bill becomes law, elected SBOE members would select the state superintendent and issue teacher’s licenses but — despite a few amendments requiring more public engagement in the DEW appointment process — the current highly public and transparent process of state education policymaking would be lost.

While some provisions of the bill, such as those designed to create more opportunities for career-technical education, are aligned with OSBA positions, Hogue explained that the importance of locally elected voices in statewide education decisions supersedes these, and as such OSBA opposes the bill.

The lobbyists answered several

questions from attendees about funding and gave examples of how to discuss the issues brought up with legislators.

Senate President **Matt Huffman** (R-Lima) provided a briefing on current Senate activities. This mainly addressed SB 1 and the intent behind it. He characterized the bill as a continuation of previous Senate bills and an attempt to complete what those bills started: a streamlining of the state education system that proponents hope would make education regulations more flexible. Huffman said the proposal stemmed from concerns about the restrictiveness of the current SBOE bureaucracy on districts and educators.

The House briefing was delivered by House Speaker **Jason Stephens** (R-Kitts Hill), who reflected on the importance of education and stressed that divisions on education issues merely stem from “different opinions on how to achieve the same objective.” He praised attendees for the work they do, saying that “school board members are the ears of the community and their voice in the legislature.”

This year’s legislative panel consisted of:

- Sen. **Andrew O. Brenner** (R-Delaware), chair of the Senate Education Committee;
- Rep. **Adam Bird** (R-New Richmond), chair of the House Primary and Secondary Education Committee;
- Sen. **Catherine D. Ingram** (D-Cincinnati), ranking member of

the Senate Education Committee; ● Rep. **Phillip M. Robinson Jr.** (D-Solon), ranking member of the House Primary and Secondary Education Committee.

The panel walked board members through current bills and shared their legislative priorities. Brenner plans to introduce a bill promoting deregulation of public schools but agreed with Bird that it was “difficult to support HB 1 in its current form.” Bird also discussed the need for better public school funding and the importance of balancing that with the interests of charter, private and religious schools.

Ingram opened her remarks by saying that “There are no cookie cutter answers to what needs to be done.” She drew attention to a need for specificity when promoting career-technical education to ensure that all students are receiving the same opportunities for both career training and higher education. Robinson said he would like to accelerate the Fair School Funding Plan phase-in and update it to reflect FY 2022 data so that its provisions would be more effective. He too criticized the voucher bills, saying, “We’re not against choice, but it needs to not be at the expense of traditional public schools.”

The panel went on to address questions about teacher shortages, the budget and improving charter school accountability. Afterward, attendees had an opportunity to meet and greet legislators over lunch.

## Wayne County student's chick donation inspires learning

A student at **Northwestern Local's (Wayne)** Northwestern High School probably deserves some "egg-stra" credit.

Senior **Harper Flores**, who raises chickens at her parents' Wayne County farm, donated 73 fertilized eggs to second-graders at Northwestern Local's Gorrell Elementary School. She also brought along one of her roosters, Bruno, and a hen, Jessica, to show the students.

Over several weeks, students

watched as the eggs incubated and hatched, with the chicks slowly beginning to peck at the shells until they cracked.

"It takes a lot of energy, and they will be tired," Flores told students.

Flores wanted to give other students the opportunity to experience the process of raising chickens and inspire them, she told a local newspaper. Her father, **Bob**, introduced Flores to chickens and raising them after

she struggled in school. "The chickens were her outlet," her mother, **Amanda**, said.

"I've never seen anyone tame chickens like her."

Flores is a member of Northwestern Local's National FFA Organization club and participates in cross country and track. She plans to attend the University of Akron after graduation and become a veterinary technician.
