State board names interim superintendent

The State Board of Education has appointed **Chris Woolard**, an Ohio Department of Education (ODE) official, interim superintendent of public instruction effective May 28. Woolard serves ODE as chief program officer. He will replace Interim Superintendent of Public Instruction Dr. **Stephanie K. Siddens**, who has taken the deputy superintendent position at **Upper Arlington City**.

The Environmental Protection Agency's Office of Transportation and Air Quality has opened applications for its nationwide Clean School Bus Grant Program. This program authorizes approximately \$400 billion in funds to replace aging school buses with clean or zero-emissions models. Primary election school tax issue results reflect economic stress

Voters approved 48% of school tax issues in the May 2 primary election, marking a significant decrease from last year's 65% passage rate. While renewal school tax proposals continue to enjoy majority support from the public, with 21 of the 29 issues passing for a 72% passage rate, this represents a decrease from last year's 88% passage rate for similar measures in the primary. Thirty-three percent of new school tax requests were approved Tuesday, May 2, with 15 of 46 issues passing. This is the lowest passage rate for these types of issues in a May election since 2007, with several levies receiving less than 20% yes votes. The declines reflect voters' concerns about current economic instability, a situation which is also sure to affect districts whose issues failed as they work to meet their students' educational needs.

Changes to Third Grade Reading Guarantee law discussed at the Statehouse

In 2012, the Ohio General Assembly passed the Third Grade Reading Guarantee law, requiring schools to administer diagnostic assessments to identify students from kindergarten through grade three who are not on track to pass the Ohio English Language Arts (ELA) test administered in the third grade. Schools are required to provide Reading Improvement Monitoring Plans (RIMPs) to identified students. Students in the third grade are required to take two ELA tests and meet the cut score that the State Board of Education designates. The current cut score for the 2022-23 school year is 685. Students who do not meet the cut score risk retention to the third grade unless they meet an alternate assessment score.

The Ohio House in the 134th General Assembly passed a bill that would have removed the retention provision from current law and would have eliminated the fall ELA test. The bill failed to make it out of the General Assembly during lame duck due to the Ohio Senate's concerns about proficiency rates and desire to ensure that identified students still received focused instruction. The Ohio House in the 135th General Assembly has renewed efforts to change the Third Grade Reading Guarantee law but has incorporated additional provisions to address the concerns of the Ohio Senate.

Substitute House Bill (HB) 33, the biennial budget bill that passed the Ohio House on April 26, 2023, included many provisions regarding literacy. Gov. Mike DeWine, in the introduced version of the budget, incorporated requirements that the Ohio Department of Education compile a list of high-quality core curriculum and instructional materials in English language arts. This list of evidence-based reading intervention programs must be aligned with the science of reading and provide strategies for effective literacy techniques. School districts, community schools and STEM schools are required to use instructional materials from the list beginning no later than the 2024-25 school year. The budget also includes funding for professional development and curriculum to help schools and teachers with implementation.

The Ohio House maintained the literacy provisions the governor introduced but also included provisions on the Third Grade Reading Guarantee:

• eliminating student retention beginning with the 2023-24 school year;

• maintaining the requirement that districts and schools offer RIMP services to students in grades K-three who read below grade level;

• requiring districts and schools to provide RIMP services to fourth- and fifth-grade students who are reading below grade level and to students who have been retained in any grades K-three and have received RIMP services for two school years but continue to read below grade level;

• requiring school districts and schools that retained students for the 2023-24 school year, based solely on those students' scores on the 2022-23 ELA, to promote the students to the fourth grade;

• elimination of one annual administration of the third-grade ELA assessment.

on the education-related provisions of HB 33, including one focused on literacy that delved deeper into conversations regarding the Third Grade Reading Guarantee law. The Ohio Senate is expected to release its budget amendments by the end of May, and at that time, the third-grade reading guarantee provisions may be maintained, changed or deleted.

Meanwhile, the House Primary and Secondary Education committee passed HB 117, sponsored by Reps. Gayle Manning (R-North Ridgeville) and Phillip M. Robinson Jr. (D-Solon), which includes all of the Third Grade Reading Guarantee provisions found in HB 33 but also requires the State Board of Education to include the teaching of phonics in the K-five standards. The bill is waiting for a vote on the House Floor. The passing of HB 117 out of committee not only solidifies the House Primary and Secondary Education committee's will to change the law but also provides an additional avenue for them to do so if the Ohio Senate removes the provisions from HB 33.

The State Board is required to set the cut score for the upcoming school year and must raise the score each year until the cut score matches the proficiency score, which is 700. The current cut score is 685. The State Board, at its May meeting, passed a recommendation out of committee to move the cut score to 690 for the 2023-24 school year. While the State Board is required to raise the cut score, it also stated through a resolution passed at the November 2022 board meeting that it would recommend for the General Assembly to remove the retention provisions of the Third Grade Reading Guarantee law. The State Board will vote on the cut score during its next meeting, which is scheduled for June 13.





Perry Local students beautify school campus, park

Members of **Perry Local**'s **(Stark)** high school environmental and gardening clubs teamed up with Home Depot Inc. to spruce up the landscape around the school campus and a local park gazebo.

Students pulled weeds, planted flowers and put down new mulch, adviser **Cathy Changet** told a local newspaper.

"In the fall, we had bulbs," Changet said. "We've weeded. The program allows students to beautify the school while learning a little bit about plants and when to plant them and how to care for them."

The two clubs focus on a variety of topics throughout the school year. Recently, the environmental club visited SA Recycling in Massillon to learn about the recycling process.

The clubs have started a composting project at the school.

Sophomore **Jacob Carter** said he likes gardening and especially working with flowers, such as roses.

A GUIDE FOR 2023 SCHOOL BOARD CANDIDATES

Ohio's public school board members, one of the largest groups of elected officials in the state, are charged with major responsibilities in government — providing the best educational opportunities possible for Ohio's youth and managing and controlling the political subdivision of the school district.

What does a school board member do?

The broadest definition of a school board's role is that it acts as the governance team for the school district. School boards adopt policy and oversee the district's policy manual. The board's most important role is to employ the superintendent and treasurer and work closely with them to establish and set policy, vision and long-range goals and be accountable for the fiscal health and opportunities provided to the district's students and families.

School board members need to be strong district ambassadors to the community and work to build public support and understanding of public education. Remember, individual board members do not hold authority unless it has been delegated to them. The board's legal authority is held by the governing body as a whole and is exercised through voting in public meetings.

Board member responsibilities

The role and function of board members often are misinterpreted by the public. The board is a policymaking body, and members are the chief advisers to the superintendent on community attitudes. Board members do not manage the day-to-day operations of a school district; they see to it that the system is managed well by professional administrators.

Board members do not evaluate staff, other than the superintendent and treasurer, nor do they typically become involved in employment interviews, other than those of the superintendent, business manager and treasurer. Board members may be consulted during the hiring process for other positions, such as assistant superintendent.

WHAT IS A GOOD BOARD MEMBER?

We often hear that one person is a good board member or another is a bad board member, yet we seldom hear a clear definition of what constitutes a "good" board member. In reality, there are about as many philosophical theories about board governance as there are board members. Members must recognize that people usually don't react to the same problem in an identical manner, so flexibility is necessary. However, there are some acceptable guidelines.

A good board member:

- Knows that they can legally act as a board member only when the board of education is in session. No single person can act for the board. No board member, unless authorized, should speak on behalf of the board.
- Avoids administrative decisions or attempting to secondguess the administration. The superintendent is the chief administrator, and the board has no administrative function.
- Is well acquainted with school policies.

- Votes at all times in the best interests of the school district.
- Is flexible and realizes there are times when changes must be made, when tradition cannot be honored and when pressure must be ignored.
- Remembers that board business often requires confidentiality, especially in processes involving students, personnel, land acquisition, negotiations and security.
- Is able to support a decision when it is made.

- Is interested in obtaining facts but also remembers that the administration is responsible for operating the schools and cannot spend all its time making reports to an individual board member.
- Is a good listener at board meetings, in the community or anywhere else, but never commits themselves, the board or the administration.
- Knows that the reputation of the entire school district is reflected in their behavior and attitude.

RUNNING FOR YOUR LOCAL BOARD OF EDUCATION

HOW TO BECOME A SCHOOL BOARD CANDIDATE

To run for a school board seat you must be:

- a U.S. citizen;
- at least 18 years old;
- a resident of the school district for at least 30 days preceding the election;
- registered to vote in the school district for at least 30 days preceding the election.

Conflicts of interest

There are conflicts of interest of which all board members must be aware to prevent jeopardizing their reputation or that of the school district. In addition to actions and relationships prohibited by school statutes, other prohibitions are set out in criminal statutes and statutes enforced by the Ohio Ethics Commission (OEC). If you already are a public employee or officeholder, a position on a board of education may be incompatible with your current position. Before seeking election, potential candidates should make certain they are eligible to serve. For a review of the applicable laws in this area, please see the "Conflicts of Interest" section of the OSBA's Get on Board website.

Election

Members are elected on a nonpartisan ballot on the first Tuesday following the first Monday in November in odd-numbered years. The term of office is four years, although in certain instances two-year terms must be filled to complete an unexpired term. When elected, your term begins on the first day of January after the election and expires on Dec. 31. Most boards of education have five members; however, some larger districts have seven. Two members (or four on a seven-member board) are elected at one general election and three members are elected at a general election two years later.

GETTING STARTED

You can obtain an election packet from your county board of elections office that includes the necessary forms and petitions required to become a candidate. Many of these forms can also be downloaded from the Ohio secretary of state's website.

Filing your petition

A candidate must file a petition to run for a seat on a board of education. This nominating petition must be filed with the county board of elections by 4 p.m. on Aug. 9, 2023, the 90th day before the November general election (RC 3513.254, 3513.255). As of April 2023, the filing fees were \$30.

Candidates may obtain the petition forms and discuss questions about filing with their county board of elections. For more information on filing your petition, please see the "Campaign First Steps" video on OSBA's Get on Board website, which walks candidates through the nominating petition form and the process for gathering signatures.

Campaigning

After filing your petition, it's time to begin gathering support. Candidates for boards of education run their campaigns in a variety of ways. Some campaigns are conducted primarily by word-of-mouth. Others are large-scale campaigns, with many signs, appearances and fundraisers. Each candidate decides how to structure their campaign. For a review of the different types of campaigns frequently used by board candidates, please see the "Campaign First Steps" video on OSBA's Get on Board website.

Candidates who want to receive campaign contributions and/or make campaign expenditures are required to form a campaign committee and must track all campaign contributions and expenditures. A candidate's ability to solicit contributions and spend campaign funds is heavily regulated by state law. For more information about the types of permissible contributions and expenditures, and the rules that must be followed when using campaign signs, literature, posts and other campaign items, please see the "Contributions and Expenditures" video on OSBA's Get on Board website.

Finally, it's important to note that most candidates for boards of education are required to periodically file an itemized statement of campaign contributions and expenditures with their county board of elections. Candidates for a board of education of a school district or ESC having a total student enrollment of 12,000 or more must also file a financial disclosure statement with OEC.
