#### Governor signs fiscal year 2023-24 budget bill

Gov. **Mike DeWine** signed the biennial budget bill July 4. The final bill retained the EdChoice voucher expansion item without any additional accountability measures for nonpublic schools. It also included measures to transfer policymaking powers previously held by the State Board of Education to an unelected cabinet-level agency. There are, however, some wins for public education among these setbacks, including the continued implementation of the Fair School Funding Plan, the use of fiscal year 2022 data for base cost inputs, the inclusion of funding for a comprehensive study on the needs of economically disadvantaged students and changes to the mandatory retention under the Third Grade Reading Guarantee. #### Filing deadline for school board candidates approaching

Those seeking a school board seat are reminded that the deadline to file nominating petitions with their county's board of elections is 4 p.m. Aug. 9. Petition forms are available from your county board of elections or the Ohio secretary of state's office. A candidate in a city district with a population under 20,000 must have 25 valid signatures; a population of 20,000 to 49,999, 75 valid signatures; a population of 50,000 to 99,999, 150 valid signatures; a population of 100,000 or more, 300 valid signatures, according to Ohio Revised Code (RC) 3513.254. Educational service center governing board candidates must have 50 valid signatures (RC 3513.255). OSBA will host several board candidate workshops for those running for a seat. #### Back to school sales tax holiday planned

Ohio's three-day sales tax holiday — created to help parents and teachers save money on back-to-school purchases — will take place Aug. 4-6. Sales tax will be suspended on clothing, school supplies and instructional materials within certain

#### Federal Hocking Local students set sail at STEM camp

Grade school students at **Federal Hocking Local (Athens)** are getting a hands-on STEM experience this summer using 3D printers to build flat-bottomed boats that actually float.

Camp facilitator and Hocking STEM Curriculum Specialist **Teo Marti** told a local radio station that the experience requires math, science and art skills. "The learning curve is steep, and failure is OK," Marti said. "Now you get the opportunity to do it differently and try a different way."

Students start with a basic drawing of their design. Next, they construct a prototype out of building blocks. Then they rebuild their models using a 3D builder online, finally sending them to the 3D printers.

#### Recognizing school boards' teamwork, commitment

Although it is a collection of its members' experiences and views, a board of education functions as one as those diverse members collaborate to ensure the success of the students they serve.

OSBA created the Ohio Boards of Distinction Award in 2020 to honor those boards of education that work collectively for the betterment of their schools, students and communities.

The award recognizes a school board that modeled ethical and appropriate leadership behaviors leading to excellence in school governance in support of quality education. To receive this award, each member of the board must participate in training and service activities. Additionally, the full board must demonstrate collaborative teamwork in areas such as strategic planning, board self-assessment or policy governance that contribute to district progress.

"This award recognizes highfunctioning board teams that commit to learning together as well as the activities and training that improve their leadership within the district," said **Cheryl W. Ryan**, OSBA director of board and management services. "We especially want to honor those boards where each member has shown a commitment to collaborative governance."

A board of education must earn 600 points in a two-year cycle to earn the Ohio Boards of Distinction Award, with each board member contributing a minimum of 100 points. The two-year cycle begins in January following board of education elections as school boards form new leadership teams. The award will be presented at the end of the two-year cycle, and districts may only receive the award once during that cycle. The current cycle began in January 2022 and culminates at the 2023 OSBA Capital Conference.

Points are earned through mandatory and optional activities. Mandatory activities include conducting an annual board self-assessment; creating and maintaining an orientation process for new board members; reviewing and updating the district's policy manual; and attending an OSBA regional event. Optional activities range from implementing a community engagement survey to participating in a customized workshop to attending various OSBA conferences and training.

# LEGISLATIVE REPORT

### General Assembly completes HB 33 the two-year budget bill

The Ohio legislature sent House Bill (HB) 33 to Gov. Mike DeWine on June 30 for his review and approval. DeWine signed the final budget on July 3, after the legislature included an amendment to pass a three-day interim budget so he had time to review it. The final budget contained numerous educationrelated items including the Fair School Funding plan, voucher expansion and the Ohio Department of Education reform provisions. It also includes additional education-related policy changes that impact transportation, literacy and teacher licensure, among other provisions.

#### Fair School Funding budget items

HB 33 continues year three and four of the six-year Fair School Funding Plan phase-in for traditional school districts and joint vocational school districts (JVSDs). The phase-in percentage in Fiscal Year (FY) 2023 was 33.33%. HB 33 will increase the percentage to 50% in FY 2024 and 66.67% in FY 2025. Additionally, the legislature updated the data used to calculate the base cost in the formula from FY 2018 data to FY 2022 data. The legislature maintained the capacity calculation that was used in FY 2022 and FY 2023 but increased the minimum state share percentage from 5% to 10% for FY 2024 and FY 2025. This percentage is used to calculate several components of the foundation aid formula.

The budget continues the same formula used to calculate **Educational Service Center** funding in FY 2022 and FY 2023 for FY 2024 and FY 2025. Additionally, the formula includes the same phase-in percentage for year three — 50% in FY 2024 — and year four — 66.67% in FY 2025 as for the traditional school district and JVSD formulas. However, the legislature did not increase the base cost inputs to FY 2022 as they did for traditional public schools and JVSDs. The formula still uses FY 2018 data.

HB 33 also includes funding for a comprehensive study on economically disadvantaged students. The study looks to determine the needs of economically disadvantaged students, the most effective services for meeting those needs,

and the costs to implement the services. The Department of Education and Workforce (DEW) will be required to issue a report on the results of the study, including recommendations regarding measures and parameters for determining student eligibility for services identified by the study, which must take into account existing state and federal resources. This study will help future conversations in the legislature when determining the budget allocations for disadvantaged pupil impact aid (DPIA).

#### Vouchers

The legislature expanded income-based voucher eligibility from the current 250% federal poverty level (FPL) threshold to a universal voucher plan that includes means testing. The voucher funding will be paid directly from the state to the chartered nonpublic school that the student attends. The new income-based universal voucher will expand eligibility to any student entering grades K-12 in the school year for which the voucher is sought. The student is not required to have attended a Continued on page 10

public school before requesting the voucher. The base voucher amount is determined by the statewide average base cost per pupil, which is \$6,165 for grades K-8 and \$8,407 for grades 9-12. The voucher amount that the student receives will be determined based on the following formula:

- A student whose household income is at or below 450% will receive the entire estimated voucher amount at \$6,165 for grades K-8 and \$8,407 for grades 9-12.
- A student whose household income is above 450% FPL but at or below 500% FPL, \$5,200 for grades K-8 and \$7,050 for grades 9-12.
- A student whose household income is above 500% FPL but at or below 550% FPL, \$3,650 for grades K-8 and \$5,000 for grades 9-12.
- A student whose household income is above 550% FPL but at or below 600% FPL, \$2,600 for grades K-8 and \$3,550 for grades 9-12.
- A student whose household

income is above 600% FPL but at or below 650% FPL, \$1,850 for grades K-8 and \$2,500 for grades 9-12.

- A student whose household income is above 650% FPL but at or below 700% FPL, \$1,300 for grades K-8 and \$1,750 for grades 9-12.
- A student whose household income is above 700% FPL but at or below 750% FPL, \$900 for grades K-8 and \$1,250 for grades 9-12.
- A student whose household income is above 750% FPL, \$650 for grades K-8 and \$950 for grades 9-12.
- Requires that a student beginning with FY 2025, a receives a minimum scholarship amount of 10% of the base amount.

The legislature did not include any additional auditing or testing requirements for students using the income-based voucher.

#### Department of Education and Workforce

HB 33 contains provisions that transfer most of the

responsibilities of the State Board of Education and the Superintendent of Public Instruction to a newly created governor-appointed Director of Education and Workforce. The director will oversee the newly named Department of Education and Workforce (DEW), which will be responsible for primary, secondary, special and career technical education. Within DEW, two divisions will be created, the Division of Primary and Secondary Education and the Division of Career-Technical Education, and each will be headed by a Deputy Director appointed by the Director of DEW.

The State Board of Education and the state Superintendent retain duties and broad powers regarding educator licensure, licensee disciplinary actions and school district territory transfers.

The bill includes a 90-transition period. Governor DeWine has indicated that he has already identified a transition team to start planning out the process and addressing transition issues.

The district collaborated with WellSpring, which offers counseling programs for individuals and families in Springfield, Urbana and Bellefontaine; and Clark County Partners of Prevention, which aims to reduce youth substance use by promoting positive activities for kids.
