# National Assessment of Educational Progress shows declines in math and reading scores during the pandemic

Nationwide, math and reading scores for 9-year olds underwent their sharpest decline since 1990 during the COVID-19 pandemic, according to the National Assessment of Educational Progress, know as the "Nation's Report Card," an annual assessment conducted by the National Center for Education Statistics. Although scores declined across percentile categories, already-struggling students were the hardest hit, with reading and math scores among the 10th percentile falling by 10 and 12 points, respectively. Further analysis showed that lack of access to remote learning resources was a major factor in the trend. # OSBA president in the 1980s dies at 91

Judy B. Howard Rhode, OSBA's 1989 president, died Oct. 9 at the age of 91. Rhode, a longtime Bucyrus City board member, was widely respected as a powerful advocate for public education.

#### Shhh! Reading time brings quiet to Port Clinton

If a visitor walks into **Port Clinton City**'s Port Clinton High School at just the right time, they might notice an eerie silence.

For 14 minutes, three times a week, every student and staff member pulls out a book and reads for pleasure as part of the RED Block initiative. RED stands for Read Every Day.

For those few minutes, the normally bustling school settles down as everyone focuses on a world found only in the pages of a book.

"The whole school is quiet," **Jan Gluth**, director of student, staff and community development, told a local newspaper.

The RED Block initiative was the brainchild of Resource Intervention Specialist **Lori Scalf**, who recognized a need to address reading and vocabulary deficiencies in high school students.



#### **Upcoming workshop dates:**

#### • Dec. 7: Rules and laws governing Ohio student transportation

Review various regulations that transportation administrators need to know. A key takeaway from this class will be the handout of the operating rules, an index to look up regulations that are pertinent. Learn how the pieces fit together to ensure your transportation is safe, dependable and compliant.

#### • Jan. 25: Driver records, background checks and compliance needs

Ohio's regulations governing school bus driver requirements are among the most detailed in the nation. This seminar will present methods to maintain compliance. Driver audit forms, onboarding checklists and task calendars will be provided and reviewed.

#### Feb. 22: Emergency transportation planning

This class will help identify what should be included in an emergency plan, how to develop the action plans and how to write a plan that anyone can follow. This session will help you create the document, which will include not only the major events that we hope will never happen, but also routine incidents that occur, such as breakdowns, sick children and minor accidents.

#### March 29: Fleet compliance

This course will review the Ohio school bus construction standards, approved options for school buses, Federal Motor Vehicle Safety Standards requirements and the need to keep your fleet compliant with both sets of standards. We also will delve into the value of a preventive maintenance plan, bus purchasing, using data to determine an effective vehicle replacement plan and how to make the best use of the driver pre-trip inspection to meet the need for safety checks and state patrol motor vehicle inspections.

# **FUNDING OPPORTUNITIES**

#### Ohio EPA offering recycling and litter prevention grants

Is your school interested in starting or expanding its recycling program? Are you looking to replace your running track or walking paths with asphalt comprised of ground tire rubber? Is your K-12 school thinking of upgrading your drinking fountains to include water bottle refilling stations? The Ohio Environmental Protection Agency (Ohio EPA) is offering two grants — the Academic Institution Grant and the Scrap Tire Grant — to assist in recycling and sustainability projects.

Public and private K-12 schools, colleges and universities may receive funding for recycling efforts as well as outreach and education, recycling equipment and conference sponsorships. In addition, schools and other

organizations can receive grants to establish and implement recycling and litter prevention programs and recycling infrastructure improvements. Grantees have 12 months to complete the project. The grant period is 24 months for scrap tire/civil engineering projects.

Here are some examples of recently funded projects:

- **Dublin City**'s Dublin Jerome High School implemented a Grind2Energy initiative to divert five tons of food scraps from the landfill.
- The James A. Garfield Local (Portage) School District expanded recycling on its campus, including athletic events, by installing recycling stations, increasing recycling by four tons.
- The New Miami Local

**(Hamilton)** School District started a recycling program in the district and collected nearly nine tons of recyclables.

• The Triad Local (Champaign)
School District upgraded its track
and walking paths using an asphalt
mixture including ground tire
rubber.

#### Cincinnati partnership expands to address teacher shortage

As school districts across the nation struggle to retain teachers, a partnership between **Cincinnati Public** (CPS) and Miami University to address the shortage is expanding, with the hope of also increasing diversity among educators.

TEACh Cincinnati, or Transformative Educators Advocating Change, is an initiative that creates a pipeline and support system for diverse teachers.

The program provides

academic, social and financial support for students interested in pursuing a teaching career, beginning in high school.

"Having worked in education for almost 30 years, first as a teacher, I'm incredibly excited for this step in our partnership with Miami University," CPS Superintendent Iranetta Wright said in a news release.

"The expansion of the program allows CPS students to not only have the opportunity to immerse themselves in meaningful, continued education at Miami University but also gain the experience needed to ensure they are prepared to successfully return to [CPS] as our next generation of teachers."

The program, first piloted at Aiken High School, will expand to all district high schools over the next five years, giving more students the opportunity to explore education as a career field.
