PROTECTION AND PEACE OF MIND

Statistics produced by the National Safety Council state that fatal accidents occur every five minutes in the United States. When life takes unexpected turns, it's important to feel secure and protected. OSBA's Insurance Agency offers you peace of mind for those difficult situations.

LOW-COST COVERAGE FOR YOU



The OSBA Insurance Agency offers low-cost business and personal Accidental Death and Dismemberment Insurance (AD&D) to all school district administrative employees. Administrative employees who purchase business and personal AD&D for themselves are also eligible to purchase coverage for their dependents at very low rates.

COVERAGE TYPES AND RATES



Business Travel AD&D: Coverage only applies when you are performing the duties of your job, either on or off school district premises. This does not include commuting to and from work, or during time off from work. The cost is \$18 per year.

Personal AD&D: If you purchase business travel AD&D, you are eligible to purchase personal AD&D coverage. This policy extends your coverage to apply at all times: 24 hours a day, seven days a week, not only when you are working, but during your leisure time and while commuting. The cost is \$18 per year.

Dependent AD&D: If you purchase business travel and personal AD&D, you are eligible to purchase personal AD&D coverage for your spouse and/or children.

PROTECT YOUR SPOUSE AND CHILDREN FOR ONLY \$19 PER YEAR



Safeguarding your family is vital, but it does not have to be expensive. OSBA's Insurance Agency offers administrative staff the opportunity to purchase low-cost personal AD&D coverage for their spouses and children if they have purchased business travel and personal AD&D for themselves.

Coverage of \$50,000 for your spouse costs just \$14 per year, and all of your children up to age 19 (or age 25 if a student) receive \$10,000 in coverage for one flat rate of \$5 per year.



ELIGIBILITY FOR YOU

All superintendents, assistant superintendents, treasurers, business managers, principals, supervisors, directors, attorneys, support staff and other administrative personnel of OSBA-member school districts and their dependents are eligible for this coverage.

ELIGIBILITY FOR 24/7 PROTECTION FOR YOU AND YOUR FAMILY

Spouses and children of covered administrative personnel are eligible for personal AD&D insurance. Coverage runs annually from March 1 through the end of February, and continues as long as the following requirements are met:

- your coverage is paid in full;
- you are employed by an Ohio public school district in an administrative position;
- your district is a member of OSBA.

If you are no longer employed by an OSBA-member district, coverage will terminate and no refund will be issued for the remainder of your premium.
