Supplement to Ohio Sunshine Law Manual now available

The attorney general's office recently issued a supplement to the *Ohio Sunshine Laws Manual* that includes legal updates that have surfaced during the last year. A copy of the supplement is available online at http://links.osba-ohio.org/95127/.

The following updates are among those included in the supplement: • Records kept by a private alumni association are not subject to a public records request to the public school system — *State ex rel. Rittner v. Foley,* 2009-Ohio-520 (6th Appellate District).

 Individual board member evaluations, used by the board president to prepare a composite evaluation but not kept thereafter, are not public records — *State ex rel.* Johnson v. Oberlin City School Dist. *Bd. of Educ.,* 9th App. Dist., 2009-Ohio-3526 (9th Appellate District). • There is no duty to provide records that later come into existence, so long as the public office transmits the public records that existed at the time of the public records request - Starks v. Wheeling Twp. Tr., 2009-Ohio-4827 (5th Appellate District). • Public school's semester examination met the statutory definition of "trade secret" and was exempt from the Public Records Act — State ex rel. Perrea v. Cincinnati Public Schools, 2009-Ohio-4762 (Ohio Supreme Court).

• Public university's internal report of investigation of plagiarism was not excepted from disclosure under the Public Records Act — *Mehta v. Ohio Univ.*, 2009-Ohio-4699 (Ohio Court of Claims).

• Release of any version of the Ohio Graduation Test is prohibited — House Bill (HB) 1 amended Revised Code Section (RC) 3301.0711(N).

• Regional student education districts are considered public offices, their records are public records and their boards of directors are public bodies subject to Ohio's open meetings laws — HB 1 enacted RC 3313.83.

• During a declared emergency, a public body may meet at an alternative location, but is still required to meet in person and is not permitted to meet by teleconference — 2009 Attorney General Opinion Number 034 (2009 Op. Att'y Gen. No. 034).

The attorney general's office has also issued an updated model public records policy, which is available online at **http://links. osba-ohio.org/52630/**. OSBA does not recommend adopting this model policy as it currently exists because it continues to impose stricter requirements than what is required by law. OSBA's Policy Department has sample model policy KBA, available upon request.

As a reminder, all elected officials or their appropriate designees are required to attend a three-hour public records training approved by the attorney general. The law allows for the board to designate one person to attend on behalf of the entire board. Because the terms of board members are staggered, the board will need to designate a designee every two years to meet the requirement of attending once per term for each board member.

Almost all board members agree that they could use more training in tackling school district problems. When asked how, board members say they want training that is highly taskoriented, takes a short period of time, is done in small groups and is led by outstanding instructors.

To meet these requests, OSBA is working with board members from across the state to develop the annual Board Leadership Institute. The twoday workshop, planned for April 23–24, is designed specifically for board members and will focus on numerous topics. Participants will have the



opportunity to attend the opening general session, multiple breakout sessions and closing luncheon, as well as network with each other.

Twenty points will be awarded for attending the institute, which may be applied toward receiving OSBA's Award of Achievement and Master Board Member Award.

Supreme Court cell phone search ruling could impact schools

A recent ruling by the Ohio Supreme Court may have a direct effect on searches of student cell phones in district disciplinary actions. OSBA encourages boards of education to review the decision and communicate it to district administrators.

This case has implications for school discipline related to searches of cell phones based on a violation of school rules. While this is a criminal case dealing with a warrantless search incident to a lawful arrest, and school officials are not subject to the same standards as law enforcement, it is clear that the court is sending a message that a higher standard applies to cell phone searches.

In a 4-3 ruling on Dec. 15, the Ohio Supreme Court ruled that a warrantless search of data within a cell phone seized incident to a lawful arrest violates the Fourth Amendment of the United States Constitution when the search is unnecessary for the safety of law enforcement officers and there are no exigent circumstances (*State v. Smith,* Slip Opinion No. 2009-Ohio-6426).

The case stems from the 2007 arrest of Antwaun Smith in Beavercreek on drug-related offenses. During the arrest, police searched Smith and found a cell phone on his person. Police confiscated the cell phone and later, the phone's call records and phone numbers were searched. The police did not have either a warrant or Smith's consent to search the phone. The trial court permitted testimony about the call records and phone numbers. On appeal, the Greene County Court of Appeals affirmed. The Ohio Supreme Court accepted jurisdiction of Smith's discretionary appeal to determine whether the Fourth Amendment prohibited the warrantless search of data within a cell phone when the cell phone is lawfully seized as part of an arrest.

The state argued that the court should rely on United States v. Finley (C.A.5, 2007), 477 F.3d 250, and concluded that the cell phone is akin to a "closed container" and is subject to search upon a lawful arrest. The court disagreed, holding that a cell phone is not a closed container for purposes of the Fourth Amendment. The court decided that it would not be helpful to create a rule that requires officers to determine whether a cell phone was a closed container or a computer, depending upon its capabilities during an arrest situation.

The Ohio Supreme Court concluded that because a cell phone is not a closed container, and because an individual has a privacy interest in the contents of a cell phone that goes beyond the privacy interest in an address book or pager, an officer may not conduct a search of its contents during a lawful arrest without first obtaining a warrant.

LEGISLATIVE REPORT

Overview of school nutrition and PE legislation

House Bill (HB) 373 and Senate Bill (SB) 210 are bipartisan bills that would establish nutritional standards for schools, measure students' body mass index (BMI) and make other changes pertaining to physical education. The bills are pending in both the House and Senate Health committees. Specifically, the legislation would:

• require schools to provide 30 minutes of physical activity for students each day;

• increase required physical education time for high school students from a half-unit to a full unit, and ensure that teachers are licensed in physical education;

• require schools to offer more nutritious food and beverages in vending machines and on a la carte menus;

• require body mass index screenings for students entering third, fifth and ninth grades, educate parents about the results and post aggregate results on district report cards;

• increase access to free breakfast for students who qualify.

The bills are being referred to as the "Healthy Choices, Healthy Children" legislation. They are being pushed by the Healthy Children Coalition, which includes the Ohio Business Roundtable, Ohio Children's Hospital Association, Nationwide Children's Hospital and the Children's Hunger Alliance.

OSBA has reviewed the legislation and has some concerns

about how it will be funded, as well as how these additional physical activity and physical education requirements will fit into an already busy school day. We recently sent an e-mail to our members on the proposals and received some great feedback. As a result of that response, we put together a list of changes we would like to see made to HB 373 and SB 210. This list has been shared with the Healthy Children Coalition, as well as the bills' sponsors. The list includes: Food and

Clean up definition of a la carte to match federal guideline terminology.

programs that help identify foods that are healthy for students, for example, the Alliance for a Healthier Generation program. O Align Ohio nutritional standards with new federal standards when they are adopted, with no exceptions.

 BMI requirements

 Do not list BMI data on school district report cards.
 Specifically exempt BMI data from being a public record.
 School districts would report BMI data to the Ohio Department of Education

 (ODE).

O ODE would aggregate the data and report the information to the Healthy Choices for Healthy Children Council.

• Physical education/physical activity

O Remove mandates from the bill: these provisions should not be implemented until a funding mechanism can be included.

• School districts should continue to have flexibility in offering waivers for athletic participation in lieu of physical

• Students requesting a waiver would undergo some physical education training as part of their required orientation to the program.

O A pilot program for the physical activity and physical education requirements included in the current version of the bills could be adopted as a voluntary pilot program for districts that want to participate; philanthropic donations could be used to fund the pilot.

- Health and wellness education O Missing from the current versions of HB 373 and SB 210 is a health and wellness education component, yet the development of healthy lifestyle habits is only likely to result from education and understanding of the implications of ignoring our own health and wellness. O School districts could be required to offer health and wellness education as part of their health curriculum; ODE would provide model curriculum.
- Council representation

 Add a school board member representative to the Healthy Choices for Healthy Children Council.
