A study by the Advancement Project says that the punitive aspects of zero tolerance and high-stakes testing policies have turned schools into alienating environments for many youth, especially those from minority and low-income groups. In what it called the "school-to-prison pipeline," the report said that students who are expelled or held back under those policies often fall behind, drop out and end up in the criminal justice system. 34-year-old school bus has second life as a snowplow

While recent winter storms have kept many school buses parked, there's one old workhorse that can't wait to hit the road on snowy days — Newport Independent Schools' "Snow Bus."

About 20 years ago, the northern Kentucky school district was ready to junk the aging school bus. Instead, the 1976 model underwent some mechanical upgrades, was fitted with a snowplow and now keeps school drives and sidewalks clear. Christened the Snow Bus by district maintenance supervisor **Dan Case**, the unusual vehicle saves the district from having to hire private contractors to clear its campuses.

"The whole thing is to get the kids to school safe," Case told a local newspaper. "Snow Bus helps."





Using WebQuests to promote learning

Here we go again, speaking techno-talk. What is a "WebQuest"? OK, let me see if I can help explain this one.

According to Wikipedia, which we'll cover later, a WebQuest, as implied by the name, is an inquirybased, online learning activity. During this activity students work in groups, dividing assignments among each other, so that everyone participates in a group-assigned role. The objective is to promote transformative learning outcomes, accomplished by reading, analyzing and synthesizing Web-based information. WebQuests were invented by Bernie Dodge and Tom March at San Diego State University in 1995.

WebQuests are fantastic ways to promote project-based learning and improve social interaction among groups of students. As **Don Tapscott** reminds us in "Growing Up Digital: The Rise of the Net Generation," social interaction places the teacher in a unique role. "The teacher is not an instructional transmitter," Tapscott writes. "He is a facilitator to social learning whereby learners construct their own knowledge."

WebQuests consist of six building blocks:

• the introduction: background knowledge that encourages the learner's interest;

• the task: a detailed explanation of what the learner is expected to do;

 the purpose: steps that learners can take to complete the quest;

• resources: Web sites and other resources for the quest;

the evaluation: measures the quest's impact on learning;
the conclusion: teachers and learners reflect on and summarize the quest.

When a teacher assigns a WebQuest project, each student in the group is responsible for a part of the quest. Social interaction and team responsibility are honed as they work together to complete each of the six building blocks. The WebQuest encourages each student to be responsible and do his or her part for the team, working together to complete the project.

When students are engaged learners they begin to realize

learning is a social experience. They are able to view their own ideas through the eyes of others, encouraging better evaluation skills, open-mindedness, fair play and even conflict resolution.

The Web site

(www.webquest.org) is an excellent place to learn how to use WebQuests for classroom projects. The site contains a wealth of knowledge about how to prepare for and use a WebQuest with students from varied age groups, and includes templates, examples and links to hundreds of validated content.

Oh yes, I almost forgot to mention Wikipedia. How about completing a WebQuest of your own? Go to **www.wikipedia.com**, think of a word or phrase you've heard at a board meeting, enter it in the search box, click the arrow and see what pops-up!

OSBA testifies against elimination of income tax

House Bill (HB) 400, sponsored by Rep. John Adams (R-Sidney), would eliminate Ohio's personal income tax over the next decade. OSBA, along with the Buckeye Association of School Administrators and the Ohio Association of School Business Officials, presented joint testimony in opposition to the bill before the House Ways and Means Committee. We are very concerned about the proposal and the potential negative effect it could have on public education in Ohio.

Currently, the income tax makes up 44% of the state's General

Revenue Fund (GRF); and according to the Legislative Service Commission (LSC), a little over 40% of the state's GRF goes to primary and secondary education.

HB 400 would completely eliminate the personal income tax without including any type of replacement mechanism for the loss of revenue that would occur. According to an LSC report on HB 400, if the income tax were to be eliminated, school districts could be facing 3.2% cuts in state funding the first year and 31.6% cuts when fully phased-in.

Our testimony states that "since

the income tax makes up such a significant portion of the state's GRF, we are concerned that the elimination of this revenue source will cause a major shift in tax burden to local residential property taxpayers. Ohio schools rely on state revenues to provide education services to their students. Without that support, districts would be forced to go back to the ballot even more often than they do today and to request higher millage amounts."

Expert testimony on the effects of HB 400 was also provided by Dr. **Howard Fleeter** of the firm Driscoll *Continued on page 7*

PUBLIC SCHOOLS WORK!

Real-life science is at work at Cuyahoga Heights Local

Science students at **Cuyahoga Heights Local (Cuyahoga)** Elementary School are no strangers to alternative energy. For the past two years they have been exploring how to produce clean, viable and economical energy.

This educational journey began when their teacher, **Barbara Currey**, was awarded a Jennings Grant, enabling the purchase of a small wind turbine. With parent and custodial help, the turbine was installed on the roof outside the science room and now powers four outlets in the classroom.

Last year, all third-graders were involved in a play titled, "Update Earth." The play provided the springboard for students to learn about wind energy, solar energy and hydroelectric power. Students created T-shirts with slogans like "drive a hybrid" and "use wind, not coal." These shirts became their costumes when they performed the play — first for the entire student body, and later for parents.

This year, the third-graders are exploring wind energy by building mini wind turbines in class. They will test these turbines using fans in the classroom and by taking them outside to capture the "real" wind. Finally, they will be asked to compare the output of their small turbine to that of the huge turbine at the Great Lakes Science Center.

Whew! That's a lot of hot air.

and Fleeter. He is a consultant for the Education Tax Policy Institute (ETPI), a nonprofit research organization dedicated to analyzing and reporting on public policy as it relates to education funding and the tax issues that generate revenues for schools. OSBA and the other school management organizations are members of ETPI and requested an analysis of HB 400 and its impact on state funding. Fleeter presented a summary of his analysis and findings to the committee. Some of the key data he shared include:

• Ohio ranks 35th in the nation in state taxes per capita (1 is the highest).

• Eliminating the income tax would put Ohio 50th in state taxes per capita.

If the income tax were to be eliminated, Ohioans earning zero to \$50,000 would save an average of \$334 per year in income taxes. Those earning more than \$250,000 would save an average of \$27,621.
Three of the nine states with no income tax — Florida, Tennessee and Nevada — have jobless rates equal to or higher than Ohio's.

The committee also heard testimony from a local school

district's perspective. OSBA would like to thank **Mason City** Schools Superintendent Dr. **Kevin Bright** and Treasurer **Dick Gardner** for coming to Columbus to testify in opposition to HB 400. They shared the devastating effects the proposed legislation would have on their district if the income tax were eliminated.
