





TECHNOLOGY

To VoIP or not to VoIP, is this a question?

In the world of technology everything has become "IP" — Internet-protocol based. In the case of VoIP (voice over Internet protocol), it means that your school district is considering — or has moved to a communications platform that is based on an Internet-protocol standard. VoIP is very popular because it provides long-term financial savings and often allows school districts to "piggyback" on existing data networks established for Internet traffic.

For many Ohio school districts, VoIP is an option if they are building new or remodeling existing facilities. The Ohio School Facilities Commission (OSFC) encourages VoIP systems for its projects, or, at the very least, recommends new facilities are built with this capability so it is available when the district moves to VoIP.

As a board member, why is VoIP important to your district? Well, VoIP is becoming the standard and everything will eventually move toward it. You can transmit multiple signals over a single connection and it makes integration with other services, like video conversation, audioconferencing or data file exchange, during the conversation possible.

Since VoIP uses the Internet protocol, merging it with a variety

of other technologies is cheaper for vendors who are developing applications and interfaces. Cheap is good for business, so integration of VoIP in products will drive the communications market for years to come. There are a variety of vendors in the market that can supply VoIP systems. OSFC or eTech Ohio are good starting points for project research or questions.

Keep in mind that a VoIP system means a complete replacement of existing infrastructure. Depending on the implementation, it may be possible to switch a few buildings at a time, but in most cases, a change to VoIP means the change must occur for all facilities at once. There are start-up costs when switching to VoIP, including an analysis of the district's requirements and infrastructure; potential upgrades to network

equipment; increased bandwidth to support Internet traffic; installation and set-up expenses; and the replacement of handsets throughout each facility.

There are a few minor drawbacks to VoIP. Since VoIP uses the district's network to "make the call," it is important to keep the network operating at all times. Maintenance and life cycle replacement programs for routers and switches, as well as high-speed Internet connections between buildings and your Internet service provider, are critical. Networks require power to remain active, so if your district does not provide uninterruptable power or battery backup capabilities for all network gear, it should be added to your capital improvement list.

Finally, emergency-calling capabilities are extremely important for school facilities, and should the network fail, it is always advisable to have one old-fashioned copper line active in each facility.

So to VoIP or not to VoIP? As everything in our lives moves to an Internet-based standard, is there really any question? If you've not yet made the move, sometime in the future you will.

Proposed alternative energy fee rate would shortchange schools

The General Assembly is just coming off its spring recess, but primary races are commanding a great deal time for those on both sides of the aisle. While the House did reconvene following the Easter weekend, the Senate has indicated that it will not return until after the May 4 primary elections. As a result, only limited activity is occurring in committees.

However, one area that is continuing to receive concentrated attention in the General Assembly is alternative energy. Two separate bills are currently pending. Senate Bill (SB) 232, sponsored by Sen. **Chris Widener** (R-Springfield), was introduced in February and has now had six hearings, while House Bill (HB) 464, sponsored by Rep. **Roland Winburn** (D-Dayton), was introduced in March and has had four hearings.

While the bills do differ in specific details, the primary thrust of both is to provide wind and solar energy developers with exemptions from tangible personal property taxes, substituting instead a payment in lieu of taxes (PILOT). Under either bill, the proposed PILOT payments would be substantially lower than what would result from applying current tangible personal property tax rates. Wind developers have argued that Ohio's tax structure is not competitive with surrounding states and that some form of tax break is necessary if alternative energy development is to prosper in the state.

The strong interest in promoting wind and solar energy is based on several factors, including the desire to make clean, renewable alternative energy more accessible to Ohio consumers. There also is a strong economic component, with advocates believing that alternative energy developments will promote jobs and economic growth in the local communities where the wind farms and solar installations are located. The projects promise not only to create short-term construction jobs, but also more permanent jobs associated with the ongoing operation and maintenance of wind turbines and solar panels. There also is the hope that Ohio's location and manufacturing capacity make it an ideal candidate to benefit from the manufacture and distribution of component parts for wind turbines and solar panels.

Parma City earns honorable mention in Magna Awards program

Parma City Schools has been named an honorable mention recipient in the *American School Board Journal*'s 16th annual Magna Awards program. It is the second time Parma has been recognized in the prestigious national program. In 2005, the district won a Magna Award for its "Improving School by School" project.

Parma was recognized this year in the 5,000 to 20,000 enrollment category for its "Leadership for Tomorrow" program to promote civic involvement. Administrators, Ohio Association of School Business Officials, Ohio Education Association and Ohio Federation of Teachers to offer interested party testimony on SB 232 and HB 464. Both bills would have a substantial negative impact on property tax revenues for schools and local governments. While understanding the need and desire for alternative energy development and appreciating the potential economic development that may occur, the organizations want the legislature to be certain that the tradeoff of local tax revenues will result in a good return for the communities involved.

Since both parties and the governor have spoken frequently and passionately on the need to spur wind energy development in Ohio, the associations recognize that one of these two bills, or a compromise version, will be passed and signed into law. They do, however, believe that the level of tax exemption proposed is greater than absolutely necessary for Ohio to be competitive.

For example, expert testimony offered by Dr. **Howard Fleeter** on behalf of the Education Tax Policy Institute noted that the amount of the proposed PILOT payments could be doubled or nearly tripled from \$6,000 per megawatt to as much as \$15,000, and Ohio would still be competitive with surrounding states. This position was also supported by testimony offered by a representative of the League of Women Voters of Ohio.

In short, the organizations believe that local communities and schools should not be expected to bear the entire burden of the costs for long-term benefits that hopefully will be derived statewide from attracting wind energy production and manufacturing in Ohio.
