# LEGAL BRIEFS

# Deadline for family and civil engagement teams is June 30

As a result of House Bill 1, Ohio Revised Code Section (RC) 3313.821 requires boards of education to establish a family and civil engagement (FCE) team by June 30, 2010. Under the statute, each board may determine the membership and organization of its FCE team, so long as the team includes parents, community representatives, health and human service representatives, business representatives, and others identified by the board. Boards may use their current business advisory council to perform the functions of both the business advisory council and the FCE team, so long as the membership and responsibilities of the combined committee satisfy the membership requirements for both groups.

There are a number of ways to establish an FCE team. The Ohio Department of Education has created a sample resolution for boards to use to appoint their FCE teams. This resolution is not required by RC 3313.821 and may limit some of the flexibility that boards have in organizing and determining the membership of their FCE teams. The sample resolution also suggests that the names of the team members be adopted in the board resolution. However, the members of the team will likely change over time, so this may be impractical and unnecessary.

Another way for boards to establish their FCE teams is by establishing the team through the adoption of a board policy. This approach has a number of benefits. Policies are readily available to and understood by the general public. Since the intent of the FCE team is to connect schools, families and communities, outlining the existence and purpose of the FCE team in a board policy may be beneficial in generating community interest and support. Establishing the FCE team through policy also may be beneficial over time, since new board members will likely be more aware of the policies adopted by the previous board than the resolutions it adopted. Finally, policies give boards greater flexibility in determining the membership and organization of FCE teams, since they allow boards to more freely appoint and remove people from the team.

OSBA has drafted a sample Family and Civic Engagement Committee policy for boards to adopt (policy BCFA/BCFB). The sample policy complies with the requirements of RC 3313.821.

# Healthy Choices, Healthy Children discussions continue

The legislature is still deliberating on Senate Bill (SB) 210 and House Bill (HB) 373, the Healthy Choices, Healthy Children legislation. Both bills are currently being heard by the House Health Committee. However, it is our understanding that SB 210 will be the vehicle for the legislation.

SB 210 requires schools to provide at least 30 minutes of moderate to rigorous physical activity per day for grades K-12. The bill provides that, due to an undue financial hardship, a school may apply for a waiver of the physical activity requirement. However, the provision would still be in permanent law with no

accompanying funding mechanism now or in the future. The best solution for schools is to remove the provision altogether to avoid the expectation that districts will comply at some point in the future.

Schools cannot solve the nation's childhood obesity crisis on their own, and we have seen no evidence that the mandate for 30 minutes of physical activity will make a difference. In lieu of mandates, encourage legislators to support the implementation of a voluntary program funded by philanthropically generated grants as a way to encourage school districts to implement the physical activity requirement. This would

allow for progress toward the goal of increased activity for students and provide an opportunity to evaluate the effectiveness of such activity.

OSBA, along with the Ohio Association of School Business Officials, the Ohio Education Association and the Ohio Federation of Teachers, presented joint testimony to the House Health Committee asking that the physical activity requirement be removed from the bill. # Twinsburg middle school students take trek in the Lost Boys' shoes

Students at **Twinsburg City**'s R.B. Chamberlin Middle School have a new appreciation of what the Lost Boys of Sudan went through.

The Lost Boys is the name aid organizations gave to the more than 20,000 displaced or orphaned boys who fled genocide and civil war in their homeland in 1987. They trekked 1,000 miles or more across African wilderness to reach safety — first to Ethiopia, then to a refugee camp in Kenya. Many of the boys were killed or succumbed to dehydration, disease or starvation along the way.

Undertaking their own lengthy trek, about 150 Twinsburg eighthgraders collectively walked 1,200 miles to raise money to build wells in Sudan. A few of the Lost Boys now living in the Cleveland area walked with the students. The well project, Isaac's Wells, was started by some of the Lost Boys who make the perilous journey back to Sudan to help build wells. English teacher and event organizer **Dave Ciborek** told a local newspaper that it costs about \$15,000 to dig a well and the students raised \$4,700 by soliciting pledges for every mile walked.

Ciborek told the paper that working with the Lost Boys fit well into the eighth-grade curriculum.

"We have read *The Diary of Anne Frank*," he said, "and the story of the Lost Boys is another example of genocide."

# Legislature to hold hearings on charter school lawsuit

Ten northeastern Ohio charter schools filed a lawsuit on May 17 seeking to void their contracts with White Hat Management, owned by charter school magnate **David Brennan**. The suit contends that White Hat has too much control over the schools' operations and that state law makes it almost impossible to break their contracts. It also states that the current contract and White Hat's proposed new management agreement "render the governing boards of the plaintiff schools virtually impotent to govern the schools ..." The suit also accuses White Hat of a number of financial improprieties.

Because of the claims filed in the complaint, the legislature has decided to hold hearings on the lawsuit. The Primary and Secondary Education Subcommittee of the House Finance Committee will be holding hearings to explore the issues brought to light through the lawsuit to determine if any legislative revisions are needed to ensure the best working relationship for charter schools in Ohio.

OSBA will update you on what occurs during the hearings and any legislation that may result.
