Report examines states' efforts to enhance teachers' skills

A recent national survey found that 9 in every 10 teachers wish they had more opportunities to further their careers and professional skills without leaving the classroom. Unfortunately, in many cases, teachers aren't given these types of opportunities to lead from the classroom. State leaders around the nation are working hard to address this issue by trying to help schools become places where teachers want to work and stay. Ohio ranks low in child health report, especially for dental care

A recent study by WalletHub ranked Ohio children's health care 42nd among the 50 states and the District of Columbia. The study examined 33 key indicators of cost, quality and access to health care. A breakdown of the report's three main findings showed Ohio ranking 46th in children's nutrition, physical activity and obesity; 43rd in oral health; and 29th in health and access to health care. Study: Students without home internet struggle with 'homework gap'

Nearly 3 million students around the country have trouble keeping up with their studies because they do not have internet service at home, according to a recent study by The Associated Press. While students in nearly every school have access to computers and the internet, the cost of home internet service and gaps in its availability create obstacles in urban areas and rural communities alike. In what has become known as the "homework gap," an estimated 17% of U.S. students do

not have access to computers at home and 18% do not have home access to broadband internet, The Associated Press found in an analysis of U.S. Census data. Children without internet at home are more likely to be students of color; from low-income families; or in households with lower parental education levels, according to the study. This puts them at a disadvantage, because students with home internet consistently have higher scores in reading, math and science than students who do not.

ODE unveils new K-12 computer science webpage

The Ohio Department of Education (ODE) has launched its new Ohio K-12 computer science webpage. It includes Ohio's Learning Standards and model curriculum for computer science along with guidance documents on the use

EHOVE summer camp emphasizes public safety, technology

Almost 300 students in grades four through nine signed up for EHOVE Career Center's summer camp, taking part in STEAM activities, including two new courses on public safety and drones.

Students navigated drones through obstacle courses using virtual reality technology and learned how to program their movements.

Campers also took turns outside using fire extinguishers to put out a diesel fire. They discovered that water won't extinguish a diesel or grease fire and learned safety skills, including how to stop bleeding.

"We wanted to increase interest in public safety and let them see if this is something they want to do," EHOVE Assistant Director Matt Ehrhardt told a local newspaper. "It's all about exposure. Here, kids experience what they've never experienced before." Source: Sandusky Register



LEGISLATIVE REPORT

Proposed changes to graduation requirements include competency score, credentialing

The Ohio General Assembly is just days away from approving long-term changes to high school graduation requirements. The changes were added by the Ohio Senate to House Bill 166, the state biennial budget bill. The changes are not yet approved due to failed negotiations over the budget bill and other legislative items, which forced lawmakers to miss their June 30 deadline and pass a temporary, 17-day funding extension. Despite the setback, the legislature and Gov. Mike DeWine are expected to retain the Senate's changes to the graduation requirements.

The plan would first apply to students in the class of 2023 but would permit students in the classes of 2018 through 2022 to graduate under the new system, instead of the system to which they are currently subjected.

Under the plan, students must attain a "competency score" on each of the state end-of-course exams in English arts II and algebra I. Additionally, students must obtain at least two "seals," a type of credential that demonstrates a student's competency in or completion of assessments, coursework, service or skills. The competency score a new scoring level — will be established by March 1, 2020, by the Governor's Executive Workforce Board, in consultation with the superintendent of public instruction and the chancellor of higher education.

The 12 seals include:

- State Seal of Biliteracy: obtained by demonstrating foreign language and English language proficiency according to state guidelines;
- OhioMeansJobs-Readiness Seal: obtained by demonstrating 15

professional skills and characteristics prescribed by the state:

- industry-recognized credential seal: obtained by attaining an industry-recognized credential that is aligned with an in-demand job;
- college-ready seal: obtained by attaining a remediation-free score on the ACT or SAT;
- military enlistment seal: obtained by enlisting in the U.S. armed forces or participating in a Junior Reserve Officer Training program;
- citizenship seal: obtained by attaining a proficient score on the state's American history and American government exams, attaining a proficient score on an Advanced Placement (AP) or International Baccalaureate (IB) exam in American history and American government or attaining an A or B grade in a College Credit



Plus (CCP) course in American history and American government;

- science seal: obtained by attaining a proficient score on the state's science exam, attaining a proficient score on an AP or IB exam in science or attaining an A or B grade in a CCP course in science;
- Honors Diploma seal: obtained by satisfying state criteria that exceed the state's minimum graduation requirements;
- technology seal: obtained by attaining a proficient score on an AP or IB exam in technology, attaining an A or B grade in a CCP course in technology or completing a technology course offered by the school district;
- community service seal: obtained by completing a community service project that is aligned with guidelines set by the district;
- fine and performing arts seal: obtained by demonstrating skill in the fine or performing arts based on a district-created evaluation;
- student engagement seal: obtained by participating in extracurricular activities like athletics, clubs or student government, which must meet district-set guidelines.

At least one seal must be completed from the first nine options listed above. The second seal may be completed from any of the available seals.

The proposed graduation plan also provides flexibility for students who are unable to attain a competency score on both the English and math tests. Such students must first retake any test for which they did not attain a competency score, and such students must be offered remedial support by their district. If a student still does not attain a competency score on both tests, the student may use an alternative pathway to graduation.

Such a student can qualify for graduation by earning CCP credit

in the course in which the student failed to attain a competency score, by enlisting in the U.S. armed forces or by demonstrating competency in what the plan calls "foundational" or "supporting" options. To demonstrate competency, students must complete two of the following options, one of which must be

from the first four options:

- earning a proficient score or higher on four state technical assessments in a single career pathway;
- obtaining an industry-recognized credential;
- completing a pre-apprenticeship

or apprenticeship in the student's chosen career field;

- being accepted into an apprenticeship program after high school that is restricted to participants who are at least 18 years old;
- completing 250 hours of work-

based learning with evidence of positive evaluations;

- obtaining an OhioMeansJobs-Readiness Seal;
- Attaining a workforce-readiness score on the WorkKeys test.

Hamilton students spend summer learning city management

A group of high school students in the southwest Ohio city of Hamilton are getting a summer crash course on how to run a modern city.

An eight-week career and leadership program introduces students to job opportunities and possible careers. The course also presents students with realistic challenges city leaders deal with all the time.

"We learn networking, we learn social skills, we spend a lot of time on soft skills," **Dan Bates**, president and chief executive officer of the Greater Hamilton Chamber of Commerce told a local TV station. "Really, just how to present themselves in public."

Any high school student in the Hamilton area is eligible to enroll in the summer program. Students from **Hamilton City** and **Fairfield City** are participating this year.

Local businesses also enjoy getting involved in the program because it gives them a chance to show students there are opportunities to stay in the area after school.

"I think we learn as much as the kids do," Bates said. "It's interesting to see their perceptions of different businesses and different things that are happening in the city."

Above all, the program is designed to invest in the future of Hamilton through a younger generation, Bates said.
