Plans being finalized for virtual Capital Conference and Trade Show

Report: COVID-19 adds barriers to child well-being in Appalachian Ohio

The Children's Defense Fund-Ohio (CDF-Ohio) recently released Children and Families in Ohio's Appalachian Region: 2020 Data & Issue Brief. The study provides a snapshot of pre-COVID-19 challenges facing Ohio's 32-county Appalachian region, challenges that have only intensified during the pandemic. The report found that the pandemic has amplified disparities in Ohio's Appalachian region, particularly in the areas of health care; housing; nutrition; early care and education; child welfare; and K-12 education. Jeanette Charles, a longtime volunteer with **Mason City Schools'** Parent-Teacher Organization, has been collecting extra bottles of hand sanitizer and other supplies she imagines teachers might need in the classroom during the pandemic.

When she got a Facebook invitation from a friend in her hometown of Omaha, Neb., for a local adopt-a-teacher group, it inspired her to start her own group for Mason City educators.

"(Teachers) are going to need to reexamine their classrooms and how they do this safely for the kids," she told a local newspaper. "I wanted to make sure the teachers had everything that they needed to go back to school."

Charles' group has adopted more than 145 teachers.

Trustees discuss new plank for legislative platform, honor late regional manager Diver

At its July 25 meeting, the OSBA Board of Trustees discussed a new plank for the OSBA Legislative Platform to address diversity and equity issues; met with the new National School Boards Association (NSBA) executive director and its president; and passed a resolution honoring late OSBA Southwest Regional Manager **Ronald J. Diver**.

OSBA President **Lee Schreiner, South-Western City**, led the meeting, which was held virtually due to state regulations limiting in-person meetings.

Kimberly Brazwell, a consultant for the OSBA Diversity & Equity Consulting Service, led a presentation on diversity and inclusion in schools and workplaces. A former educator, she is the chief executive officer of KiMISTRY, a diversity and equity coaching and consulting firm.

Brazwell discussed the trauma that results from racism and how it impacts classrooms and

workspaces. It's important, she said, to build diverse teams so that those leading the diversity initiatives in their district aren't working in isolation, which can lead to more trauma.

In addition, team leaders can invite those who are disenfranchised to meetings and involve them in decision-making. This provides new ideas and points of view for better outcomes.

As the school year begins, it is important to realize that “children often are ready to talk about race before adults are,” she said. Resources on conducting critical conversations can help staff and students have discussions on events impacting their lives.

Each person can make a promise to do something in the diversity and inclusion space, Brazwell said. This could include reading a book on diversity and equity, participating in a learning experience or talking with

someone with a different race lens.

“This work is not one person's work,” she said. “It's everyone's work. What is your small part you can play in this work?”

“Everyone has the ability to grow as a student and a teacher.”

Later in the meeting, the Board of Trustees directed OSBA staff to develop a new plank for the OSBA Legislative Platform on racism and equity. The proposed plank was shared with the Legislative Platform Committee at its meeting on Aug. 1 and approved to be considered by the 2020 Delegate Assembly in October.

NSBA Executive Director **Anna Marie Chávez** and NSBA President **Charlie Wilson**, a board member at **Worthington City Schools**, joined the meeting to greet trustees and share NSBA's recent initiatives. Chávez, who was appointed in June, explained that NSBA is exploring how to better serve the

Workshop dates and descriptions

Sept. 16 — Routing and technology (virtual)

In today's school environment, it is essential to maximize route efficiency and get the best use out of your buses. This also becomes key as we manage continuing driver shortages. No one can afford to run extra buses or run buses with only a few students. We will look at some proven strategies for determining how many buses you really need and different styles of routing. This conversation also requires us to look at routing cost analysis. We will examine some of the technologies available to districts to assist with routing and their costs and benefits.

Oct. 28 — Personnel management (virtual)

Employees can either “make or break” any operation. A transportation administrator must have some knowledge of labor practices to effectively manage staff, especially when there is a bargaining unit. Discussion will include not only working with contracts but also discipline, grievances, arbitration, negotiations and practices. We also will review driver qualifications and how to manage issues, evaluations and monitoring driver license records.

Dec. 2 — Transportation rules and regulations (virtual)

Without a working knowledge of the laws and rules, the transportation administrator is flying blind. This class will walk through the key regulations that you might have overlooked, forgotten or not even have known existed. We will explore the relationship between federal, state and local regulations, talk about policy versus practice and then look at a checklist that every transportation department can use to measure its performance and compliance. This class is a favorite not only for brand new supervisors but also veterans and other school administrators who are responsible for pupil transportation service.

Feb. 3 or 10 — The transportation handbook (virtual or in-person)

Transportation administrators cannot afford to “fly by the seat of their pants” or to be inconsistent in management practices. Guidelines and procedures are essential and can be the manager's best friend. Other issues that are related include board policy, administrative guidelines, labor agreements and other local resources. We will discuss the handbook development process as well as what to include in the handbook and how to keep it current.

March 3 or 10 — Public relations and working with the media (virtual or in-person)

We will have two related focus points for this session. First, we will experience a live interview process to refine our skills in developing talking points and staying on target in an interview about a real event. Second, after focusing on reactive news responses, we will shift focus to proactive news relationships to inform your community about the resources your transportation department offers.

April 7 or 14 — Designing your operational plan and building keys for success (virtual or in-person)

We will start this final class of the year by looking at how to put the operational plan together. What is your work calendar? When do you need to do what, and how do you schedule or delegate that project? Much of what we do has a critical work path, and unless you plan your work in advance it is easy to get “behind the curve” and feel like you are trying to catch up. After that, we will focus on building support networks, identifying friends and foes and how to recognize where you need allies to succeed. Building your stakeholders' group and support network is key to your success and helps broaden your potential for positive impact.

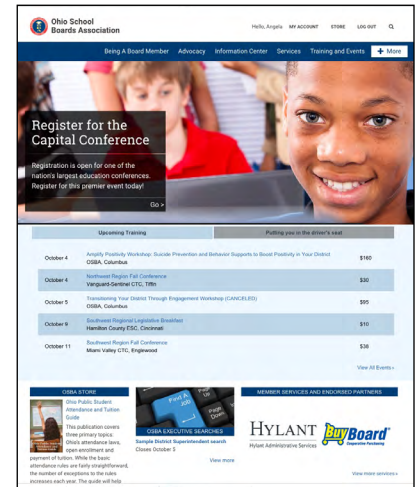

state school board associations by focusing on membership, innovation and services.


OSBA Immediate Past President **John W. Halkias, Plain Local (Stark)**, who serves on the NSBA Board of Directors, provided information on upcoming regional NSBA meetings and the NSBA Delegate Assembly, which will meet virtually in August. The trustees took action to approve the NSBA dues for 2020-21.

The trustees unanimously approved the resolution honoring Diver, who died in April. Prior to serving as a regional manager, he

was a school board member at **Carlisle Local (Warren)** and **Miami Valley Career Technology Center** for 29 years and served as OSBA president in 1998. The board also welcomed **Mark Ewing**, who was appointed southwest regional manager on July 8. Lorain City thanks Ohio National Guard, volunteers

Lorain City joined with the Second Harvest Food Bank a few years ago to begin providing food pantries at schools throughout the district.

When the COVID-19 pandemic began, the need was even greater, with school pantries serving as many as 550 families a night, Superintendent Dr. **Jeffrey M. Graham** told a local newspaper.

That's when the Ohio National Guard and many other volunteers stepped up to help with food

distribution, driving and warehouse sorting and packing, said **Julie Chase-Morefield**, the president and chief executive officer of Second Harvest Food Bank.

The district recently honored volunteers, both military and civilian, for their work with a picnic dinner at Lorain City's Longfellow Middle School, a site for the drive-through distribution program.

Volunteer **Jackie Ziegler**,

Lorain High School's ninth-grade dean of scholar and family engagement, told soldiers that they truly made a difference for families.

"This has been a really hard time, so without your help this couldn't have been accomplished, and our families tell me every day that they really appreciate everything that you all do, because this couldn't have happened without you," she said.

In other business:

- OSBA Deputy Chief Executive Dr. **Kathy McFarland** updated trustees on the work being accomplished through OSBA's strategic plan, Visionary Initiatives for Strategic Action (VISA). Trustees approved an amendment extending the goal of a staffing perpetuation plan through 2022.
- OSBA Chief Financial Officer **Allison Morris** briefed the board on the association's finances for the first half of 2020. **Alex Bey**, a portfolio specialist at Johnson Investment Counsel, provided an update on the association's investments.
- OSBA Director of Legislative

Services **Jennifer Hogue** presented a legislative update.

- **Halkias**, chair of the OSBA Nominating Committee, presented the committee's report. On July 11, the committee selected **Robert M. Heard Sr., Cleveland Municipal**, as the nominee for 2021 OSBA president-elect. If confirmed by the OSBA Delegate Assembly, Heard will become president-elect on Jan. 1.
- Chief Legal Counsel **Sara C. Clark** provided an update on the work of the OSBA Governance Review Committee. The committee is expected to complete its work in early 2021 to present to the trustees.

These written reviews serve as a critique of current contract provisions, suggest potential pitfalls regarding legal compliance and provide specific recommendations as you go into your next round of collective bargaining.
