Partnerships, strategic plan, awards focus of trustees meeting

"We'd like for you (and schools across the state) to look at this," Superintendent of Public Instruction **Paolo DeMaria** said while explaining an infographic summarizing Ohio's strategic plan for education. "You are being asked to write competencies down and rate yourself and then connect all the dots ... success can come packaged in different ways."

As part of the OSBA Board of Trustees' July 28 meeting, DeMaria detailed each section of the Each Child, Our Future strategic plan, which was publicly released Aug. 28. During its formulation, more than 150 Ohio-based partners and 1,200 citizens, including students, reviewed the plan and provided feedback.

"We want to make education exciting, engaged, empowered so learning doesn't end at high school but opens the next chapter after high school, whether it's a vocation, college, et cetera," DeMaria said.

During the meeting, led by OSBA President **Randy Smith**, **Forest Hills Local (Hamilton)**, trustees listened to several guest speakers as well as recommended changes to the association's board member awards program.

Over the past 16 months, the OSBA Awards Review Task Force held multiple meetings reexamining all of OSBA's efforts in awards and recognition. Task force Chair Eric K. Germann, 2016 OSBA president and a board member at Lincolnview Local (Van Wert) and Vantage Career Center, summarized the committee's recommendations,

Sept. 12 or 19 — T-reports and state funding

Review the data that is reported to the state annually. Learn how to set up a system that works well for each district and how that data is used to calculate funding for your district. We also will look at other ways in which data is valuable to each operation.

Oct. 15 or 18 — The budget process — local and state

Transportation is a significant cost center in every school district. Learn about the local and state budget process, including a review of cost analyses and how to find them, what to do with them and what the numbers mean. Consider bringing your department budget to this class to apply these techniques to it.

Nov. 28 or Dec. 6 — Transportation rules and regulations

Review the rules and regulations that govern pupil transportation in Ohio. Look at state law, administrative code and the role that local policy plays in a successful operation. What is the difference between revised code, administrative code and department policy? Are they all mandates or just best practices? What happens when they conflict? Review the technical aspects of these various regulatory controls and the process through which ideas become rules or regulations. Learn how you can help influence the future.

April 3 or 10 — Hot topics — safety, trends and statistics

Review hot topics in student transportation, including seat belts in school buses. Learn about NTSB accident studies, Ohio school bus accident statistics and any topics that attendees bring from their local districts. While we look at these hot topics, an underlying focus also is on how to identify the learning points in each of these areas and share them with the staff that delivers our front-line transportation services.

Despite demographics, any student who is chronically absent is more likely to have lower achievement and is less likely to graduate than their non-chronically absent peers. This session will discuss evidence-based practices to help school leaders address chronic absenteeism with their students.

and trustees approved the Awards and Recognition Program document to guide staff with implementation.

In January 2020, OSBA will roll out a new program for board member awards. An acronym — STAR — has been developed as an outline for key awards and stands for Service, Training, Aptitude and Recognition. When a board member receives all four awards within a three-year period, he or she will become a Master Board Member. Master Board Members are then eligible for nomination from their regions to the All-Ohio School Board, OSBA's highest individual board member honor.

Additionally, OSBA will have a new recognition for full boards that participate in training together. The Ohio Board of Distinction will be awarded based on a two-year cycle of activity beginning the January following board elections. Activities must add up to 600 points per board, with each individual member contributing a minimum of 100 points.

The committee recommended no significant changes to any regionally based recognitions. It recommended exploring the creation of credentialing programs and changing School Board Recognition Month to earlier in the school year. More specifics about all of the award changes will be shared closer to the 2020 implementation date.

Another committee, the OSBA Charter School Task Force, presented its recommendations after studying the potential future impact of charter schools in Ohio on OSBA and its members. Chaired by Smith, the team held multiple meetings over the last 16 months.

Based upon the team's recommendation, the trustees voted unanimously to continue the current practice of allowing charter schools to participate in OSBA programs and services but only if they are sponsored by a member of the association. Member-sponsored charter schools are eligible for a subscription membership, which allows them to access resources, receive publications and attend training. OSBA will begin providing professional

development opportunities specifically targeted to charter school subscription members. The association also will market information to eligible charter schools about the subscription membership and OSBA's programs and services through the traditional public school boards that serve as their sponsors.

In other business, Chief Financial Officer **Allison Morris** briefed trustees on the association's finances, with the assistance of two guests. **Alex Bey**, from Johnson Investment Counsel, provided a report on the association's investments, which have had "historically low volatility and great returns."

Danah Smalley, manager at RSM US LLP, provided an overview of the auditor's opinion and OSBA's audited financial statements, saying it was "a clean audit ... and I am extremely impressed with (OSBA staff) who are always helpful and accommodating."

Another guest, **Terry Russell**, executive director of the National Alliance on Mental Illness Ohio, shared information about the group's work. The alliance is one of more than 20 organizations partnering with OSBA to hold the Sept. 12 School Security and Safety Solutions Summit at the Greater *Continued on page 7*

"Eighty percent of children with mental illness do not receive any treatment at all," said Russell. "We must do a better job of recognizing intervention. Early support can reduce mental illness problems. Together, we must demand mental health professionals in every school district in Ohio ... ensure youth have access to coordinated treatment ... and reduce barriers to providing care in schools."

OSBA Chief Executive Officer **Richard Lewis** said he hopes the summit is just the beginning of a something out there that will work for those students that either don't want to go to college, can't afford to go to college at this stage in their life, but want to be productive," Dayton City Superintendent Dr. **Elizabeth Lolli** told attendees.

The partnership's goal is to create a pipeline for students to have high-paying jobs, revitalize the local economy and attract more businesses to the area.

"This is more than just a

workforce issue," Dayton City Commission member **Chris Shaw** said. "As we go about doing the work of attracting business to this community, the No. 1 question is, do you have a skilled workforce?"

Apprentices earn money while they're learning skills that can later land them jobs making \$30 an hour, said **Tom Ritchie**, Dayton-Miami Valley Regional Labor Council president.
