#### American, Ohio public education weeks are next month

American Education Week — Nov. 13-17 — provides the opportunity to honor public education and recognize those who work hard to ensure that every child receives a high-quality education. November also marks the first Ohio Public Education Appreciation Week. Legislation was enacted earlier this year designating the week before Thanksgiving for the commemoration.

#### Study explores how hunger affects test performance

Students whose families are running low on food stamp benefits perform worse on math tests, according to a study by researchers at the University of South Carolina. Researchers say the monthly schedule for distributing food stamps in South Carolina coincides with testing schedules in such a way that students may have gone hungry for several days by test time. Other studies from across the U.S. show that students who experience chronic food insecurity struggle with testing and learning year-round.

#### Ohio child poverty rates down but still above national average

Based on new U.S. Census Bureau data, nearly 70,000 Ohio children rose out of poverty from 2014 to 2016 and more than 30,000 gained health insurance coverage, according to the Children's Defense Fund Ohio. However, too many Ohio children still languish in poverty, the group said, with African-American, Hispanic and multiracial children experiencing poverty at much higher rates than white and Asian children. Poverty is defined as an annual income below \$24,563 for an average family of four. Extreme poverty is half that level, with almost 10% of Ohio's children living in households below that threshold. The group reported that the state child poverty rate

fell from 21.3% in 2015 to 20.5% in 2016. Ohio's child poverty rate is above the national average.

The new state budget bill authorized two more graduation options for students who entered ninth grade between July 1, 2014, and June 30, 2015. They provide an opportunity for students who do not meet one of the three existing pathways to earn a diploma. complete with promotional materials, activity ideas and downloadable templates.

Some suggested activities include:

• Organize an AEW kickoff open house to celebrate education, teachers, education support professionals, substitute teachers, parents and students.

• Distribute a media alert and press release about your event. Get samples at www.nea.org/aew.

• Use social media to promote the activities in your district. NEA has sample tweets and Facebook posts available in the AEW tool kit. Use the hashtag #AEW2017 in your tweets.

• Invite parents to have lunch with their children in the school cafeteria.

• Ask a local radio station to share "quiz" questions about the city's schools.

### Senate Education Committee hears e-school accountability bill

The Senate Education Committee recently held a hearing on Senate Bill (SB) 39, legislation that would enact a number of provisions that would increase oversight and transparency of online charter schools, or e-schools, as initiated in House Bill 2 of the 131st General Assembly. The legislation, sponsored by Sen. **Joe Schiavoni** (D-Boardman), would require e-schools to submit a monthly report on student participation in learning opportunities to the Ohio Department of Education (ODE). These schools also would need to notify the student's parent, ODE and the school district of residence if a student fails to participate in learning opportunities for 10 consecutive days. In addition, e-school representatives would be required to confer with a student's parents if his or her performance declines.

#### Berea City alum donates company; students running business

Instead of selling his company or passing it onto his children, a **Berea City** Schools alum made a unique donation.

**Doug Kawiecki**, a 1980 graduate of Berea High School and owner of ACM Signs & Graphics, donated his company to the district and helped create an innovative entrepreneurial program at Berea-Midpark High School. He told a local TV station his wife inspired him to do it.

Kawiecki's donation included

\$75,000 worth of equipment and a computerized router.

Students are now learning how to make professional signs and run a small business.

"This class is very different, a lot of hands-on work," junior **Nicholas Ruggiero** said. "No books involved."

The company, which sells real signs, is now called Lightning Strike Imaging (**www.lightning** strikeimaging.com).

"It's just something new that I

haven't really done before," senior Adriana Riley said. "Learning how to carve into wood, making posters and stuff like that. I think that's pretty cool."

Teacher **Jim Bycznski** said he's teaching students how to create a product that has craftsmanship and a spreadsheet to track supplies and materials.

A provision in SB 39 seeks to affirm in law that e-schools must "provide" rather than "offer" 920 hours of learning opportunities to students in each academic year. For a student to count as a fulltime equivalency of 1.0, the percentage of learning opportunities provided by the e-school to that student must be equal to the amount of time that the student is actively engaged in learning opportunities. The Electronic Classroom of Tomorrow (ECOT) claimed in a lawsuit it filed against ODE that current law does not require e-schools to actively educate students if class materials are made available online.

SB 39 also seeks to elevate transparency in e-school operation. For example, certain school report card elements would be reported on promotional materials. Public meetings of the governing board would be streamed online as the meetings occurred. Sponsors would be required to report to ODE if the e-school fails to comply with the required International Association for K-12 Online Learning standards.

Additionally, the legislation clarifies other issues. It would limit contracts between school operators and the governing authority to a term of three years, and subsequent agreements would be required to reflect any applicable modifications made prior to renewal. Attendance requirements and rules would be strengthened by including them in the contracts between the sponsor and the e-school's governing authority.

SB 39 also includes a provision specifying that when the state auditor issues a finding for recovery from a charter school audit, that money would be returned to the school district from which it had been deducted.
