#### Sandy Hook Promise, ODE partnering on school safety training

Sandy Hook Promise (SHP) is partnering with the Ohio Department of Education (ODE) to train Ohio students, educators and school administrators to identify, assess, intervene and get help for those exhibiting at-risk behaviors. The training is being offered to all Ohio public schools through SHP's Safety Assessment and Intervention program, a nationwide project that trains a multidisciplinary team in each school. SHP is a national nonprofit led by several family members whose loved ones were killed in the 2012 mass shooting at Sandy Hook Elementary School. SHP hosted an informational booth at last month's School Security and Safety Solutions Summit in Columbus. The summit was organized by OSBA and 21 other groups. ## OSBA platform committee recommends nine resolutions

OSBA's Legislative Platform Committee met in August to review recommended changes to the association's Legislative Platform. Committee members approved nine platform amendments and modifications to present to the 2018 OSBA Delegate Assembly, where every member school district has a vote.

The OSBA Legislative Platform publicly states OSBA's positions on key state and federal education issues. It communicates to policymakers and the public where school board members across Ohio stand on public education issues and guides OSBA's advocacy efforts and sets its education agenda.

The platform addresses scores of topics in four sections: Students and learning, School governance, Finance and Personnel. The assembly approved OSBA's first Legislative Platform in 1996 to reflect legislative goals and beliefs

adopted by members in the past.

Committee Chair and OSBA President-elect **John W. Halkias**, **Plain Local (Stark)**, led the August meeting, which was attended by five OSBA Executive Committee members, 19 members of the Legislative Platform Committee and five association staff members.

The following resolutions were discussed, amended and approved by the committee. Language that is struck through was deleted; language in italics was added.

#### Resolution 2018-1

Submitted by **Xenia Community City**, this resolution adds language to the Discipline plank in the Students and learning section.

OSBA supports legislation that: ● *Prohibits the mandating of zero-tolerance policies and instead* enables discipline of students to be dealt with individually in a way that is appropriate for their age, gender, mental health condition, emotional development and special educational needs and appropriately protects the school's educational environment.

#### Resolution 2018-2

Submitted by OSBA staff and Northridge Local (Montgomery), this resolution adds a new plank in the Students and learning section.

## Student and school employee safety

Student and school employee safety is the paramount concern for school districts. Ensuring a safe learning and working environment is a shared responsibility among school board members, school employees and community members working in collaboration with lawmakers, law enforcement, mental health and

## OSBA MASTER OF TRANSPORTATION ADMINISTRATION (MTA) PROGRAM

This series of workshops will help those involved in student transportation better understand and perform day-to-day operations.

#### Nov. 28 or Dec. 6 — Transportation rules and regulations

Review the rules and regulations that govern pupil transportation in Ohio. Look at state law, administrative code and the role that local policy plays in a successful operation. This class is essential for new transportation administrators as well as any school administrators involved with transportation services. These are the standards to which you are held and for which liability can be assigned when your department fails to meet them.

#### Feb. 6 or 13 — Federal regulations, guidance and agencies

School transportation is not only governed by local rules, it is subject to a significant number of federal agencies, rules and regulations. We will look at the external impacts on transportation and review the federal alphabet soup, including FMCSA, NHTSA, NTSB, TSB and ODI, as well as landmark federal studies on school transportation.

#### March 6 or 13 — Laws, rules and policy — what, how and why

What is the difference between revised code, administrative code and department policy? Are they all mandates or just best practices? What happens when they conflict? Review the technical aspects of these various regulatory controls and the process through which ideas become rules or regulations. Learn how you can help influence the future.

#### April 3 or 10 — Hot topics — safety, trends and statistics

Review hot topics in student transportation, including seat belts in school buses. Learn about NTSB accident studies, Ohio school bus accident statistics and any topics that attendees bring from their local districts. While we look at these hot topics, an underlying focus also is on how to identify the learning points in each of these areas and share them with the staff that delivers our front-line transportation services.

## Reasonable Suspicion Training



OSBA is offering a reasonable suspicion drug and alcohol training program for supervisors. Best practice is that each district have at least two administrators trained in this requirement.

- Mandates any security measure to be implemented without the approval of the local school district board of education.

OSBA supports legislation that:

• *Provides for* the composition of the commission and review team

should to reflect the demographics (geographic, economic and social) of the school district.

#### Resolution 2018-4

Submitted by **North Olmsted City**, this resolution adds language to the Charter/community schools plank in the School governance section.

OSBA supports legislation that:

• Prohibits a charter/community school from any and all advertising if, and while, that school is being formally investigated by any governmental agency for possible misuse of taxpayer funds.

#### Resolution 2018-5

Submitted by Northridge Local,

this resolution adds new language to the Sale/lease of real property plank in the School governance section.

OSBA supports legislation that:

- Repeals the right of first refusal to purchase property to private, charter/community and online schools.
- Allows local school boards the flexibility to make facility sales and purchasing decisions based on the needs of their district.

# Crowdfunding best practices

Crowdfunding refers to online fundraisers that help teachers and schools solicit donations of money and supplies to enhance classrooms and enrich the education of their students. Crowdfunding can be tremendously beneficial but also can pose some risks. OSBA supports legislation that:

Reinstates funding for school bus purchases.

#### Resolution 2018-8

Submitted by OSBA staff, this resolution removes language from

the Personnel section.

Ohio enacted a comprehensive collective bargaining statute in April 1984. The enactment of the collective bargaining bill and a series of court cases, particularly in the area of teacher evaluation and nonrenewal, have made it difficult for locally elected boards of education to effectively manage schools. OSBA believes that changes and modifications to the Ohio Revised Code Chapter 4117 as well as Section 3319.11, 3319.111 and 3319.16 are necessary.

#### **Next steps**

These amendments and

modifications will be submitted to the OSBA Delegate Assembly for consideration on Nov. 12 during the OSBA Capital Conference. At least 75% of the assembly's voting delegates must approve any changes before they are incorporated into the Legislative Platform.
