#### Highland Local board members sacrificing pay to get community input

**Highland Local (Medina)** is seeking stakeholders' opinions, and the district's board members have pledged to ante up a year's pay to help fund the initiative. According to *The Medina Gazette*, school board members said they will donate the \$125 they earn for each meeting in 2011 to provide funding to conduct focus groups, an online survey and a phone poll of 500 registered voters in the district. The donation is expected to total about \$10,000. In the wake of three failed levies, the board wants the community's input before returning to the voters.

#### OSBA's first woman president passes away at 93

**Jean F. Dye**, the first woman elected as OSBA's president, died on Nov. 15. She was 93. Dye served as a **Cleveland Heights-University Heights City** board member for 16 years and was OSBA's president in 1970. She also served as Ohio PTA president and National PTA vice president. Among her many honors were a distinguished service award from the Ohio League of Women Voters and a Layman of the Year award from the Ohio Department of Elementary School Principals.

#### Entrepreneur cashing in on schools' cell phone ban

**Vernon Alcoser** has cornered the mobile market at two Bronx high schools, where students pay \$1 a day to keep their cell phones in the trucks he parks nearby.

Cell phones are banned in New York City schools. Offenders' phones are confiscated and will only be returned to their parents.

"I'd rather pay a dollar than take that risk," one student said.

Alcoser hit on the idea after a parent complained about the ban. To prevent theft, students are photographed with their phones every morning and use ticket stubs to retrieve them after school.

Alcoser is surprised by his success, but not employee **Jonathan Ortiz**, a recent graduate of one of the schools. "These kids can't live without their phones," Ortiz said.



## Reviewing election results and previewing the lame-duck session

Not only did the Republicans sweep all statewide offices and regain control of the Ohio House, they increased their majority in the Ohio Senate to have the largest edge in 47 years. Come January, single-party rule returns, as Republicans will control the governor's office, the House and the Senate. The lawmakers also will have to balance a biennial budget with an estimated \$8 billion shortfall.

## President Obama recognizes Solon City students at White House

**Solon City**'s Solon Middle School Science Olympiad teams were honored Oct. 18 at the White House by President **Obama** for winning a national championship. The team joined others from around the U.S. that were invited to Washington for the White House Science Fair.

Team co-captain **Ojas Sathe** and gold medal winner **Stephen Tang** met Obama and sat just to his right as he spoke in the East Room about the importance of investing in math and science education.

"We welcome championship sports teams to the White House to celebrate their victories," Obama said. "I thought we ought to do the same thing for the winners of science fair and robotic contests, and math competitions, because often we don't give these victories the attention that they deserve."

For Sathe, who competed on all three of Solon's championship teams, meeting and shaking hands with the president was "pretty incredible." Tang, who won three gold medals at the 2010 Science Olympiad National Championship, said that Obama took note of the number of medals he was wearing by saying, "Wow, you have quite a bit of hardware there, don't you?"

\* Even though the 129th Ohio General Assembly doesn't convene until Jan. 3, there already are vacancies to be filled. Gov.-elect **John Kasich** recently named Rep. **James Zehringer** (R-Fort Recovery) director of the Ohio Department of Agriculture and Sen. Steve Buehrer (R-Delta) administrator of the Bureau of Workers' Compensation. In addition, Sen. Tim Grendell (R-Chesterland), who was elected to the House, has decided not to move to the lower chamber, opting instead to serve out the final two years of his Senate term before

term limits kick in. The Senate also has two other spots to fill with Sen. **Bob Gibbs**' (R-Gabeville) departure for the U.S. Congress and Sen. **Jon Husted**'s (R-Kettering) election as Ohio secretary of state.

#### Lame-duck session

With both the House and governor's office set to change into Republican hands next year, the normally chaotic lame-duck session looks like it will be relatively quiet. Some fireworks could come from the Senate's decision to reject some of Gov. **Ted Strickland**'s pending appointments. Senate President **Bill Harris** (R-Ashland) believes Kasich

should get to appoint people in "key policy positions," but Harris has not specified which of the more than 200 appointments fall into that category. The only other substantive matters likely to be addressed include a human trafficking measure, an extension for the Sunset Review Committee and language to synchronize the state tax code with federal law changes.
