THE SEARCH

The River View Local School District Board of Education is seeking qualified applicants for the position of superintendent. The new superintendent will replace Mr. Kyle Kanuckel, who served the River View District for fourteen years.

In addition to providing leadership for all programs and operations, the board is seeking an individual who will serve as a model of professionalism, capable of articulating and achieving the district's educational mission and vision.

The River View Local School District Superintendent will be responsible to advise board members on administrative matters; execute policies and decisions made by the board; and operate the district efficiently and effectively. Treasurer Lee Williamson, other key staff and administrators, and a committed board of education support the superintendent.

ABOUT THE DISTRICT

The River View District was organized in 1962. It encompasses 376 square miles. The district surrounds the city of Coshocton and is located approximately 70 miles east of Columbus, 47 miles east of Newark, and 35 miles northeast of Zanesville.

The district is composed of nearly 2200 students in six buildings: River View High School and River View Junior High School are two separate buildings in a campus atmosphere near the village of Warsaw; and four elementary schools; Conesville Elementary, Keene Elementary, Union Elementary, and Warsaw Elementary are in surrounding communities.

Areas of Pride:

River View Local School District has earned an "Excellent" rating from the Ohio Department of Education for five of the past six school years. In addition we have had steady improvement in the Student Performance Index with a 101.3 rating for 2010-2011.

In the spring the district celebrates student achievement and talents with the Black Bear Fest, which is held at the high school campus. Performing groups, student projects and individual work is on display from each school in the district. Community members and parents enjoy food, games, and the opportunity to appreciate the hard work of teachers and students.

Black Bear Pride is alive and well. In addition to a rich athletic tradition, the arts flourish as well. Our annual spring musical has a history of involving a great number of students in excellent productions.

The River View Local School District is proud of the sound leadership and professional staff that works daily to serve our students and parents. During the 50 year history of the district there have only been three superintendents, and the Board of Education has a combined 72 years of experience.

ABOUT THE COMMUNITY

River View Local School District is in Coshocton County. This area of the state of Ohio is made up of rolling wooded hills and boasts of beautiful scenery. The area is rich in history which is made evident by Roscoe Village, a restored 1800s canal town, which was once a bustling center of commerce on the Ohio/Erie Canal. The historic village offers the Johnson-Humrickhouse Museum, shops and restaurants which attract many visitors to the area. The village hosts events and festivals throughout the year, which involve the Coshocton residents and bring people into the area.

The Lake Park Recreational Complex offers the community an aquatic center, walking and biking trails, and campsites. Close by are golf courses, wineries, and public hunting and fishing areas.

Muskingum University, Central Ohio Technical College, Kent State University, and Ohio State University regional campuses are in easy driving distance of River View Local Schools.

Agriculture is of major importance in our area and the district's FFA program is strongly supported by the Walhonding Valley Farmers Association.
