

# Hiring a Coach / Permit Requirements

\*\*\*Districts must verify all training for coaching permits\*\*\*

#### Permit Terms

- 3-yr permit: For those who hold no other educator credential or an educator credential not listed below.
- 4-yr permit: For those holding a 4-yr resident educator license or a 4-yr alternative resident educator license.
- 5-yr permit: For those who hold a 5-yr professional license, a 5-yr senior professional license, or a 5-yr lead professional license.

# Hiring Process

- The first step is for applicants to complete the hiring process to coach. An applicant must notify the district that he or she is submitting a permit application request. The superintendent or a credentialed e-signer will need to e-sign the applications.
- Background check each applicant must have an up-to-date background check on file.

# District E-Signer Guidance: Verifying Training for Coaching (Pupil Activity) Permits

There are four required trainings for those who hold coaching (pupil activity) permits: fundamentals of coaching; cardiopulmonary resuscitation (CPR) training; first aid for coaches; and concussion training.

Districts are responsible for verifying that permit holders – and those who apply for permits through the online CORE system – have valid trainings and certifications. With each CORE application, the esigner's electronic signature signifies official district verification of the applicant meeting the requirements.

Districts must decide how they want to verify that trainings are valid. The Ohio Department of Education encourages districts to have applicants or coaches provide verification to the district that these trainings are completed and are current. Except for fundamentals of coaching, which is a one-time requirement, the expiration dates for the other trainings vary. Please note, some trainings will expire before the expiration of the coaching permit. In addition to verifying the trainings through documentation provided by the coach, some trainings provide an online resource to verify completion. Where available, this information is included below.

### I. FUNDAMENTALS OF COACHING

# II. CARDIOPULMONARY RESUSCITATION (CPR) TRAINING

# III. FIRST AID FOR COACHES – Applicants can fulfill this requirement through one of four options.

- Courses must be completed within the past three years and be related to first aid or athletic training.
- Training cannot be verified online.

#### D. Medical license

- The licenses M.D., D.O., D.C., R.N., EMT and A.T.C. fulfill the first aid training requirements.
