#### Pilot program offers school districts federal funding flexibility

The federal government is offering new flexibility for school districts to create equitable, student-centered funding systems under a pilot program authorized by the Every Student Succeeds Act. The flexibility will allow up to 50 districts to combine eligible federal funds with state and local funds to allocate resources to schools based on the number of students and the level of need. Districts must design and implement a student-centered funding system meeting all the program's requirements, including the use of weights that allocate substantially more funds to students from low-income families, English learners and other educationally disadvantaged groups identified by the district. 

#### OSBA members lobby congressional reps on Capitol Hill

Local school board members from across the U.S. recently headed home from Washington, D.C., after participating in the National School Boards Association (NSBA) Advocacy Institute, held Feb. 4 through Feb. 6.

The OSBA delegation consisted of the association's Federal Relations Network (FRN) and several OSBA staff members. FRN is composed of two local school board members appointed by OSBA in each congressional district to lobby their members of Congress on federal education issues. The focus of the Advocacy Institute and Ohio's FRN centers on building year-round advocacy for public education and local school board governance in the public, legal and legislative arenas.

This year, 28 members of Ohio's FRN joined more than 700 local school board members from other states to participate in the Advocacy Institute. With the 115th Congress beginning its second session, the institute presented a great opportunity for FRN members to be brought up to

speed on federal legislative priorities and understand the impact proposed legislation may have on local school districts. On the last day of the conference, local school board members led a national grassroots legislative effort on Capitol Hill to urge members of Congress to make public education a top priority.

During the institute, members heard from congressional leaders, including Sen. John Boozman (R-Ark.); Sen. Deb Fischer (R-Neb.); and Rep. Terri A. Sewell (D-Ala.); and the chief of staff for Senate Health, Education, Labor and Pensions Committee Chairman Lamar Alexander (R-Tenn.). In addition, members heard from NSBA's legislative experts and keynote speaker Cokie Roberts, political commentator for NPR and ABC News.

On the last day of the conference, OSBA FRN members met with their House of Representatives members and their staffs. They also met with Ohio's senators, Rob Portman and Sherrod Brown. The purpose of

the meetings was to discuss key legislative priorities and the local impact they will have on their students and schools.

Specifically, FRN members called on Congress to:

• ensure adequate funding for education programs, including full funding for the Individuals with Disabilities Education Act and Title I;

• provide greater support for the innovative programs and educational choices offered by Ohio's public schools, which educate 1.7 million students each day;

• pass a bipartisan reauthorization of the Carl D. Perkins Career and Technical Education Act, including provisions for a strong academic component and credentialing program to help districts advance 21st century skills and knowledge to meet the needs of students and employers;

 reauthorize the Higher Education Act to strengthen teacher and principal preparation programs and retain the Public *Continued on page 6*  News, continued from page 5 -

Service Loan Forgiveness Program, an important tool used to recruit effective educators into the field;
act swiftly to amend the Illegal Immigration Reform and Immigrant Responsibility Act of 1996 and restore the pathway to

U.S. citizenship for qualified undocumented students previously protected by the Deferred Action for Childhood Arrivals program.

As we proceed through the year, FRN members will continue

#### Proposal would diminish State Board of Education's authority

Rep. **Bill Reineke** (R-Tiffin) recently introduced House Bill (HB) 512, legislation that would consolidate the Ohio Department of Education (ODE), the Ohio Department of Higher Education and the Governor's Office of Workforce Transformation into a new cabinet-level agency called the Ohio Department of Learning and Achievement.

According to Reineke, the legislation is aimed at better aligning Ohio's public education system with the state's workforce needs and making the state more accountable for achieving results. It also is intended to centralize Ohio's education and workforce policymaking while responding to the changing job market.

At a Feb. 14 press conference unveiling the bill, Reineke said, "Education is one of the state's most important tasks and this legislation aligns our education systems to better prepare our workforce for the needs of today and tomorrow. I look forward to discussing this bill further with the education and workforce community with the goal of working together to ensure that Ohio's students are ready and prepared for the future."

The press conference also was attended by House Speaker **Cliff Rosenberger** (R-Clarksville), who emphasized that the legislation would be a major priority for House Republicans throughout the remainder of the year, in addition to HB 508. HB 508 would create a pilot program at Ohio colleges and universities supporting student mentors for at-risk youth threatened by the opioid epidemic.

Under HB 512, the governor, with the consent of the Senate, would appoint the director of the Ohio Department of Learning and Achievement. The director would have the authority to appoint deputy directors where deemed appropriate to streamline prekindergarten through 12th-grade education through workforce policy development and implementation.

The legislation makes no changes to State Board of Education membership but, according to Reineke, brings its duties more in line with other state boards and commissions and keeps its functions consistent with the Ohio Constitution. That would include primarily quasi-judicial responsibilities such as regulating teacher licensure and educator misconduct. The board also would continue to appoint a state superintendent.

The State Board of Education, state superintendent and ODE staff would maintain the authority to perform the following tasks:

• revoke a district and/or school charter;

• issue educator licenses;

• establish payments in lieu of transportation determinations;

• make territory transfer determinations;

• supervise and administer Ohio Revised Code Administrative Procedural Act Chapter 119 dealing with community schools and sponsors and administer other Chapter 119 proceedings;

• determine the permanent exclusion of students;

• sponsor community schools in accordance with state law;

• oversee the state schools for the deaf and blind.

Following the bill's introduction, OSBA, the Buckeye Association of School Administrators and the awards from the Alliance for Young Artists & Writers, a nonprofit organization whose mission is to identify students with exceptional artistic and literary talent and present their work through the Scholastic Art & Writing Awards.

The six-part series of books, known as "The Disappearing Series," focuses on a young boy who finds out he's part of an ancient group of sorcerers. Horvat's family remembers when he found out in a phone call that his first book, "The Vortex Entrance," would be published.

"We had it on speaker and she said it, and he just put his hands up and he was just like, 'Oh my God, oh my,' and he was pacing back and forth, and it was just a great moment," his mother, **Sherri**, said.

Ohio Association of School Business Officials expressed several initial concerns with the proposal.

"HB 512 would undermine the role and authority of the elected members of the State Board of Education," OSBA Executive Director Richard Lewis said. "By stripping it of all but its regulatory role, the board would no longer be acting in any significant way on behalf of the citizens the members represent. At the core of our existence is the notion that education in Ohio will be at its best when the interests of the people are served through publicly elected boards. The State Board of Education is no exception.

"The proposal would move decisions about important topics, such as setting the state's learning standards, graduation requirements for students and school district report cards, to a politically appointed staff as opposed to the current process that includes many opportunities for public input. An additional source for concern about the House proposal is the uncertainty it could mean for school districts when administrations change."

Once the legislation is referred to a committee, hearings are expected to begin immediately.
