Federal aid for school lunches at an all-time high in Ohio

New data from the Ohio Department of Education show the proportion of students getting free and reduced-price school lunches through a federal program has reached a record high. The proportion of students who get the tax-funded benefit has risen nearly 50% in the past five years, and four of every 10 Ohio students are now part of the lunch program for low-income children, according to *The Columbus Dispatch*.

ODE encouraging school districts to sponsor summer food programs

The Ohio Department of Education is seeking school districts and other nonprofits to sponsor Summer Food Service Program (SFSP) sites. The federal program offers nutritious meals to low-income children during summer vacation and provides sponsoring agencies with cash reimbursements. 
OSBA consultant chosen to lead national organization





*BWC requires any public employer who is either group experience rated or group retrospective rated to complete a two-hour training if they had a claim, medical only or loss time, in either 2009 or 2010. This requirement must be satisfied during calendar year 2011. If a district is "penalty-rated" and not, by BWC rules, eligible for a group program, they do not have this requirement, but can attend for the purposes of safety education.


Facing an estimated \$8 billion shortfall in the next state budget, Gov. John Kasich and the General Assembly are looking at a number of changes that could have a significant impact on Ohio public education. Among those is a cut in state funding to schools as high as 20%.

It is estimated to take at least two years of school board service to learn what it takes to be an effective school board member. The challenge is not only for new board members — it's ongoing.

Whether you're a rookie or a veteran, the

Twenty points will be awarded for attendance at the institute, which may be applied toward receiving OSBA's Award of Achievement and Master Board Member award.



LEGISLATIVE REPORT

Statehouse legislative action kicks into overdrive

Capitol Square was the scene of fast-paced activity the week of Feb. 14 as the Statehouse filled with proponents and opponents of legislation affecting public education. The House passed and sent to the Senate a bill that would eliminate a number of components of the Ohio Evidence Based Model (OEBM) for education. Meanwhile, a Senate committee heard hours of testimony on proposed changes to Ohio's collective bargaining law for public employees. Following are updates on these two pieces of legislation.

House passes Sub. HB 30

The Ohio House of
Representatives passed Substitute
House Bill (Sub. HB) 30 on Feb. 16
by a vote of 59-36. The legislation,
sponsored by Rep. Randy Gardner
(R-Bowling Green), would
eliminate spending and reporting
requirements for most of the
components of OEBM. OSBA was
successful in working with
Gardner to make several changes
to the bill from its "as-introduced"
version.

Following are provisions from Sub. HB 30 as passed by the House:

• Eliminates the all-day kindergarten requirement.

- Allows school districts to continue to charge tuition for all-day kindergarten (on a sliding scale, based on wealth).
- Eliminates spending and reporting requirements related to the components of OEBM, except for gifted education funding.
- Delays implementation of gifted education spending rules for two years, until July 1, 2013.
- Eliminates the set-aside requirements for textbooks and instructional materials.
- Eliminates the Ohio School Funding Advisory Council.
- Retains the current requirement for a five-year financial forecast.

Thanks to everyone who contacted legislators about Sub. HB 30! We believe there were several improvements to the bill because of your input. While we still have concerns about the eventual implementation of the spending rules for gifted education funding, the two-year suspension allows us time to work with representatives from the gifted education community to find a more suitable resolution.

The bill now moves to the Senate for further deliberation. We will continue to monitor the bill and keep you updated.

Collective bargaining reform

Senate Bill (SB) 5, sponsored by Sen. **Shannon Jones** (R-Springboro), would make sweeping changes to Ohio's collective bargaining law for public employees. Some of the bill's provisions include:

- Requires public employers to publish a report on their websites describing provisions of a collective bargaining agreement (CBA) affecting compensation of any kind.
- Requires public employers and the State Employment Relations Board to publish negotiating parties' contract offers on their websites before and after factfinding is complete.
- Requires mediators to consider compensation paid to employees who are not members of the bargaining unit, or who are members of the bargaining unit but not of the "exclusive representative."
- Requires parties to consider the financial status of the public employer during negotiations ("the ability to pay"), not the possibility of future increases from the passage of levies or bond issues.
- Makes state employee compensation merit-based,

eliminating salary schedules and "step" increases.

- Existing CBAs would continue until they expire according to contractual terms.
- Does not eliminate collective bargaining for local governments, but makes significant "reforms."
- Allows a public employer in fiscal emergency to terminate, modify or negotiate a CBA.
- Allows a public employer to hire permanent replacement workers during a strike.
- Specifies that only matters

related to wages, hours or terms and conditions of employment are mandatory subjects of bargaining, eliminating the cumulative "floor" of future bargaining.

- Extends some bargaining deadlines so that they are more "realistic" and defines "impasse" as "a failure to achieve agreement in the course of good-faith bargaining for 90 days."
- Specifies that length of service cannot be the only factor in determining the order of layoffs,

and adds efficiency, appointment type, relative quality of performance (teachers only) and "other similar factors" as further considerations.

- Bars a public employer from covering an employee's required pension contributions.
- Further bars "pickups on the pickup," wherein school districts cover employee pension contributions and then treat the contributions as additional salary for pension purposes.
- Eliminates the terms and design of health care plans from collective bargaining, producing "uniform benefit packages" for all employees.
- Requires employees

to pay at least 20% of their health care premiums.

- Eliminates future continuing teacher contracts after any effective date of the bill.
- Abolishes the School Employees Health Care Board and instead permits boards of education to govern their employees' health care benefits.

Some provisions in SB 5 will affect non-union school employees, such as the prohibition of "employer-paid" employee share of retirement, the elimination of the required 15 minimum days for sick leave and the requirement that employees pay a minimum of 20% of employee health care premiums. We are working to get clarification as to whether the legislative intent was to affect those outside the bargaining unit with these provisions.

OSBA and the Ohio Association of School Business Officials recently provided joint proponent testimony on SB 5. We used the feedback we received from members following our survey in December on the collective bargaining issue to determine our position on the components of the bill. Two Ohio youth volunteers earn national recognition

A fifth-grader and a high school senior have been named Ohio's top two youth volunteers and honored with the 2011 Prudential Spirit of Community Award. Ohio's winners are Mariah Faith Reynolds, 12, from Cincinnati City's School for Creative & Performing Arts, and Joseph Melenick, 17, from Bay Village City's Bay High School.

They and 100 other volunteers from across the U.S. will travel to the nation's capital in May for

recognition events and tours. All 102 winners will be in the running to be named one of the top 10 youth volunteers in the U.S.

Prudential Financial and the National Association of Secondary School Principals sponsor the program, which recognizes the top two youth volunteers from each state and Washington, D.C., for exemplary community service. OSBA is committed to working with the General Assembly, as well as the associations representing teaching and non-

teaching employees, as the bill works its way through the legislative process. It is our understanding that drafting errors have been detected during this early part of the deliberations. OSBA will offer suggestions for improvements to the legislation on behalf of our members as we become more informed about the actual intent and interpretation of all the provisions in the bill.

Gov. **John Kasich** has publicly stated that he is watching SB 5 as it progresses. The governor has indicated that he respects the legislative process, but if there are provisions he believes to be necessary that are not included in SB 5, he will include those

provisions in his budget proposal. It appears that the Senate would like to move the bill quickly.

Again, as we continue to get more information about the proposal and any changes that are made along the way, we will keep you informed. In the meantime, there will be more opportunities for members to testify. The bill is currently being heard in the Senate Insurance, Commerce and Labor Committee.
