DR. NORMAN JONES SPRING CONFERENCE KEYNOTE SPEAKER

We are delighted to welcome Dr. **Norman Jones**, dean and director of the Ohio State University at Mansfield, as our spring conference keynote speaker.

Jones earned a bachelor's degree in humanities from Yale University, and a master's degree and doctorate in English from the University of California at Los Angeles. He joined Ohio State's faculty in 2004 and has taught undergraduate and graduate-level courses on American literature, the Bible and film.

He is the author of several books and essays that explore intersections between the Bible and literature. The Mansfield campus has recognized his contributions with its Award for Excellence in Scholarship and its Award for Excellence in Service.

Recently, Jones announced a partnership between Ohio State Mansfield and Mansfield City Schools that promises to make a big impact for African American students in the Mansfield City School District. The organizations

are collaborating to create a pipeline for African American students to earn a Bachelor's degree with licensure in Education through Ohio State.



WILSON TO BE TAPPED NSBA PRESIDENT

Central Region's **Charlie Wilson** will be tapped as National School Boards Association (NSBA) president in April of this year. Wilson is an emeritus professor at The Ohio State University Moritz College of Law where he teaches Education Law, Education Policy, School Funding Law, Comparative International Education Policy & Law, Labor Law, and Civil Procedure. Charlie is a 33-year resident of the Worthington school district and has been a Worthington school board member for 12 years. He also serves on the McConnell Arts Center's board of trustees.

Wilson's term as president will be the highest NSBA office achieved by an Ohio school board member. He will become NSBA president on April 3rd in Chicago during the NSBA Annual Conference & Exposition. Wilson was elected as a Central Region representative to NSBA's Board of Directors in 2014 and has held several other NSBA posts. He was OSBA's president in 2013 and has served on the OSBA Board of Trustees, Executive Committee and numerous other regional and state committees.

He has been on the Worthington City Board of Education since 2007.

Charlie has been awarded OSBA's and NSBA's Master Board Member Awards and NSBA's Distinguished Service Award for Extraordinary Commitment to America's Children.

Wilson's goals for his

presidency include increasing our voice in Washington for 50 million public school children, continuing the Equity Initiative by reviewing all NSBA policies, resolutions and practices to ensure that they do not hinder or obstruct the promotion of equity, ensuring a student-centered focus and finding ways that will better engage the 90,000 locally elected school board members in NSBA's advocacy.

TOM ASH CHAMPION OF PUBLIC EDUCATION

2016 marked the creation of Central Region's Champion of Public Education Award. The Central Region Executive Committee established the award to recognize public servants who have a demonstrated career history of supporting and advocating for public education.

Tom Ash, was awarded the 2019 Central Region Champion of Public Education.

Thomas P. "Tom" Ash retired Sept. 30th from the Buckeye Association of School Administrators as Director of Governmental Relations after 14 years of serving in that post. In this governmental relations' role, he represented public school district leaders throughout Ohio, before the Ohio General Assembly and various state organizations and provided technical assistance to BASA members.

Ash and BASA have been strong partners with the Ohio School Boards Association and its members over the years coordinating lobbying initiatives, fostering collaboration among superintendents and treasurers and unifying the voice of the public school management team.

Prior to joining the BASA staff, Tom devoted 35 years to public education, with 21 of those as a superintendent at East Liverpool City Schools and Mid-Ohio Educational Service Center and he served as the 30th president of BASA during the 1999-2000 school year.

He earned a sterling reputation as a recognized authority on school finance, special education and facilities. He has traveled the state as a speaker and presenter and came to be known as one of Ohio's most influential voices for public education.

Ash was named the 2016-2017 Hicks Executive in Residence at the Patton College of Education at Ohio University, an award bestowed by the university and the Coalition of Rural and Appalachian Schools that honors outstanding educational leaders.

The OSBA Central Region extends our deepest gratitude to Tom for his dedication, service and devotion to Ohio's public schools and the students they serve.

CHANGE IN RECOGNIZING OUTSTANDING SCHOOLS

In November of last year, the Central Region Executive Committee determined it will no longer recognize a school or district's overall grade rating for a regional award. Considering our long standing issues with the current report card and the inaccurate story it tells about our districts and our work, we decided the "Overall A" recognition was not aligned with the region's values.

Member feedback suggested this action and recommended honoring Schools of Promise, Schools of Honor, Momentum and Blue Ribbon Schools. While the measures used to determine these designations are part of the Local Report Card, the mark is achieved because of substantial progress in high achievement for all students and closing the achievement gap. The Executive Committee concluded progress, not grade attainment, would determine the Outstanding School Award.

SEVEN KEY BOARD ACTIONS FOR IMPROVED STUDENT ACHIEVEMENT

Research conducted in Montana in 2013 (Ivan J. Lorentzen and William P. McCaw)

The Montana study found that items within the categories of responsible governance, high student achievement expectations, creation of conditions for student and staff success, district accountability and community engagement were related with high student achievement at a statistically significant level. If a school board wants to begin the journey to high student achievement, the following actions are imperative. Effective boards:

- hold the school district accountable for meeting student learning expectations by evaluating the superintendent on clear and focused expectations.
- set and communicate goals and plans for meeting those expectations.

- hold the school district accountable for meeting student learning expectations by committing to a continuous improvement plan regarding student achievement.
- 4. provide responsible school district governance by conducting board and district business in a fair, respectful, and responsible manner.
- engage the local community and represent the values and expectations the community holds for its schools.
- model responsible school district governance by working as an effective and collaborative team.
- 7. require the board to create districtwide conditions for student and staff success
