General Assembly passes state budget

The Ohio Legislature has put its final touches on the \$55.8 billion biennial budget bill, House Bill (HB) 153. The House voted 59-40 along party lines, while the Senate voted 22-11 to approve the final conference committee report. Sen. **Scott Oelslager** (R-Canton) was the only Republican joining Senate Democrats in opposition to the bill.

Some of the final educationrelated differences between the House and Senate versions that had to be worked out by the conference committee were issues related to the expansion of school choice and merit pay/teacher evaluations. The final result meant compromises in both areas.

Some of the final merit pay/ teacher evaluation provisions include:

• Requires the State Board of Education to develop a "standards-based" framework for evaluating teachers and principals by Dec. 31, 2011.

• Requires districts to adopt a teacher evaluation policy that conforms to the framework by July 1, 2013; the policy takes effect after current bargaining contracts expire.

• Criteria must be developed for these evaluation categories: "accomplished," "proficient," "developing" and "ineffective."

• Requires the framework for evaluations to:

◆ use multiple factors, including student academic growth as 50% of each evaluation;

be aligned with the Educator
 Standards Board's standards for
 teachers;

 require classroom walkthroughs and teacher observations on at least two occasions for 30 minutes each;

 require the teacher to be provided with a written report of the evaluation results;

implement a classroom-level,

value-added program;

• provide for professional development to accelerate teacher growth and provide for the allocation of financial resources to support it.

• Requires districts to evaluate each teacher annually, except that teachers rated "accomplished" may be evaluated every two years.

• Prohibits using seniority for reductions in force or rehiring, except when evaluations are comparable.

• School districts receiving federal Race to the Top (RttT) funds must use pay-for-performance criteria under a schedule based on license and evaluations.

• School districts *not* receiving RttT funds must use either a performance-based salary schedule or current law.

school choice through charter schools, the EdChoice Voucher program and the new Jon Peterson Special Education Scholarship (Voucher) Program. It's important that schools and members of their local communities understand that the district-by-district funding spreadsheets that have been circulating throughout the budget process do not take into consideration or reflect the additional reductions in funding to school districts as a result of the expansion of these types of program.

As for overall funding, the final bill retains about the same level of funding for education as proposed by the governor, with the exception of approximately \$200 million added through the changes made by the House and Senate. On the whole, reductions in state and federal aid, Tangible Personal Property (TPP) tax replacement payments, and Federal Title I and Individuals with Disabilities Education Act funding mean approximately \$2.9 billion less for schools over the biennium as compared to fiscal year 2011 levels. Many school districts will lose all TPP tax replacement payments in this biennium.

Some of the other changes included in the final version of the budget affecting education include: • Health care pooling option for local government employees' coverage — optional, self-insurance and other pools could still exist as long as they meet best practices and benchmarks. This provision includes the elimination of the School Employees Health Care Board.

• Principals or other employees also can serve as a school district's gifted education coordinator, if qualified.

• Removes the provision allowing home-schooled students to participate in extracurricular activities.

• Directs the Ohio Department of Education (ODE) to develop a plan and legislative recommendations for allowing students over age 22 to be enrolled tuition-free in school district and charter school dropout recovery and prevention programs.

• Removes the provision prohibiting the selling of services to a charter school by a sponsor.

• Reinstates the moratorium on new e-schools until 2013, then allows up to five new schools each year thereafter.

• Allows charter schools that do not have a sponsor to apply to ODE for approval to operate.

It is important to note that one provision not included in the legislature's final version of the bill was the governor's proposal for a 2% swap in employer and employee retirement contribution rates.

OSBA, along with the Buckeye Association of School Administrators (BASA) and the Ohio Association of School Business Officials (OASBO) sent a joint letter to the governor asking him to line-item veto the following provisions not included in his original proposal:

• Jon Peterson Special Education

Scholarship (Voucher) Program.

• The provision directing ODE to develop a plan for allowing students over the age of 22 to attend district and charter dropout/recovery programs tuition-free.

• The provision that would allow charter schools without sponsors to apply to ODE for approval to operate.

Fort Frye kids give disabled classmate gift that keeps on giving

A Fort Frye Local (Washington) student recently celebrated a new way of getting around school, thanks to the efforts of his classmates.

Fort Frye High School freshman **Patrick Arnold-McKinney**, who has cerebral palsy, was presented with a new battery-powered mobility scooter right before the end of the school year. The school's Cadets for Care club raised the \$1,300 needed to buy the scooter with bake sales and raffles, and by soliciting donations from local businesses.

Prior to receiving the scooter, Arnold-McKinney walked with braces or used a wheelchair.

"I wear braces, but I still don't do well over long distances," the teen told a local newspaper. "I can walk OK on a good day, but this is going to change my life at school — and everywhere else."

"We wanted to help someone ... and although there were so many kids in the district we wanted to help, we made a unanimous decision to help Patrick," junior **Justin Moody** told the paper. Moody is president of Cadets for Care.

Arnold-McKinney said the scooter will be a big help when he goes to summer Boy Scout camp. He currently is working on his Eagle Scout project, which includes building a handicapped-accessible swing for children at a park along the Muskingum River in Lowell. Source: *Marietta Times*
