## DeMaria returns to ODE as Ohio's 38th state superintendent

**Paolo DeMaria** assumed the helm at the Ohio Department of Education (ODE) as state superintendent of public instruction June 27. "It's an exciting time for education in Ohio, and I look forward to engaging with our families, teachers, administrators, policymakers and advocates to help guide our work at the department," DeMaria said in a press release. The well-respected education policy expert comes to ODE from Education First Consulting. He also served as Ohio Board of Regents executive vice chancellor, an ODE associate superintendent, budget director for Gov. **George V. Voinovich** and chief policy adviser for Gov. **Bob Taft**.

## Report: Ohio children's well-being drops; nearly 1 in 4 live in poverty

Ohio's child well-being ranking has slipped to 26, falling to the bottom half of the states for the first time since 2012, according to the Annie E. Casey Foundation's 2016 Kids Count Data Book. The book rates well-being in four areas: economic, education, health, and family and community. It showed Ohio's child poverty rate at 23%, a figure that has changed little for several years. Thirty-one percent of Ohio kids live in families lacking secure employment and 14% live in high-poverty areas. ## Doctors' group backs later school start times to allow teens more sleep

The American Medical Association has adopted a policy to encourage later school start times to allow students to get sufficient sleep. The policy specifically calls on school districts across the U.S. to implement middle and high school start times no earlier than 8:30 a.m. The policy also encourages physicians to educate parents, school administrators, teachers and others about the importance of sleep for adolescent mental and physical health based on their proven biological needs.

## Special group registration rate returns for 2016 OSBA Capital Conference

A special Capital Conference group rate for school districts means that the more people a district sends to Columbus, the lower the per-person cost. When more than six people from a member school district register, the cost is a flat fee of \$1,850 for an *unlimited* number of registrants. The individual registration rate is \$295. Public Charter Schools, National Association of Charter School Authorizers and the 50-State Campaign for Achievement Now. Part of the study focuses on Ohio - along with California and Pennsylvania — as one of the "big three" for full-time virtual charter school enrollment. It said these states enroll more than half of the nation's full-time virtual charter students. The report noted Ohio has particularly high limits on the number and size of online schools and cited the Electronic Classroom of Tomorrow, with more than 15,000 students, and Ohio Virtual Academy, with nearly 11,000 students, as examples. 



## OSBA lobbies congressional reps during D.C. conference

OSBA's Federal Relations
Network (FRN) members recently
traveled to Washington, D.C., to
take part in the National School
Boards Association's (NSBA)
Advocacy Institute, held June 12
through June 14. Originally
scheduled in January, the institute
had to be postponed until June
due to a blizzard that hit the
capital.


FRN is composed of local school board members appointed by OSBA to lobby their members of Congress on federal education issues. The focus of the Advocacy Institute and Ohio's FRN centers on building year-round advocacy for public education and local school board governance in the public, legal and legislative arenas.

Twenty-four Ohio FRN members, accompanied by several OSBA staff members, joined more than 600 other school board members from across the country to participate in the institute. The event culminated with NSBA's Day on Capitol Hill, when FRN members met with congressional representatives to discuss key federal legislative issues. These legislative priorities included: The Every Student Succeeds Act (ESSA) implementation, Child Nutrition Act reauthorization, Carl

D. Perkins Career and Technical Education Act reauthorization and federal investments in education.

FRN members heard from a variety of speakers at the institute, including NSBA leaders and the

association's legal, legislative and public advocacy experts; political strategists; and key members of Congress. Speakers offered a range of insights, providing attendees a *Continued on page 6*

keener understanding of the issues, political atmosphere and most effective ways to advocate for America's schoolchildren. Keynote speakers included U.S. Secretary of Education Dr. John B. King Jr.; Sen. Lamar Alexander (R-Tenn.);

Rep. **Todd Rokita** (R-Ind.); CNN Senior Analyst **Jeffrey Toobin**; and Dr. **Larry Sabato**, director of the University of Virginia Center for Politics.

OSBA members attended a breakfast meeting with Sens. **Rob** 

Portman (R-Ohio) and Sherrod Brown (D-Ohio) and lobbied other Ohio members of Congress to ensure that ESSA implementation efforts secure balanced local-statefederal partnerships; maximize the flexibility provisions of the law; and support school districts with technical assistance and compliance resources.

Members also urged Congress to ensure ESSA is implemented in a manner that recognizes the law's clear directive to restore local governance and community ownership in public education and provide an opportunity for local school board members to provide input on nonregulatory guidance and proposed regulations. The U.S. Department of Education is in the process of designing regulations to implement the law.

On the Child Nutrition Act reauthorization, FRN members urged Congress to grant flexibility and relief for school districts to successfully administer school meal programs. This includes increasing flexibility for school districts in addressing whole grain content and sodium reduction targets. Members also lobbied to include the school board perspective in policy and implementation by the U.S. Department of Agriculture.

In discussing the Carl D.
Perkins Career and Technical
Education Act reauthorization,
FRN members lobbied for
Congress to provide the necessary

## Buses turned lunchrooms deliver food to students in need

When the school bus arrives at Christina Staples' apartment complex in West Chester, her three children know it's lunchtime.

For the first time, Lakota Local (Butler) is experimenting with a summer mobile lunch program for children already eligible under the district's free and reduced-price lunch program during the school year.

"It helps out financially, and I know they have someplace to eat lunch each day," Staples, a single

mother, told a local newspaper. "It's very nutritional for them, and it gives me more study time."

Of Lakota Local's 16,500 students, more than 3,500 families qualify for the subsidized program through the U.S. Department of Agriculture.

Lakota Local estimates it will serve more than 200,000 meals during the summer. The modified buses make seven stops.

"We have a variety of food choices for them, and it's going well," **Kelly Crumb**, the district's assistant director of child nutrition, said.

In many low-income families, both parents or a single parent work and may not be around to provide lunch, according to those who oversee the program.

Lakota Local has seen a nearly 30% increase in the number of students participating in the free and reduced lunch program since the 2008-09 school year.

support to school districts to ensure all students have access to high-quality career and technical education programs with strong academic components and credentialing.

OSBA believes education funding should be the highest federal priority to ensure students have the opportunity to meet today's challenges and promote excellence in public education. In supporting that, FRN members urged Congress to appropriate federal investments in education that will improve equity in educational opportunity; maximize the federal share of special education aid to help districts and states address the

cost of educating children under the requirements of the Individuals with Disabilities Education Act without displacing resources from other education priorities; and ensure the requirements of the Elementary and Secondary Education Act are fully funded, as authorized in ESSA.

In addition to the Advocacy Institute, NSBA sponsored an Equity Symposium June 10. The symposium provided a forum for school board members to examine and discuss strategies, current trends, research and best practices that are improving educational outcomes for academically and economically disadvantaged students in traditional public schools. Discussions at the symposium helped school board members increase their knowledge and skills around issues of access, equity and diversity in public education.

FRN members will continue advocating throughout the year for public education in Ohio and working with their members of Congress to achieve that goal. For more information on federal advocacy, please contact OSBA's Division of Legislative Services.
