Education community mourns loss of former OSBA leader John Brandt

Retired OSBA Executive Director **John M. Brandt** died June 12. He was 65. Brandt, the association's fifth executive director, led OSBA from 1994 until his 2006 retirement. He was known throughout his career — and especially around the Statehouse — for his unwavering advocacy for Ohio's public school boards and the children they serve. Starting at OSBA in 1976 as the association's first labor relations negotiator, he went on to serve as labor relations director, chief lobbyist, legislative director and deputy executive director. Brandt also represented OSBA on scores of statewide and national committees and spoke at numerous education events across Ohio and the nation.

Powerful public education advocate Ravitch set for Capital Conference

Renowned public schools advocate **Diane Ravitch** will address the second General Session at the 2012 OSBA Capital Conference. A former U.S. assistant secretary of education, Ravitch was once a strong supporter of the No Child Left Behind Act. But, after seeing NCLB's true impact, she now speaks out against standardized testing, charter schools and vouchers. Also an author, the New York University professor's most recent book is *The Death and Life of the Great American School System: How Testing and Choice Are Undermining Education*. 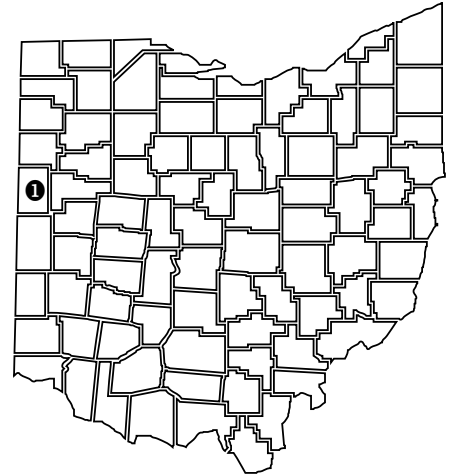

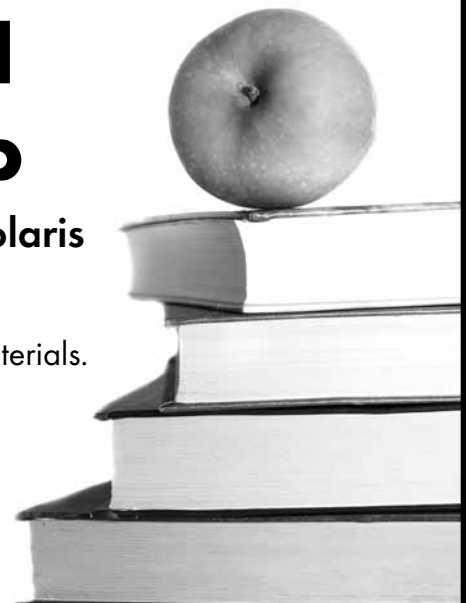

LEGISLATIVE REPORT

Legislature wraps up work, leaves for summer recess

The General Assembly recently returned to finalize work on a number of bills before adjourning for an extended summer recess. However, House Speaker **William Batchelder** (R-Medina) has indicated there might be hearings on pension reform in July and the full House could return around Labor Day to act on the measures.

The two education bills commanding attention in the final days were Senate Bill (SB) 316, the education mid-biennial review (MBR) legislation, and House Bill (HB) 525, the Cleveland Plan. In addition, the governor signed HB 487, the general MBR bill, and exercised his authority to line-item veto certain provisions in the spending bill. Below is more information on each of these issues.

SB 316 (Education MBR)

SB 316 was referred back to the House Education Committee to allow for adoption of a new substitute version of the bill. For the past two weeks, members of the House, Senate and the governor's office have been negotiating behind the scenes to work out their differences and avoid sending the bill to a conference committee. A new version of the bill emerged this

week, was reported out of the House Education Committee and passed by both chambers. The House passed the measure by a vote of 56-35, with some Democrats joining the majority in support and some Republicans dissenting. The Senate concurred with the House's changes by a vote of 23-8.

Legislators responded to your calls, letters and emails on some issues in SB 316, but not others. Following is a summary.

Gifted mandates: Legislators removed the controversial provisions that would have created 16 regional charter schools for gifted students. This provision would have impacted all school districts. In addition, legislators reinstated current law allowing districts the flexibility to use qualified principals or other qualified people to serve as gifted coordinators for the school district.

Please thank legislators for listening to their school districts and making these changes to the bill.

School choice mandates: Unfortunately, the final version of SB 316 still contains school choice mandates. The bill requires districts to notify parents of individualized education program (IEP) students about the Autism

Scholarship Program and the Jon Peterson Special Needs Scholarship Program, even though the Ohio Department of Education (ODE) already provides this information. In addition, the General Assembly chose *not* to remove provisions that require public school districts to verify charter school enrollment monthly — using charter schools' verification policy.

Please remind legislators that OSBA considers both of these provisions to be unfunded school choice mandates.

Third-grade reading guarantee: The final bill makes some changes to the third-grade reading guarantee. The State Board of Education is charged with determining the "cut score," which dictates when to retain a student in the third grade. The bill states that the initial cut score must be no less than "limited," and subsequently be adjusted upward until it arrives at the "proficient" level. Exemptions from retention include students with limited English proficiency, certain special education students and those who demonstrate an acceptable level of performance on an alternative assessment. To be retained, students must have

received intensive reading remediation during at least two school years.

A separate line item creating a \$13 million grant program for the reading guarantee was included in HB 487, the general MBR signed by Gov. **John Kasich** on June 11. In addition, ODE is expected to redirect federal funding allocated for the Title I supplemental services tutoring program that was recently eliminated.

School district report cards:

Provisions related to the changes in report cards were removed from SB 316 and will be taken up separately in HB 555. This will allow the issue to be deliberated more thoroughly. OSBA supported the delay in passing report card legislation.

It is important to note that OSBA is *not* opposed to accountability or raising Ohio's standards. However, a delay will allow districts an opportunity to educate their communities on the new Common Core standards and changes to the report card system. The original proposal would have changed the rules at the end of the school year and held districts accountable for a new system that wasn't even in place.

Let your legislators know that OSBA and its members appreciate the delay and look forward to working with them on HB 555 this fall.

HB 525 (The Cleveland Plan)

Both the House and Senate approved the Cleveland Plan this week and chose HB 525 as the vehicle for the legislation. It passed the House by a vote of 77-16 and the Senate by a margin of 27-4.

The final version of HB 525 includes details negotiated by interested parties, including charter school stakeholders concerned with the accountability and oversight proposed through the Cleveland Transformation Alliance. That objection was addressed by providing an appeal process through the State Board of Education.

The bill includes language permitting charter schools to share local tax levy proceeds. OSBA continues to believe tax levies should be preserved for political subdivisions, like school districts, that are accountable to taxpayers. Districts already have the authority to enter into contracts for services with charter school providers without the necessity of levy approval.

HB 487 (General MBR)

The governor exercised his veto authority 13 times before signing HB 487, the general MBR appropriations bill. One item vetoed was language related to the local share for school districts participating in the Ohio School Facilities Commission Expedited

Local Partnership Program. The provisions would have changed the calculation for certain districts highly impacted by the tangible personal property (TPP) tax. This is the third time a governor has vetoed this proposal, and the second time for Kasich.

OSBA, the Ohio Association of School Business Officials (OASBO) and the Buckeye Association of School Administrators (BASA) have scheduled a series of regional MBR seminars in July to provide greater detail on the specifics of the education provisions in SB 316 and other MBR-related bills. Shared services report released

The long-awaited shared services report by the Ohio Office of Budget and Management (OBM) was officially released on June 14. The biennial budget bill, HB 153, directed OBM and the Governor's Office of 21st Century Learning to perform a study of shared services, conduct a survey of Ohio schools and local governments regarding current shared service activity and issue a report on the findings.

The report, "Beyond Boundaries: A Shared Services Action Plan for Ohio Schools and Governments," includes 10 recommendations and a summary

Ohio students make strong showing at national spelling bee

Ohio students shined brightly under the spotlight of the Scripps National Spelling Bee in May.

Eighteen Ohio students competed in the event held in Maryland. Five Ohioans were among the 50 best spellers nationwide who advanced to the semifinals: **Indian Creek Local (Jefferson)** eighth-grader **Dharani Kotekal**; **Canfield Local (Mahoning)** seventh-grader **Max Lee**; **Medina City** eighth-grader **Sunny Levine**; **Mentor EV** eighth-

grader **Vishnu Nistala**; and **Pickerington Local (Franklin)** eighth-grader **Nicholas Rushlow**.

The semifinals were broadcast on ESPN2 and the finals were shown on ESPN.

Rushlow advanced to the finals and finished fourth in the competition. He advanced by spellings words such as kanaima, monocotyledon and theophylline.

"My dad would've killed me if I missed theophylline," Rushlow joked after the bee.

Rushlow said he devoted about 600 hours to studying the dictionary last summer. The Lakeview Junior High School student was one of two participants in the 2012 bee with five consecutive appearances, making him well known on the national stage. He received a \$3,000 prize for his recent finish.

"I'm among the top 10 in the nation," he said. "That's not bad."

of the survey results. While some of the recommendations were already considered by the General Assembly in MBR legislation — HB 487 and HB 509 — others may be included in next year's biennial budget.

OSBA is pleased that the report recognizes the many shared service activities school districts are involved with. It also cites some examples of pooled purchasing services OSBA offers to school districts. We hope the report will inform schools and other local governments of opportunities that currently exist and encourage their continued search for excellence through efficiencies and sharing

governmental services.

However, OSBA was disappointed to see references in the report to previous studies like the Greater Ohio Policy Center / Brookings Institution Metropolitan Policy Program 2010 report, "Restoring Prosperity: Transforming Ohio's Communities for the Next Economy," and the Education Matters benchmarking study. OSBA, BASA and OASBO published analyses prepared by the consultants for the Education Tax Policy Institute (ETPI) that challenged the data, assumptions and conclusions found in these studies. We submitted the various ETPI analyses to OBM as part of

the shared services study process. Generally, we support the recommendations in the shared services report, but believe the references and quotes from these flawed studies detract from the report's effectiveness.
