

LEGISLATIVE REPORT

New education bills being heard in legislative committees

Now that the General Assembly is up and running, several bills impacting public education are being heard in various committees. As for biennial budget legislation, a bill is not expected until after March 15. Following is a brief analysis of some of the legislation currently before the legislature.

Senate Bill (SB) 4, sponsored by Sens. **Stephanie Kunze** (R-Hilliard) and **Michael Rulli** (R-Salem), would make a capital appropriation of \$100 million for school facilities assistance and allow districts to move forward with several projects that are ready to begin construction.

Since 1997, the Ohio Construction Facilities Commission has disbursed more than \$12.1 billion to supplement local dollars for school construction. Currently, 284 school districts have completed a Master Facilities Plan, with 1,202 new and remodeled school buildings now open. Construction at another 116 school districts are either in progress or have had at least one segment completed.

The purpose of the legislation is to allocate additional funds to continue this progress during the current biennium. The appropriation of \$100 million would allow work to continue for those districts that have secured local funding and are awaiting state dollars.

Other legislation, House Bill (HB) 75, sponsored by Rep. **Derek Merrin** (R-Monclova), requires a local school board to adopt a resolution prior to a property tax complaint or counter-complaint being filed with a county board of revision (BOR). Prior to adopting a resolution, the board would be required to send written notice to

the property owner announcing the intent of the board's action. The notice must be postmarked at least 14 days before the board acts. A resolution would be required for each property being contested; however, a single vote may be used to adopt one or more resolutions.

HB 75 is similar to HB 343 from the last General Assembly. OSBA, the Buckeye Association of School Administrators and the Ohio Association of School Business Officials opposed HB 343 and also are opposing HB 75.

The legislation is unnecessary and would create an unreasonable burden on school boards and district staff. Its provisions, which would require school districts to jump through a number of new hoops, are unacceptable. Further, HB 75 would politicize the BOR

process by forcing school board members to vote on specific, individual properties, and thus the property owners, possibly resulting in "selective" valuation challenges. HB 75 is currently before the House Ways and Means Committee.

Another way to keep abreast of General Assembly activity is to participate in the State Legislative Conference on March 19 at the Sheraton Columbus at Capitol Square. The conference provides an outstanding opportunity to hear from and meet with state legislators, including the leaders of both chambers, Senate President Larry Obhof (R-Medina) and Speaker of the House Larry Householder (R-Glenford). They will share their perspectives on the upcoming biennial budget and education policy.

In addition, Ohio Office of Budget and Management Director **Kimberly Murnieks** will offer insights on the governor's budget proposal, and two education committee members will present a panel discussion on the latest Statehouse activities. The panelists are the new House Primary and Secondary Education Committee Chair, Rep. **Louis W. Blessing III** (R-Colerain Township), and Rep. **John Patterson** (D-Jefferson), co-chair of the House Finance Subcommittee on Primary and Secondary Education.

The conference also includes briefings on proposed legislation that will help school district leaders in discussions with their legislators during lunch and in office visits later in the day.
