#### Trustees take a stand on school safety, review strategic plan

The adoption of a school safety resolution and a work session seeking input on the association's new strategic plan were the two most discussed items during the Feb. 24 OSBA Board of Trustees meeting.

OSBA President **Randy Smith**, **Forest Hills Local (Hamilton)**, presided over the meeting, which began with an hourglass being placed in front of each attendee. "Each minute on the agenda takes at least a minute to prepare," Smith said explaining the timers. "Your time is valuable."

That's why Smith told the group he plans to keep meetings on time and on task, but, "No, it is not designed to be a timer for how long you can talk."

Trustees spent the most time discussing the recent surge in school violence and what OSBA can do to assume a leadership role in identifying solutions in Ohio. "It's an emotional issue and an important issue," Smith said. "Parents are asking us to step up and as OSBA's mission states, we are the leader."

Leading the way, trustees approved a school safety resolution, which can be viewed at **www**. **ohioschoolboards.org/schoolsafety**. The goal is for each board of education in the state to adopt the resolution and push lawmakers to prioritize the protection of students and school employees by enacting legislation with sufficient funding for mental health services, safety measures and increased training.

Additionally, trustees directed OSBA staff to work on creating a school safety and security solutions summit as well as a legislative platform position related to school safety.

Trustees also spent an hour

providing input on OSBA's strategic plan, Visionary Initiatives for Strategic Action, which was initially adopted in 2008 and reauthorized in 2013 and 2018. The 2018 reauthorization transforms seven vision priorities into four new goals that will be the pillars of OSBA's work for the next five years.

During the work session, trustees were split into groups, given time to reflect on each goal and offer suggestions. The trustees' input will be integrated into the goals.

The Board of Trustees, OSBA's governing body, had a busy and productive first meeting of 2018. It meets three times a year in February, July and November. The February and July meetings are held at the OSBA office in Columbus; the November session is conducted at the OSBA Capital Conference and Trade Show.

Conference. He said the Capital Conference Planning Task Force did not anticipate the high number of people that would attend the conference on Sunday, so more programming will be added on that day. He also indicated that Tuesday's programming will be enhanced to feature specialized learning tracks covering a number of disciplines.

Some of the proposed changes to the 2018 Capital Conference include moving the First General Session to Sunday; moving the Student Achievement Fair from Tuesday to Monday; and modifying the Trade Show hours on Tuesday.

In other business trustees: • discussed Director of Legislative Services Jennifer Hogue's outline of OSBA's 2018 legislative initiatives and received an update on education-related bills that have been introduced in the Ohio General Assembly since the last trustees' meeting;

• heard an update on National School Boards Association activities from Lewis and **Susie Lawson**, **Tri-County ESC** and Wayne County Schools Career Center; • approved changing Lewis' title from executive director to chief executive officer;

• heard an update from Senior Information Services Administrator **Drew Clark** on the association's technology initiatives, including the database that handles registration; work on a line of business processes to make them more efficient; centralizing the invoicing and contract process; and pay-perview training with webinars.

The next meeting of the OSBA Board of Trustees is scheduled for July 28 at the association's offices.

### LEGISLATIVE REPORT

#### Bill would limit pre-K-3 out-of-school suspensions, expulsions

The Ohio Senate Finance Committee is holding hearings on Senate Bill (SB) 246, the Supporting Alternatives for Fair Education Act. Also known as the SAFE Act, the legislation would limit using out-of-school suspensions and expulsions for grades prekindergarten through three and require locally driven positive behavior interventions and supports (PBIS).

The legislation's sponsors, Sens. **Peggy Lehner** (R-Kettering) and **Gayle Manning** (R-North Ridgeville), said the legislation's focus is to limit the use of exclusionary discipline with the goal of reducing achievement gaps. In testimony before the committee, Lehner emphasized the persistence of achievement gaps among students from low-income families, minority families and students with disabilities.

As defined in the Ohio Administrative Code, the Ohio Department of Education (ODE) currently requires all schools to implement PBIS. HB 246 further clarifies the objectives and requirements of the PBIS framework that each school must adopt.

In addition, the bill: • Provides \$2 million from Ohio Lottery profits in fiscal year (FY) 2019 to fund competitive grants for public districts and schools to implement PBIS frameworks and social and emotional learning initiatives in buildings serving any of the grades kindergarten through five.

• Prohibits a public district or school from issuing an out-ofschool suspension or expulsion for a student in grades prekindergarten through three except for serious offenses or to protect the immediate health and safety of students, staff and teachers.

The bill delays full implementation of this provision *Continued on page 7*

#### Career-tech students develop fire safety program for youth

Three seniors at **Springfield-Clark Career Technology Center** (CTC) have created a safety program for younger students one that could possibly save lives.

Seniors **Caleb Wirth**, **McKenzie Rucker** and **Ashlyn Sergent** designed a program that teaches children what to do in a fire. All CTC students are required to produce a senior year project.

The students, who are part of CTC's EMT program, got the idea after seeing statistics about a high number of fatalities among children in fires.

"There were many statistics about people dying in fires and children dying in fires who tend to go in closets and hide," one of the seniors told a local newspaper. "We just wanted to raise their awareness and help them know what to do so it prevents deaths from happening."

Once the students came up with the idea, they reached out to **Springfield City**'s Lincoln Elementary School and the city of Springfield's Fire Rescue Division to demonstrate their program, which teaches children essentials such as calling 911 and "stop, drop and roll."

The elementary students also had the opportunity to see the tools firefighters use to save lives and ask them questions.

"I think they learned a lot," Sergent said. "They all seemed pretty interested in it." Source: Springfield News-Sun

until FY 2021. For the three years prior (FY 2018-FY 2020), each public district or school must report to ODE the number of outof-school suspensions and expulsions of students in grades prekindergarten through three for both minor and serious offenses. Using the numbers reported in FY 2018 as a base, each district or school must decrease the number of suspensions and expulsions of prekindergarten through thirdgrade students by 25% in FY 2019, 50% in FY 2020 and 100% in FY 2021 and report this data to ODE. • Requires that in-school suspensions be served in a supervised learning environment

within the school setting. Students

given an in-school suspension must be given the opportunity to complete any classroom assignments missed because of the suspension.

• Requires all teacher preparation programs in Ohio to include a course on PBIS and social and emotional development for all students pursuing a license to teach in any of the grades prekindergarten through 12. Current teachers who have not completed professional development or continuing education on PBIS would be required to complete a course in PBIS within three years of the bill's effective date.

• Requires school principals, beginning in FY 2019, to consult

with a mental health professional under contract with the district or school prior to issuing an out-ofschool suspension or expulsion for a student in grades prekindergarten through three. If the events leading to suspension or expulsion indicate a need for additional mental health services, the principal or mental health professional must, in any manner that does not result in a financial burden to the school district or school, help the student's parent or guardian find providers or obtain those services, including referral to an independent mental health professional.
