### OSBA Board Member Cabinet meets with top Kasich administration reps

The OSBA Board Member Cabinet met in Columbus on May 9 with Dr. **Robert Sommers**, director of the Governor's Office of 21st Century Education. The cabinet attended a separate meeting with **Randy Cole**, president of the Ohio Controlling Board, an arm of the Office of Budget and Management. The OSBA cabinet was created in 2008 to meet with key state leaders to discuss important education issues. It consists of the OSBA president, president-elect and immediate past president, and representatives from around the state. Accompanying the cabinet were OSBA Executive Director **Richard Lewis**, Deputy Executive Director **Rob Delane**, Director of Legislative Services **Damon Asbury** and Lobbyists **Michelle Francis** and **Jay Smith**.

### Study: State funding for Ohio preschool programs drops sharply

Ohio dropped from fifth in the nation in 2009 to 23rd in 2010 in state preschool funding, according to the National Institute for Early Education Research's "The State of Preschool 2010" study. The report presented data from the 40 states that provide preschool funding. Ohio now ranks 36th out of 40 states that provide preschool funding for four-year-olds and 19th out of 24 states that fund it for three-year-olds. Ohio's program serves 3- and 4-year-old children from families with incomes up to 200% of the federal poverty level.

### ODE seeking nominations for 2012 Ohio Teacher of the Year

The Ohio Department of Education is accepting nominations for the 2012 Ohio Teacher of the Year. This program was created in 1969 to honor and promote excellence in teaching and to build a network of exemplary teachers who are leaders in school improvement initiatives. ### Nearly 60% of school levies pass, but new money issues largely rejected

Ohioans approved 86 of the 147 school tax issues on the May 3 primary ballot, a passage rate of 59%. Voters rejected nearly two-thirds of the new money requests, while all but four renewal issues passed. For details, see "OSBA online" on page 2 for information on accessing the OSBA levy database.

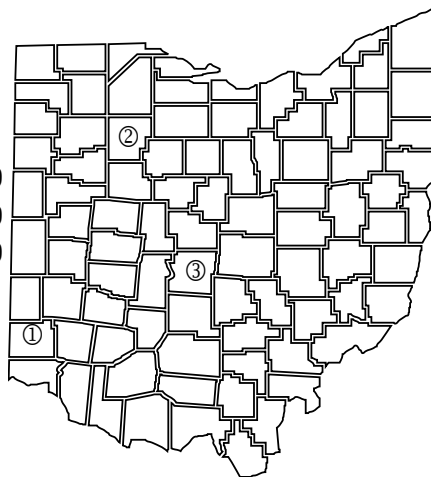

# **Changes in administering medication**

Beginning July 1, all school districts that administer medication to students must meet a new requirement. Under state law, only employees of the school board who are licensed health professionals or have completed a drug administration training program conducted by a licensed health professional and considered appropriate by the board can administer prescription drugs to students.

OSBA is offering a webinar to discuss the history of administering medications and changes in legal requirements to help districts find ways of training licensed health professionals and district personnel on administering medication. The Ohio Department of Health's (ODH) School and Adolescent Health School Nursing Program will discuss the requirements and talk about a new training resource titled "Medication Administration in Ohio Schools: Training for School Personnel."

## LEGISLATIVE REPORT

### House passes budget; OSBA testifies in Senate Finance Committee

The biennial budget bill, Amended (Am.) Substitute (Sub.) House Bill (HB) 153, is continuing to move through the legislative process. It was voted out of the House on May 5 along party lines. While the debate on the House floor was long, very few

amendments were added.

One floor amendment affecting school districts, proposed by Rep. **Ron Maag** (R-Lebanon), would reinstate gifted education spending requirements. Gov. **John Kasich**'s original proposal had eliminated the Ohio Evidence

Based Model (OEBM) provisions, including gifted education reporting and spending rules. The amendment would require school districts to spend the same level of state dollars for gifted education as they spent in fiscal year 2009, even though the gifted education funding component of OEBM would be removed from law and the line item eliminated.

This is of particular concern to our members, given the overall reductions in funding that also are contained in Am. Sub. HB 153. At a time when funding for most programs is being cut, it is unreasonable for a mandate on gifted spending to be required. If there is to be a spending requirement, the mandated effort should be reduced by a percentage equal to the funding cut for overall programs.

OSBA, the Buckeye Association of School Administrators (BASA) and the Ohio Association of School Business Officials (OASBO) expressed opposition to this provision in their testimony, to the Senate Finance Committee on May 11. ## Twenty-five Ohio school districts named to AP honors list

The College Board has honored 25 Ohio public school districts for expanding access to Advanced Placement (AP) exams while maintaining or improving the rate at which students earn college credit for passing rigorous tests.

The districts are among 388 in the U.S. named to the 2011 AP honor roll. Established by the College Board, the AP program enables high school students to take college-level courses, followed by comprehensive exams. Most

universities require a score of three or better, on a five-point scale, to earn college credit.

In Ohio's class of 2010, 23,045 high school seniors took at least one AP exam and 14,323 scored three or higher. These numbers are up significantly from 2001, when 12,923 seniors took an AP test and 8,063 earned at least a three.

The Ohio Department of Education (ODE) recently added a full-time AP coordinator as part of the federal Race to the Top (RttT)

grant. The coordinator is building strong networks among AP teachers, enhancing professional development and working on strategies to raise AP participation.

We encourage you to contact your senators to discuss how the proposed budget will affect your district. It appears as though the Senate is moving up its anticipated schedule and is likely to vote the bill out of committee before Memorial Day. Please watch for updates and calls to action as the bill moves forward.

### Elections reform

Two election reform bills are being heard concurrently in the House and the Senate — HB 194 and Senate Bill (SB) 148. They

include election reforms proposed by Secretary of State **John Husted**. The original purpose of the bill generally does not have an impact on schools. However, the Senate Government Oversight and Reform Committee recently amended SB 148 to eliminate the February and August special elections.

OSBA, OASBO and BASA have joined with the Ohio Township Association, Ohio Municipal League, Ohio Library Council, Ohio Education Association and Ohio Federation of Teachers to oppose this provision. The elimination of special elections was proposed by the County Commissioners' Association of

Ohio and the Ohio Association of Election Officials. They also are advocating for increased election costs to schools and local governments to cover the cost of obtaining and maintaining voting machines.
