#### Study: Nearly \$11 billion diverted to Ohio charter schools since 1999

A new study by Dr. **Howard Fleeter** of the Ohio Education Policy Institute (OEPI) shows that since their launch in 1999, Ohio charter schools have received \$10.9 billion in state money — revenue that was deducted from public schools' state funding. The study states that Ohio's method of funding charter schools is mathematically equivalent to funding them with local tax dollars. The reason is that local districts receive only a portion of the per-student state funding amount, ranging from 90% in the poorest districts to 5% in the wealthiest, while the charter school deduction amount is 100% of the funding for each student. The local funding following charter school students has been about 30% of total charter school revenue over the past several years. OEPI is a not-for-profit research arm of the education community.

#### Voters OK about two-thirds of school tax issues on primary ballot

Ohio voters approved 63 of the 92 local school tax issues in the May 8 primary election. Although 68% of the issues passed, most of the winning issues were renewal levies. Voters approved 40 of the 46 renewal issues on the ballot, an 87% passage rate. Twenty-three of the 46 new school tax issues were approved, a passage rate of 50%. The success rate for renewal levies in the May 2017 primary election was 94%, while new money requests had a 52% passage rate. #### Auditor says ECOT probe could result in criminal prosecution

Ohio Auditor of State **Dave Yost** has referred an audit of The Electronic Classroom of Tomorrow (ECOT) to the U.S. Attorney's Office and Franklin County Prosecutor's Office for possible criminal prosecution. The audit, released May 10, found that ECOT misled state regulators by inflating the amount of time its students were engaged in learning by failing to deduct the time students were inactive online. The audit includes a \$249,962 finding for recovery related to political ads attacking the Ohio General Assembly and Ohio Department of Education in an apparent attempt to keep the state from trying to recover \$80 million in overpayments based on faulty enrollment data.

#### OSBA posts resources to help combat opioid epidemic

In collaboration with the Ohio Attorney General's Office and other groups, OSBA is sharing two webinars that address the state's opioid epidemic. The webinars were created by the Center for Innovative Practices, with support from Ohio Mental Health and Addiction Services and a federal 21st Century Cures Act grant, which provides funding to combat the prescription opioid and heroin crisis. 



## Senate OKs bill limiting suspensions of younger students

Senate Bill (SB) 246, sponsored by Sens. **Peggy Lehner** (R-Kettering) and **Gayle Manning** (R-North Ridgeville) was unanimously voted out of the Ohio Senate May 16.

The legislation, referred to as the Supporting Alternatives for Fair Education (SAFE) Act, now heads to the House for consideration. It seeks to address disciplinary procedures used in schools with the goal of limiting out-of-school suspensions and promoting positive behavioral interventions and supports (PBIS).

Specifically, SB 246 prohibits the use of an out-of-school suspension or expulsion for students in grades pre-K through three unless the student has engaged in a serious offense or it's necessary to protect the immediate health and safety of students, staff, teachers and other school employees. The full implementation of this provision would be phased in over a three-year period.

Current law permits districts

and schools to suspend students for up to 10 school days and/or expel students for up to 80 days for a violation of the district's code of conduct policy. The bill specifies a number of serious offenses for which a yearlong expulsion may be authorized, such as bringing a firearm or knife to school, possessing a firearm or knife at school, making a bomb threat or causing serious physical harm to persons or property.

## Reasonable Suspicion Training

## Cosmetology students experience the beauty of giving

Students in cosmetology classes at Cleveland Heights-University Heights City's Cleveland Heights High School learn and practice the professional skills that help improve one's appearance.

However, a project started by teacher **Donna Pollard** relates more to the beauty of giving. Her students made 44 wigs for cancer patients in 2016 and 2017 and hope to double that number this year.

Pollard started the project two years ago and has even contributed

her own money to buy hair and supplies from a local vendor.

"(A student) was making a wig for her mother's friend who was dying of cancer," Pollard told a local newspaper. "She asked me, 'How do you think this looks?' I said it was great, and then I thought, 'We could do a project with this.'"

Students collaborate with the American Cancer Society, which gives the wigs to The Gathering Place, a nonprofit organization that offers free programs and services to those who have been diagnosed with cancer and their families.

Several students have been touched by cancer. Seniors **Serenity Jackson** and **Larrian Redmond** had grandmothers diagnosed with the disease.

"My grandmother died from breast cancer about six years ago," said Redmond, who recently made an 18-inch-long blond wig. "So, when I was growing up, I wanted to give something back."

During the three years of implementation, a district or school must report to the Ohio Department of Education (ODE) the number of out-of-school suspensions and expulsions of students in grades pre-K through three. While using fiscal year (FY) 2018 as a base, each district or school must decrease that number by 25% in FY 2019, 50% in FY 2020 and 100% in FY 2021.

In addition to limiting out-ofschool suspensions and expulsions, the bill requires all teacher preparation programs to include PBIS instruction. Under the bill, teachers seeking a license for teaching grades pre-K through five would be required to take a course in PBIS.

SB 246 provides an appropriation of \$2 million to fund competitive grants for public districts and schools to implement PBIS frameworks or social and emotional learning initiatives. The individual grant awards are limited to \$5,000 per school building.

The bill requires school districts, within three years, to provide professional development or continuing education in PBIS to any teacher or administrator serving students in grades pre-K through three who have not already completed a PBIS course. Additionally, ODE is required to include on a school district's or

building's report card a measure indicating whether the district or building has implemented a PBIS framework that complies with the bill.

The legislation also requires, rather than permits as under current law, a school to allow a student to complete classroom assignments missed during both in-school and out-of-school suspensions. Furthermore, the superintendent or principal is required to ensure that a student serving an in-school suspension is in a supervised learning environment.
