More than half of state's counties home to Schools of Promise

Stan W. Heffner, superintendent of public instruction, has named 122 Ohio schools as 2010-2011 Schools of Promise. The schools are located throughout the state, including 53 from Appalachia and 11 from the "Big 8" urban districts. The State Superintendent's Schools of Promise program, administered by the Ohio Department of Education (ODE), recognizes schools that are demonstrating high achievement in reading and mathematics for all groups of students, despite the fact that 40% or more of these students come from low-income backgrounds. Boards should act now to prepare for January organizational meeting

Before the end of the year, boards should appoint an individual who will be a member in January to serve as president pro tem to call the organizational meeting to order and preside over officer elections. Additionally, because Ohio's Constitution prohibits compensation changes during a board member's term, now is the time to make any changes in compensation for new board members, including changing the number of paid meetings per year, the amount paid per meeting, and mileage or training reimbursement amounts. ODE submits Early Learning Challenge Grant application to USDOE

Ohio has applied for a federal Race to the Top Early Learning Challenge Grant to improve the quality of early childhood education. If awarded, the grant could bring Ohio \$70 million for the 2012-2015 funding cycle. ODE is the lead agency for the grant, and worked collaboratively on the application with the governor's office, Ohio Department of Job and Family Services and Ohio Business Roundtable. The U.S. Department of Education is expected to announce recipients by the end of the year.

Northeast Ohio universities collaborating on college readiness program

Kent State University, the University of Akron and Youngstown State University were awarded \$432,558 by ODE and the Ohio Board of Regents to establish the East Central Region College TechPrep/Program of Study Center. The center will work with over 100 school districts to boost student enrollment in college prep courses.

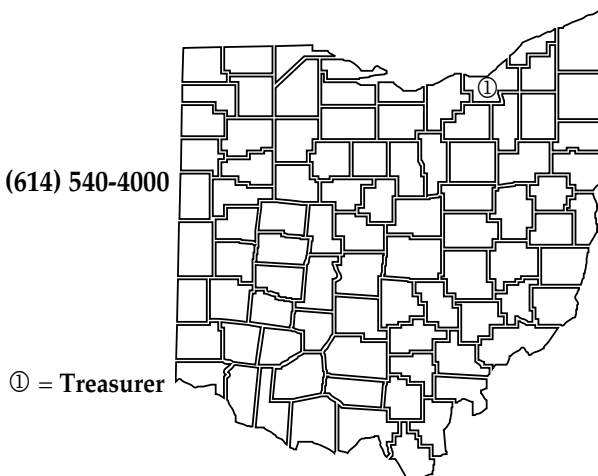

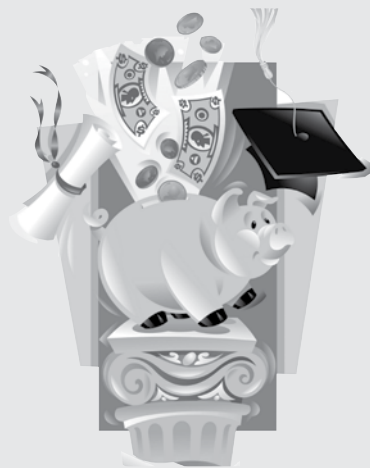

Legislature returns for quick election vote in October

Even though the General Assembly is currently in recess, legislators came back to Columbus for a short voting session in late October to address issues over congressional redistricting.

The legislature passed and Gov. **John Kasich** signed House Bill (HB) 318, which establishes three elections in calendar year 2012:

- March 6 (primary) — Ohio General Assembly and U.S. Senate

- June 12 (primary) — U.S. House of Representatives and U.S. president

- Nov. 6 — General election

The legislation creates a new primary/special election date on June 12 to select party nominations for U.S. House of Representatives seats and presidential candidates. It also eliminates the August 2012 special election date. The March 6, 2012, primary election would be

for party nominations for U.S. Senate and state and local races.

As a result of the language, school districts will have three election opportunities in 2012 for levy purposes — March 6, June 12 and Nov. 6.

The reason for the two primary elections has to do with debate over the redrawing of the congressional district boundaries

Superintendent rides bus for a 'student's eye view'

Jackson Local (Stark) school buses carried an unconventional passenger for the first few weeks of the school year: Superintendent **Chris DiLoreto**.

The superintendent hopped aboard to find out what the world and the schools look like through the eyes of his students. During his time on the buses he watched, listened and talked to students and bus drivers.

The school bus rides were part of an overall effort to remove

barriers that often divide students, teachers and staff from administrators.

"They (students) are our customers," DiLoreto told a local newspaper. "Whether we are riding the school buses with them, eating lunch with them or watching them compete at the Stark County Band Show ... we need to make sure we have their perspective."

Gaining that perspective is critical to helping the school

district ensure that the educational and support services it provides are fully meeting the students' needs, the superintendent said. That's why it's important to understand how students see their schools, classrooms, cafeterias and buses.

"That feedback we get from the students is instrumental for our organization if we are to continue to move forward to meet their needs," DiLoreto said.

based on the most recent census data. Recently passed HB 319 would have set the new boundaries, but the Ohio Supreme Court recently ruled that the legislation could be subject to the referendum process and opponents have started to gather signatures to put HB 319 on the 2012 ballot.

As a result, HB 319 will not be implemented in time for new congressional districts to appear on the ballot in the March primary. The legislature passed HB 318 setting the June 12 date to allow time for the redistricting questions to be resolved.

HB 318 calls for the state to reimburse county boards of election for the cost of the June 12

primary. However, it is unclear whether other local entities would pay a portion of the costs if they use the date for a special election. The following is language from the bill:

Section 4. Upon completion of the June 12, 2012, primary election, the secretary of state shall certify to the director of budget and management the cost to each county of conducting the election. An amount equal to the total of these costs is hereby appropriated to GRF appropriation item 911404, Mandate Assistance, for fiscal year 2013. The director of budget and management shall use this appropriation to reimburse each county for the certified costs of this election.

The ongoing political struggles

over congressional redistricting could result in further changes to the 2012 election calendar. On Nov. 3, House Republicans attempted to fast-track a new congressional redistricting map and eliminate the new June 12 primary, but the plan failed. In the meantime, a new dates and deadlines calendar that takes into account the changes made by HB 318 can be found at www.ohio.schoolboards.org/ORC-dates. We will continue to keep you posted if there are any election changes.
