

### Platform committee OKs 11 resolutions

The OSBA Legislative Platform Committee met Aug. 15 at the association's headquarters in Columbus to review recommended changes to the OSBA 2016 Legislative Platform. The committee approved 11 platform amendments that it will present to the 2015 OSBA Delegate Assembly.

OSBA leadership developed the Legislative Platform Committee to provide a way to streamline the annual process of amending and refining the platform. The purpose of the Legislative Platform is to publicly state OSBA's positions on key education policy issues. The platform guides the association's advocacy efforts and serves as a valuable tool to inform policymakers and the public where OSBA stands on issues impacting public education.

Legislative Platform Committee Chair and OSBA President-elect **Eric K. Germann, Lincolnview Local (Van Wert)** and **Vantage Career Center**, presided over the meeting, which was attended by 17 members of the Legislative Platform Committee and five association staff members.

The committee discussed, amended and approved the following resolutions. Language that is struck through was deleted; language in italics was added. All resolutions were submitted by OSBA staff, except where noted.

### **Resolution 2015-1**

Removes language in the Students and learning section's Assessments plank on page 3 of the platform.

OSBA supports legislation that — Allows locally elected schoolboards to exempt foreign exchange students from taking the Ohio-Graduation Test during the yearthey are visiting the United States.

### **Resolution 2015-2**

Moves language in the Students and learning section's Curriculum plank on page 3 to the Assessments plank on the same page.

OSBA opposes legislation that — Subjects school districts to strict use of technology in testing requirements.

### **Resolution 2015-3**

Adds language in the Students and learning section's Discipline plank on page 4.

OSBA supports legislation that — Furthers the ability of educators to maintain control of their classrooms, buildings, facilities and other school property, and offers appropriate discipline measures as determined by locally developed, board-approved policy *and/or district procedures*.

### **Resolution 2015-4**

Removes language in the School governance section's Charter/ community schools plank on page 6.

OSBA supports legislation that — Limits the sponsorship of charter/community schools solelyto locally elected boards of education.

Plank title and statement:

### Pupil transportation

Pupil transportation presents a significant challenge for many districts. In many areas of the state, students would face great challenges in getting to school were it not for the option to ride a school bus. Rural districts often encompass a large geographic area, but have low-density populations. Funding for transportation services should incentivize efficiencies and account for specific circumstances among districts.

OSBA supports legislation that —
Provides sufficient funding for every child who rides a school bus.

• *Rewards schools for efficiency.* 

• Incentivizes school districts to transport students residing within one to two miles of their school.

• Incentivizes school districts to provide transportation for high school

students.

• Fully compensates districts for the transportation of students to schools that are not part of the district.

• Provides for better support of rural districts with low density and low wealth.

• Operates separately from the education funding formula to ensure districts actually receive the state transportation levels to which they are entitled.

• *Reinstates funding for school bus purchases.* 

The OSBA Delegate Assembly will vote on the proposed changes to the platform during its annual meeting at the Capital Conference and Trade Show on Nov. 9 at the Greater Columbus Convention Center. Items receiving approval of at least 75% of those present and voting will be added to the official 2016 OSBA Legislative Platform.

All Capital Conference delegates and attendees are encouraged to attend the meeting, which begins at 2:30 p.m. in the Terrace Ballroom. *Note*: Due to renovations underway at the convention center, the location and time of the Delegate Assembly meeting has changed. The Terrace Ballroom is on the second floor at the north end of the convention center.

# LEGISLATIVE REPORT

### Judge OKs Youngstown Plan; two legislators propose changes

The controversial amendments added at the last minute to House Bill (HB) 70 are set to move ahead after a judge's Oct. 13 rejection of an injunction to delay them. Those amendments, which have come to be known as the Youngstown Plan, call for a dramatic restructuring of academic distress commissions in Ohio.

The **Youngstown City** Board of Education had filed a lawsuit requesting the injunction in Franklin County Common Pleas Court. The suit sought to have the new academic distress commission model declared unconstitutional. The district has since appealed the Franklin County court's ruling.

The new structure diminishes local control and puts an appointed CEO in charge of Youngstown City Schools. The law applies to any Ohio district overseen by an academic distress commission. Youngstown City currently is the only district in such a situation.

At an Oct. 16 news conference, Ohio Senate Minority Leader **Joe Schiavoni** (D-Boardman) and Rep. **Michele Lepore-Hagan** 

(D-Youngstown) announced plans to introduce legislation that would improve the new academic distress commission plan. Their legislation would recommend changes to ensure more transparency, accountability and community involvement in the design of the CEO's district improvement plan.

HB 70, as introduced by Reps. **Denise Driehaus** (D-Cincinnati) and **Andrew Brenner** (R-Powell), was intended to allow school districts and community schools to initiate a community learning center process to assist and guide school restructuring. The recommended process was a collaborative model based on the Oyler School experience, a successful **Cincinnati City** Schools community learning center.

The 11th-hour amendments to the bill — proposed by the governor's administration with support from some Youngstownarea leaders — substantially altered the operation of academic distress commissions. The plan was developed without any involvement from the Youngstown City Board of Education or community members, and passed through the legislature in fewer than 12 hours with little or no debate.

The law requires the Youngstown academic distress commission and future commissions to be composed of three members appointed by the state superintendent of public instruction; one appointed by the mayor; and one appointed by the school board president. The school board president's appointee must be a teacher.

The five-member commission would then hire a CEO who would have full managerial and operational control of the district. The powers of the CEO would include the authority to:

• close and reconstitute buildings, including reopening them as charter schools;

• reopen contract provisions of union collective bargaining agreements;

• suspend contract provisions, as long as per-hour pay and insurance costs are not affected; this can only occur in the third year of oversight.

The board of education has no authority over the CEO. If academic performance improves over the first two years, a transition back to board control could occur. If improvement does not occur after five years, the district would transition to a board appointed by the mayor.

In seeking to have the law ruled unconstitutional, Youngstown City Schools argued that the law violates citizens' rights to have elected representatives (school board members) oversee their

### Piqua fifth-grader places in national game-a-thon

Cooking with mom inspired a **Piqua City** Schools fifth-grader to create a fun math game that has earned national recognition.

Kirsten Shaneyfelt's game, Fraction Bakery, placed her in the top five of the national MIND Research Institute's K-12 Game-athon Challenge. The competition encourages students to create a game that involves various math subjects.

"It feels really awesome," Shaneyfelt told a local newspaper. "I worked really hard last year and it was a disappointment to not get into the top."

Shaneyfelt said she wanted the game to do with cooking. Her game uses fractions to create a pie. Players pick from colored cards with fraction problems. A correct answer allows a player to add the colored piece of pie that matches the card color to their pie pan.

A player who completes a pie must then answer the equivalent

fractions listed on a recipe card.

Shaneyfelt, the daughter of Marie and Joseph Shaneyfelt of Piqua, was invited to the institute's Math Fair at the Navy Pier in Chicago on Sept. 26.

Eight Piqua City Schools teams participated in the competition. Shaneyfelt was the only one to place.

schools. The district also contended that by rushing the amendments through at the last minute, the General Assembly violated the Ohio Constitution's requirement that each legislative chamber conduct three readings of a bill prior to passing it.

The Franklin County court subsequently ruled that HB 70's passage did comply with the Ohio Constitution's three-reading requirement. The ruling read, in part:

"The court finds that there was an opportunity to study and debate amended HB 70 ... (B)oth the Senate and the House decided to forgo their opportunity to further consider and debate the amended version of HB 70, and instead voted and concurred with the amended version."

The court also found that since HB 70 maintained its common purpose of restructuring lowerperforming school districts, the legislation was not vitally altered. That part of the ruling stated:

"The court finds that both versions of HB 70 were focused on restructuring and improving failing or lower-performing school districts, and both versions of the bill primarily amended the same chapter of the Ohio Revised Code — Chapter 3302 'Performance Standards.' Although HB 70, as originally introduced and passed by the House, focused on addressing these concerns by the use of a community learning center model, and the enacted version of HB 70 added the use of an expanded academic distress system with an appointed CEO to manage the distressed school system, the purpose of both versions of HB 70 remained the same — to assist and guide school restructuring and provide support for lower-performing school districts."
