### Youngstown City files legal action to declare HB 70 unconstitutional

**Youngstown City** Schools and several other groups have filed a lawsuit seeking to have House Bill (HB) 70 ruled unconstitutional. Hastily passed last-minute amendments to the bill drastically changed the structure and authority of academic distress commissions. The legislation requires the newly structured commissions to appoint a CEO who would have full operational and managerial control of a district in academic emergency, as well as other unprecedented powers. The suit contends that by pushing the amended bill through in fewer than 24 hours with no input from the school district or community, the legislature vitally altered HB 70 as introduced and violated the Ohio Constitution's "three-reading rule." OSBA is strongly urging school boards across Ohio to adopt a resolution calling for changes to the last-minute amendments to HB 70 and opposing the manner in which the changes were approved. 

### Ryan promoted to director of board services as LaSota retires

When **Kathy LaSota** arrived at OSBA 12 years ago, it didn't take long for her to recognize her passion.

As a prior director of school and community relations for **Hilliard City** and **Delaware City** schools, LaSota strived to bring together diverse opinions from administrators, teachers and parents.

"I have thoroughly enjoyed my entire career, but OSBA gave me the amazing opportunity to use the talents and skills that I enjoy the most to benefit the people who make the biggest difference in the lives of our youth," LaSota said. That skill as a facilitator has earned LaSota the respect of OSBA members who have trusted the director of OSBA's Division of School Board Services and her team to help districts hire qualified superintendents and treasurers, undertake strategic planning and *Continued on page 5*

improve their leadership team relationships.

That expertise will be missed as LaSota's more-than 40-year career in public education comes to a close; she retired at the end of August.

**Cheryl W. Ryan**, former deputy director of school board services, has been promoted to lead the division. She joined OSBA in 2007 as an education management consultant.

"I couldn't be leaving the division in better hands," LaSota said. "Cheryl and her team are unmatched in the industry."

LaSota's motivation to follow a career path in public education began in her hometown of Steubenville, where her fifth-grade teacher inspired her.

With a bachelor's degree in elementary education, LaSota began teaching in 1972.

Prior to joining OSBA, she also was self-employed as an educational consultant, working with district administrators and school boards on goal setting, continuous improvement planning, diversity, communications and other related topics.

"Kathy has been an integral part of the board development team," said **Richard Lewis**, OSBA executive director. "Not only has she has made an enormous impact on hundreds of school boards across the state, she has been the catalyst for several new programs."

LaSota has remained active as a member of the National Affiliation of Superintendent Searchers and the National School Boards Association's State Association Trainers work-alike group.

"Kathy has been a fabulous mentor," Ryan said. "She's been a very open and transparent director and she's a creative problem solver. She's always involved the entire staff in the division as decisions were made and new initiatives explored."

Ryan, a former Hilliard City school board member, expects a smooth transition.

Before coming to OSBA, Ryan served as the director of international programs at the Ohio State University Fisher College of Business. There, she directed the activities of the university's Center for International Business Education and Research. Prior to moving to Ohio, she had a similar role at the University of Colorado Denver.

Ryan's education includes an undergraduate degree in psychology from Colorado State University and a master's degree in business administration with an emphasis in strategy and international business from the University of Colorado.

Ryan and her husband, **Paul**, live in Hilliard, and are parents of a son and daughter.

"The hardest thing about taking over as director is going to be doing it without Kathy here," Ryan said. "I'm excited about the opportunities for both of us, but it's going to be a different kind of reality."

LaSota plans to spend more

time with her family, including her 94-year-old mother, who lives in Steubenville. LaSota and her husband, **Don**, live in Delaware. They have a son, daughter and three grandchildren.

"My parents always taught me that you surround yourself with good people and that's who you become," LaSota said. "I just hope in retirement I will be able to find those people again. I found those good people at OSBA."




OSBA President Ed Penrod,

### More than 30 Ohio schools on Newsweek top high schools list

More than 30 Ohio high schools made the list of *Newsweek*'s America's Top High Schools 2015.

Those among the top 100 were Ottawa Hills Local's (Lucas) Ottawa Hills High School; Oakwood City's Oakwood High School, Indian Hill EV's Indian Hill High School; Dublin City's Jerome High School; and Solon City's Solon High School.

The magazine creates the list of the top 500 public high schools, which has been publicized for more than a decade, by analyzing the schools' proficiency related to state math and reading tests.

The magazine then issues the rankings based on a variety of factors, including college enrollment and graduation rates and Advanced Placement or International Baccalaureate test scores.

"Newsweek's high school

rankings are exceptional because of the many factors we take into consideration when selecting top schools, as well as our look at inequality when it comes to education," **Jim Impoco**, the magazine's editor in chief, said in a news release. "We have unique insight into what public schools across the country are doing to prepare their students for college, which is a critical next step for graduating teens."
