#### **ENATE HOLDS HEARING ON PRESIDENT BIDEN'S FY24 BUDGET REQUEST**

On Wednesday, March 15, the Senate Budget Committee held a hearing on President Joe Biden's Fiscal Year 2024 Budget Proposal. The hearing <u>featured</u> Member statements from Chairman Sheldon Whitehouse (D-RI) and Ranking Member Chuck Grassley (R-IA), and witness testimony from Office of Management and Budget (OBM) Director Shalanda Young. In his opening statement, Chairman Whitehouse commented on how the budget symbolizes the Administration's values and touted its investment in kids, families and communities. "The

investments proposed in this budget are more than worthwhile. They are overdue," the Chairman said. He continued, "I challenge anyone to say it's not worthwhile to make investments in our kids. The Biden budget would increase childcare options for 16 million more kids, lower costs for parents, fund pre-K access for all four-year-olds, and restore the full Child Tax Credit." Tackling childcare and getting people back into the workforce was a prominent topic of discussion between Senators and Director Young. "It matters what to invest in. And we believe we have to grow the economy and one of the important pieces of the President's investments is childcare," Ms. Young responded in an exchange with Senator Tim Kaine (D-VA) that the lack of high-quality, affordable childcare is preventing people from entering or reentering the workforce. Additional discussion during the hearing focused on lowering costs for Americans, reducing the deficit, and amending the tax code to make it more fair, as well as strengthening Medicare and protecting Social Security. # 2. Budget and Appropriations Wrap-Up

Last week, the House was in recess while the Senate stayed in town. Since the House goes first in the annual appropriations process, that means there wasn't much progress on that front. There will be a slew of House Appropriations Committee <a href="hearings this week">hearings this week</a>, though, including the Labor, Health and Human Services and Education Subcommittee's <a href="public witness day">public witness day</a>, which will feature 17 witnesses addressing the breadth of issues and programs the panel will be considering. The schedule of the Committee is representative of the pace of activity on the Hill this week: busy. Thousands of advocates for various issues will be visiting Congress.

The Senate won't act on appropriations for a while, and Senate Appropriations Committee Chair Patty Murray (D-WA) released a tentative schedule for hearings that will host agency leaders. Secretary of Education Miguel Cardona is (tentatively) expected to appear before the Senate Labor, Health and Human Services and Education Appropriations Subcommittee to defend the White House's budget request for his agency on May 11, 2023.

In the meantime, Dear Colleague letters making the case for more—or "robust"—funding for programs are circulating. Local interests are busily filling out paperwork to meet deadlines for community projects. There is a lot of work going into an appropriations process that still has the country's debt limit and House Republicans' desire to keep government spending at Fiscal Year (FY) 2022 levels slowing action. Seasoned advocates think there's very little chance that the spending bills will be completed by the end of FY 2023—September 30, 2023, and are predicting several continuing resolutions while the issues are sorted.

# How does this impact State School Board Associations?

In education news, it is clear that the Administration has been watching both the Education and the Workforce Committee deliberation and passage of the *Parents Bill of Rights Act* as well as the introduction, debate and passage of various state-level education policies. Last week, Secretary Cardona penned **an op-ed** titled, "As Education Secretary, I want us to enrich public schools, not ban books and topics." The piece, published by the Tampa Bay Times, takes aim at a number of topical education debates, and asserts that the Biden Administration has been successfully working to improve education nationwide.

BONAMICI, DEMOCRATS INTRODUCE BILL OF RIGHTS FOR STUDENTS, PARENTS On Friday, March 10, Congresswoman Suzanne Bonamici (D-OR.) introduced her Bill of Rights for Students and Parents, a Democratic response to the Republicans' Parents Bill of Rights, now on its way to the House floor for a vote. "Parental involvement is critical to developing and sustaining high-quality public schools, and we must do all we can to involve parents and break down barriers that prevent or discourage participation," Bonamici said. The bill is supported by numerous education groups, including the National Parent Teacher Association (PTA). A <u>summary</u> of the legislation outlines that a student "should be able to receive a well-rounded education," and parents and families "should be able to collaborate effectively" with their children's teachers. Additionally, it dictates that public schools should be "responsive and inclusive," students should be able to learn in environments "free from all forms of discrimination," and all students should "receive an education that is historically accurate, reflects the diversity of our nation, and prepares students to think critically and participate actively in a representative democracy." The Republican counterpart, led by Congresswoman Julia Letlow (R-LA) mandates school districts to offer teacher-parent meetings, publicly disclose budget materials and allow parents to address the school board. "The previously introduced 'Parent Bill of Rights', HR 5, completely misses the mark and has discriminatory undertones that distract us from the seriousness of this moment," the National Parents Union said in a statement. "Pitting parents against parents, parents against teachers, and adults against students does nothing to move us forward," they continued. A full list of endorsers of Bonamici's bill, the

#### CATO EXAMINES POLICY PROPOSALS FOR CHILDREN'S ONLINE SAFETY

On Wednesday, March 15, the Cato Institute held a webinar titled, "Do the Latest Policy Proposals Improve Children's Online Safety." The event featured Jennifer Huddleston, technology policy research fellow for the Cato Institute; Matthew Feeney, head of technology and innovation at the Centre for Policy Studies; and James Czerniawski, senior policy analyst for Americans for Prosperity. Ongoing parental conversations concerning online content exposure have pushed policymakers to introduce regulatory proposals aimed at improving child online safety. Since the start of the New Year, debate on this issue has expanded across many levels in the United States and the United Kingdom, and panelists aimed to cross-examine the resulting policy developments and their potential consequences on the world stage. Feeney initiated the discussion and explained the United Kingdom's Online Safety Bill – a bill that regulates certain internet services and focuses on "child safety measures through monitoring user-to-user interaction." Czerniawski then provided a U.S. perspective, noting that "the federal government is going to be slow in implementing a strategy similar to the U.K.," leaving ultimate responsibility on individual states. Czerniawski elaborated on two pathways states are taking on this issue: age assurance and age verification, proposed by California and Utah, respectively. The panel also discussed potential international implications if the United Kingdom's online safety bill became law and drew attention to smaller U.S. companies that have European contributors. These entities lack the industry and institutional support that larger corporations have established – such as Meta or Google – and therefore creating a disadvantaged system with different sets of rules. To this, Czerniawski added that as smaller companies face difficulties in

trying to attract growth, it will inevitably lead to "deterioration of investment and innovation." Both Feeney and Czerniawski agree that child online safety needs to be at the forefront of policy, however policymakers should consider the difficulties that could arise in maintaining personal autonomy through constitutional rights and privacy protection. Specifically, Feeney states that "eighty to ninety percent [of the Online Safety Bill] would be unconstitutional in the U.S." Participants also examined TikTok cybersecurity concerns, the perspective of young people, and alternative age verification techniques.
