### **Budget and Appropriations Wrap-Up**

The House and Senate are poised to pass an FY 2023 omnibus spending bill before week's end. After weeks of negotiations, Senate Appropriations Committee leadership released <u>the 4,155-page bill</u> last night. The omnibus includes \$772.5 billion for non-defense discretionary programs and \$858 billion in defense funding. Senate Appropriations Committee Chairman Patrick Leahy (D-VT) issued <u>a statement</u> summarizing the measure.

Regarding education, the bill includes increases, but, as predicted, the increases are not what President Joe Biden requested or what the House and Senate approved earlier this year. The bill grows the Department of Education's budget by \$3.9 billion overall, and includes \$18.387 billion, an increase of \$850 million or 5 percent more than FY 2022, for Title I. This program assists more than half of the country's public schools and their efforts to raise student achievement.

The bill also includes increases for a range of other important programs, providing \$150 million, an increase of \$75 million or 100 percent, to support additional Full Service Community Schools. The bill also provides \$215 million, an increase of \$20 million or 10 percent, for Rural Education programs and invests \$1.33 billion, an increase of \$40 million, for the Nita M. Lowey 21st Century Community Learning Centers program, which supports more than 10,000 afterschool programs around the nation, serving 1.6 million students. For higher education, the bill increases the maximum Pell Grant award by \$500 or 7.2 percent to \$7,395 for the 2023-24 school year. This is the largest increase in the maximum Pell grant award since the 2009-10 school year. The bill also includes \$285 million, an increase of \$50 million or 21 percent, for the Registered Apprenticeship program. A summary of the Labor, Health and Human Services and

While there could be some partisan sniping and procedural maneuvers in coming days, the bill is expected to pass the House and Senate before Friday, when the current measure keeping the federal government open will expire.
