# **OSBA Master of Transportation** Administration (MTA) Program

#### Workshop dates and descriptions

#### Oct. 13 — The budget process — state and local

Transportation is a significant cost factor in every school district. This session will look at the local budget as well as the state education budget and review cost analyses and how to find them, what to do with them and what the numbers mean. To prepare for this class, consider bringing your department budget — whether or not it is under your control.

#### Dec. 1 — Transportation rules and regulations

This course is essential for new transportation administrators and any school administrator involved with transportation services. The rules and regulations — revised and administrative codes — that govern student transportation will be reviewed. The local policy contains the standards to which you are held and can be a liability when your department fails to meet them. This course is an annual part of MTA and is different each year to focus on areas that are particularly sensitive in the current environment.

#### Feb. 2 — Federal regulations, guidance and agencies

School transportation is not only governed by local rules but also is subject to a significant number of federal rules and regulations. We will look at the external impacts on transportation and consider the federal alphabet soup: including FMCSA, NHTSA, NTSB, TSB and ODI. Part of this session will look at various federal studies that continue to be landmarks in the student transportation industry.

#### March 2 — Laws, rules and policy — what, how and why

What is the difference between revised code, administrative code and department policy? Are they all mandates that must be followed, or are they just best practice that should be followed? What happens when they conflict? We will look at the technical aspects of various regulatory controls and the process that is invoked in moving an idea for change into policy, rule or revised code. Is this "government 101"? Perhaps, but it is also important for you to understand in the event you want to help influence the future.

#### April 6 — Hot topics — safety, trends and statistics

This final session of the year will look at hot topics in the school transportation industry. As part of that review, we will look at the never-ending discussion on passenger restraints, review crash studies completed by the National Transportation Safety Board, look at Ohio school bus accident statistics and leave the door open for attendees to bring up topics that are important in their districts. While we explore these hot topics, an underlying focus is also on how to identify the learning points in each of these areas and to share them with the staff that delivers our front-line transportation services.

# LEGISLATIVE REPORT

#### Vaccine legislation struggles to find common ground

"The General Assembly hereby declares that it intends to enact legislation regarding vaccines."

Those few words were the sole content of the first version of the House's priority legislation to address vaccine mandates. That bill, House Bill (HB) 435, was introduced on Sept. 27 by Reps. **Rick Carfagna** (R-Genoa Township) and **Bill Seitz** (R-Cincinnati) under the direction of House Speaker **Robert R. Cupp** (R-Lima).

Cupp's proposal, which he called "reasonable and workable," joins a bevy of House bills addressing vaccine mandates but, unlike others, attempts to find common ground among his caucus and vaccine advocates and opponents. The release of the plan also comes on the heels of Cupp's stifling of a competing proposal, HB 248, sponsored by Rep. Jennifer Gross (R-West Chester). Until this point, HB 248 dominated the statewide debate on vaccines and, at times, garnered intense national media attention for controversial witness testimony.

The House Health Committee held five jam-packed, hourslong hearings on HB 248 in the spring, but the summer recess stalled its progress. A rare August hearing was scheduled as Gross and her allies hoped it would kick-start and advance the bill, but House leaders had different plans.

The day before the Aug. 24 hearing, Cupp weighed in. "This legislation is important to many members of the caucus," Cupp said in a statement. He concluded that the House would pause hearings on the bill and would work with the chairman, bill sponsor and interested parties on "this important issue."

In search of an alternative to the holdup, Gross sought a discharge petition, a seldom-used and littleknown maneuver that bypasses the committee process and forces a vote of the full chamber on the legislation. According to House Rule 87, a representative can file a motion to discharge a committee of further consideration of a bill if a majority of House members sign such a petition.

Over several days in mid-September, Gross circulated the petition. Despite only a small contingent of House Republicans lending their support to the effort, Gross pressed on, but Cupp was forced to respond and removed Gross as a member of the House Health Committee.

Then came Cupp's legislative response on Sept. 27. Carfagna and Seitz — majority floor leader and assistant majority floor leader, respectively — introduced HB 435, with the only cosponsors being the speaker, three remaining members of Cupp's leadership team and Health Committee Chairman Rep. **P. Scott Lipps** (R-Franklin).

The following day, the House Health Committee adopted a substitute version of HB 435, replacing the 13-word intent language at the beginning of this article with the full contents of the bill. It then passed the bill by a vote of 11-3 at its first hearing.

The next day, the fast-tracked legislation was up for a vote in the House, but Speaker Pro Tempore Rep. **Timothy E. Ginter** (R-Salem) successfully motioned to rerefer the bill back to the House Rules and Reference Committee, which spelled trouble. Sensing a lack of consensus and perhaps a majority of "yes" votes, Cupp and his leadership team were forced to retreat on their proposal, telling reporters that lawmakers wanted more time to consider the bill.

Criticism of the bill from vaccine supporters and opponents alike was intense and swift. The former alleged the bill undercut vaccination efforts, and the latter claimed it did not go far enough to protect individuals' health decisions. The bill is currently *Continued on page 6*

pending in the House Rules and Reference Committee.

So, what's in the bill? HB 435, which sunsets on June 30, 2023, would prohibit public and private schools and public and private colleges and universities from requiring a student to receive a COVID-19 vaccine for which the U.S. Food and Drug Administration (FDA) has not issued a biologics license. To date, Pfizer Inc.'s COVID-19 vaccine is the only vaccine to possess a biologics license, which is used to obtain full FDA approval.

If such an entity requires a student to receive a COVID-19 vaccine for which the FDA has issued a biologics license, a student may satisfy that requirement either by receiving the vaccine or receiving a COVID-19 vaccine that is available under emergency use authorization.

Student immunization requirements in Ohio are prescribed in state law, with all students subject to several immunizations prior to enrollment in school. HB 435, however, leaves the decision to mandate the vaccine up to each school, opening the door for disuniform and disparate COVID-19 vaccine policies for students across the Buckeye state.

HB 435 also prescribes the following exemptions from a COVID-19 vaccine requirement: medical contraindications, which must be communicated to the school, college or university via a written statement signed by the student's primary care provider; natural immunity, which must be communicated to the school, college or university that the student has been tested for the presence of COVID-19 antibodies and had antibodies equal to or greater than those conferred by a COVID-19 vaccine that has been issued a biologics license;

• reasons of conscience, including religious convictions, which must be communicated to the school, college or university via a written statement.

These exemptions explicitly do not apply to students who, as part of their course of study, receive instruction or training at a children's hospital or intensive care or critical care unit of a hospital if either of those hospitals are owned or operated by or affiliated with a public or private college or university.

Except for non-vaccinated students with natural immunity, exempted students are not responsible for any costs or fees associated with measures to prevent the spread of COVID-19, including testing for active infection and masking.

Meanwhile, the bill prescribes restrictions for public and private employers, including school districts, with regard to COVID-19 vaccine mandates. First, it prohibits all employers from requiring employees to receive any vaccine for which the FDA has not issued a biologics license. Second, it prohibits public employers and school districts from requiring individuals to show proof of COVID-19 vaccination to gain admission to or enter a facility. Second, it prohibits employers from requiring employees to receive any vaccine for which the FDA has not issued a biologics license.

The same exemptions and submission requirements that the bill applies to students are also *Continued on page 7*

### 14 Ohio public schools earn national blue ribbon honors

Fourteen Ohio public schools have been recognized as 2021 National Blue Ribbon Schools by the U.S. Department of Education. The recognition is based on a school's overall academic performance or progress in closing achievement gaps among student subgroups.

applied to public and private employees. However, the exemptions do not apply to:

• employees who begin employment after the bill takes effect;

• employees of a children's hospital or in the intensive care or critical care unit of a hospital.

The bill establishes remedies by which students and employees can seek relief from the bill's violations. For example, violations of the bill's restrictions constitute an unlawful employment discriminatory practice and allow for an employee to file a charge with the Ohio Civil Rights Commission. Public sector employees also may elect to pursue a mandamus action against an employer, rather than an action based on employment discrimination. Finally, students are authorized to bring a mandamus action in the event their school, college or university violates the bill's provisions.

The bill's prohibitions and requirements explicitly do not impede or diminish collective bargaining rights with respect to terms and other conditions of employment related to vaccines. However, the bill prohibits COVID-19 vaccine-related provisions of a collective bargaining agreement entered into on, before or after the bill's effective date from applying to a person who is not a party to the agreement.

Finally, the bill extends through June 30, 2023, the temporary qualified civil immunity provisions from HB 606 of the 133rd General Assembly, which expired Sept. 30, 2021. These immunity provisions include a provision that prohibits a civil action for injury, death or loss to person or property against any person, including schools, for injury, death or loss caused by exposure to or transmission or contraction of the coronavirus.
