OAG offering \$11 million in school safety grants

The Ohio Attorney General's Office (OAG) announced it will be awarding \$11 million in school safety grants to Ohio schools for the 2022-23 academic year. The funding, from House Bill 110, can be used for safety planning, training and classroom programs for public schools, educational service centers, STEM schools and schools operated by county boards of developmental disabilities. Each school is eligible for a grant of \$2,500 or \$5.50 per student, whichever amount is greater. Grant applications should be submitted via the Ohio Grants Portal at https://grants.ohio.gov/fundingopportunities.aspx. Details are available at http://links.ohioschoolboards.org/46654. The deadline is Feb. 28.

OSCC releases list of trainings to meet SAVE Student Act requirements

A list of evidence-based programs that meet the requirements of the Safety and Violence Education Students (SAVE Students) Act is now available. Developed by the Ohio School Safety Center (OSCC), in consultation with the Ohio Department of Education and Ohio Attorney General's Office, the list includes approved threat assessment programs that identify physical safety risks and provide instruction in identifying behaviors, signs and threats that may lead to a violent act; determining the seriousness of a threat; developing intervention plans that protect potential victims and address the underlying problem or conflict that initiated the behavior; and assessing plan results. 

Feb. 2 — Federal regulations, guidance and agencies

School transportation is not only governed by local rules but also is subject to a significant number of federal rules and regulations. We will look at the external impacts on transportation and consider the federal alphabet soup: including FMCSA, NHTSA, NTSB, TSB and ODI. LEGISLATIVE REPORT

Bill would require curriculum to be posted online

Despite existing laws covering the topic, a pair of Republicans in the Ohio House of Representatives want public and private schools and public colleges and universities to upload to their websites all educational materials used in student instruction. The proposal, House Bill (HB) 529, was introduced Jan. 4 by Reps. Brett **Hudson Hillyer** (R-Uhrichsville) and Bill Roemer (R-Richfield) and includes 13 co-sponsors.

Under HB 529, all public school districts, charter schools, STEM schools, chartered nonpublic schools, and public colleges and universities that participate in the College Credit Plus program

would be required post an internet link or title to specified instructional items on their websites by July 1 each year.

The following items must be uploaded:

- all textbooks;
- course syllabi that include a list of all instructional materials and activities to be used for student instruction in each instructional course;
- a written summary of each instructional course;
- the state academic content standards related to each course.

The bill defines "instructional materials" to include "textbooks, reading materials, videos, digital materials, websites, online applications and any other materials used for student instruction." It also defines "activities" to include "presentations, assemblies, lectures, or other activities or events facilitated by the entity's staff, excluding student presentations."

Finally, the bill defines "used for student instruction" to mean "any task assigned or any information distributed or otherwise presented to students in any course for which students receive academic credit" and "any materials from which students are

required to select one or more, provided that the available selection is restricted by the school district or school."

If any of the uploaded items are used or revised by educators after their initial posting, those updates must be uploaded within 30 business days after each use or revision. All uploaded items must

remain accessible on the website at least two years from the date posted.

The bill also includes two provisions requiring the posting of course curricula for all chartered nonpublic schools and for public colleges for courses in which high school-level students are enrolled.

The provisions of HB 529 are in addition to Ohio's existing laws on parental access to student instructional materials, which have long-provided parents virtually unfettered access to those materials upon request.

For example, Ohio Revised Code (RC) 3313.60 requires school Continued on page 7

Trees to Textbooks invests \$1.5M in schools, communities

Sixteen rural Ohio school districts and their corresponding counties and townships are sharing more than \$1.5 million from the harvest of timber from Ohio's state forests through the Trees to Textbooks program, part of the Ohio Division of Natural Resources' (ODNR) Division of Forestry.

Through the program, a percentage of the revenue generated from state forest management activity goes to the

county, township and school district in which the activity took place.

"Our Trees to Textbooks program is just one of the economic benefits our state forests bring to rural communities," ODNR Division of Forestry Chief **Dan Balser** said in a news release. "Sharing these funds locally helps communities provide necessary services and can go a long way in making good schools better."

The Ohio Division of Forestry

began distributing timber revenues to counties and townships in the early 1980s.

Since the Trees to Textbooks program started in 1999, more than \$34 million has been shared with Ohio school districts and local governments. The Ohio Division of Forestry is responsible for the care of more than 20,000 acres of state forests. State forestry experts manage these woodlands.

districts to permit parents, upon their request, to promptly examine the following information:

- surveys and questionnaires prior to their administration;
- textbooks, workbooks, software, videos or other instructional materials;
- completed and graded tests and completed surveys and questionnaires;
- copies of the statewide academic content standards and model curriculum, copies of which must be always available during school hours in each school.

This law does not apply to chartered nonpublic schools, charter schools, STEM schools or public or private colleges or universities.

Another provision of law, RC 3313.212, requires school districts to provide an opportunity for parents to review the selection of textbooks and reading lists, instructional materials and the academic curriculum used by schools in the district. That statute also requires each board of education to establish a parental advisory committee or another method for review to meet this requirement.

This law also does not apply to chartered nonpublic schools, charter schools, STEM schools or public and private colleges or universities.

Finally, RC 3313.60 contains another provision that requires public school building principals to provide parents, upon written request, an opportunity to review the school's dating violence prevention instruction materials.

This law, like the others previously mentioned, does not apply to chartered nonpublic schools, charter schools, STEM schools or public and private colleges and universities.

HB 529 is pending referral to a standing committee in the House.
