The U.S. Department of Education, in partnership with the National Comprehensive Center, recently released a resource to help states share their progress on deploying Elementary and Secondary School Emergency Relief (ESSER) funds through the American Rescue Plan (ARP). This tool, called the ARP Partnership, Assistance, Transformation, and Heightened Support (ARP PATHS), will help states describe their strategies and offer examples to other states regarding this funding. The tool includes six sections based on the ARP ESSER state plan, providing the opportunity to describe progress and outline “promising practices” regarding each section. ## CDC updates guidance on wearing face masks for COVID-19 prevention

On Feb. 25, the Centers for Disease Control and Prevention (CDC) updated its guidance on wearing masks and other face coverings for COVID-19 prevention. CDC is no longer requiring universal indoor masking in public settings unless the person has symptoms, a positive COVID-19 test result or exposure to someone with COVID-19. The updated guidance is based on COVID-19 community levels; a map showing the levels is at <http://links.ohioschoolboards.org/15183>. The new CDC guidance is to wear a well-fitting mask indoors in public settings, including K-12 schools, regardless of vaccination status, for counties with a high community level. CDC similarly updated its guidance for school transportation, and no longer requires masks on school buses and vans for schools in areas with a low or medium COVID-19 community level. 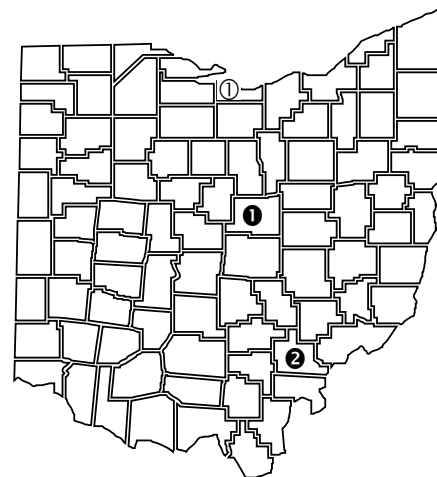

## LEGISLATIVE REPORT

### Conference committee to address property value challenges

Rep. **Derek Merrin** (R-Monclova Township) rose from his desk on the floor of the Ohio House of Representatives during the March 2 session, awaiting the invitation to speak from House Speaker **Robert R. Cupp** (R-Lima). This was a milestone moment for the third-term Republican from Lucas County.

Since 2017, Merrin has tried throughout three legislative sessions to pass bills restricting the ability of school districts and local governments to challenge a county auditor's assessed value of

property. And now, Merrin only needed his colleagues to approve HB 126 one final time to send the bill to Gov. **Mike DeWine** for his signature and for his bill to become law. But as Merrin began to speak, it became apparent this would not happen.

"Mr. Speaker, I rise today to describe the Senate amendments to HB 126," Merrin said.

Veterans of Statehouse politics and parliamentary procedure knew immediately the House would not concur. Customarily, in the first sentence of the floor

speech on a concurrence vote, the bill sponsor urges colleagues to support the concurrence vote, a legislative procedure in which the first chamber effectively approves the changes made by the independent, second chamber.

Instead, Merrin began to describe the Senate's changes and admonished opponents of the legislation. He then voiced his personal conflict, saying, "Myself, and I believe many people in this House, largely agree with many of the changes the Senate has made,

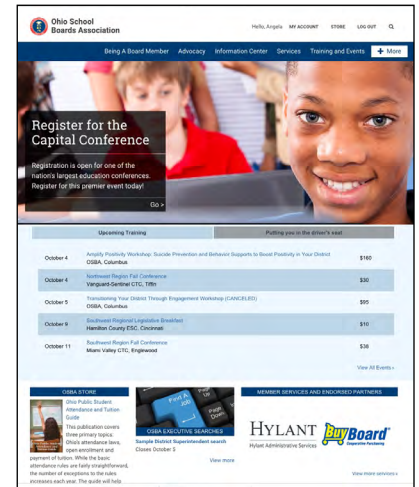

but they are wholesale changes from what my original bill was — what the House voted on. And this is such an important issue. I think it's important we get this right. So, I'm going to urge the House to vote no on concurrence today."

By unanimous vote, the concurrence failed.

What happens next could take several days, weeks or even months, depending on the decisions of House and Senate leadership. Further complicating this timing is the unsettled debate over state and congressional redistricting, the apportionment maps for which are being challenged in court.

Regardless of the timing, the Senate has three choices to respond to the House's nonconcurrence vote. It may recede from its amendments, which effectively sends the House version of the bill to DeWine. It may adhere to its version, which effectively kills the bill. Or, it may insist on its version of the bill — the likely outcome — which prompts the convening of a six-person conference committee. In that case, Cupp and Senate President **Matt Huffman** (R-Lima) will each appoint three lawmakers from their respective chambers to the panel: four Republicans from the majority party and two Democrats from the minority party. The committee's responsibility is to reconcile the differences between the two versions of the bill, but there is no requirement to reach a

compromise; bills can perish in conference committee.

A conference committee typically meets to approve a compromise, not necessarily to receive witness testimony. If House and Senate leadership can broker a deal, the committee votes on a conference committee report, which contains the details of the compromise agreement and is drafted in the form of an amendment. A majority of the committee members from each chamber must approve the report for it to pass. In other words, a report cannot be approved if, for example, all Senate members and one House member support the report. Once approved, the conference committee report returns to both the House and Senate for a vote on whether to accept the report of the conference committee. If both chambers accept the report, the bill heads to DeWine.

Under the Senate-passed version of HB 126, school districts and other local governments would be prohibited from filing initial complaints to challenge a property's valuation. Initial complaints could only be filed by a property owner on property they own. The bill also prohibits complaints from being filed to challenge:

- the tax classification for property as residential/agricultural or commercial/industrial for House Bill 920 tax reduction purposes;
- the tax classification for property as agricultural property eligible for

current agricultural use valuation (CAUV);

- the tax classification for property as nonbusiness property eligible for the state's 10% property tax rollback.

Complaints by property owners and local governments are heard before a county board of revision, including the county auditor, county treasurer and a county commissioner.

According to the nonpartisan Legislative Service Commission (LSC), the effect of HB 126 "will tend to shift tax payment obligations to taxpayers other than those whose taxes could go up as a result of initial complaints by school districts and other nonowners under current law." LSC adds that HB 126 will "tend to result in lower taxable values and tax revenues" for school districts and local governments.

School districts' ability to file counter-complaints will be curtailed under the bill as well. Districts will only be allowed to file countercomplaints that were initially filed by a property owner if all of the following conditions are met:

- the board of education must first adopt a resolution approving the action;
- the resolution must include evidence supporting a higher valuation if the counter-complaint alleges that the property's value should be higher than the county auditor's valuation;
- the board of education must

## Toledo City brings mobile health services to students

A new **Toledo City** initiative will bring free health services to students right outside their school.

The district's mobile health unit will offer vision screenings, physical exams and dental care.

Superintendent Dr. **Romules Durant** told a local TV station that families sometimes have a hard time getting access to proper health services.

All medical care will be provided for free thanks to a \$500,000 donation from the

Landman-Goldman Foundation and a partnership with Health Partners of Western Ohio.

"Many times, we find parents have a difficult time," Durant said. "We have many kids who are being raised by their grandparents who no longer drive. Because of that, we're able to provide this type of care consistently that really makes a difference."

The district will identify which students could benefit from having dental care, then their parents or

guardians will be notified.

Health and Nutrition Coordinator **Nicole Hancock** said many students have significant dental needs that impact their ability to learn.

"With our early childhood kids, they can't always express what is happening and that they're in pain, and it translates into them not being able to focus, not listening, acting out because they can't even eat," she said.

adopt a single resolution for each counter-complaint, with a separate vote occurring on each such resolution;

- the board of education must certify each resolution to the county board of revision.

LSC estimates that this provision will "tend to increase costs of school boards for such filings."

The bill prohibits boards of education from appealing a decision of a county board of revision if it decides against the school board's counter-complaint. Ordinarily, such an appeal would be filed with the Ohio Board of Tax Appeals.

The bill also prohibits districts from entering into a private payment agreement with an individual who has filed a property tax complaint. Such an agreement is one in which the property owner agrees to make one or more payments to the district in exchange for the district dismissing a counter-complaint, refraining from filing a countercomplaint or settling a claim. Finally, the bill would apply to any complaint or counter-complaint filed for tax year 2022 or thereafter.

HB 126 received five hearings in the Senate Ways and Means Committee, chaired by Sen. **Louis**

**W. Blessing III** (R-Colerain Township). Instead of producing a previously approved compromise proposal by the Senate from the last legislative session — House Bill 75 of the 133rd General Assembly — the committee proposed revising the bill to outright prohibit all complaints and counter-complaints. After consideration, the committee maintained its desire to prohibit initial complaints by local governments and allow countercomplaints with new guardrails.
