



# LEGISLATIVE REPORT

## Republicans pass bill limiting property valuation challenges

Republicans fulfilled their years-long quest to weaken the ability of school districts and local governments to challenge property values and ensure those values in their communities are fair and accurate.

House Bill (HB) 126 cleared the General Assembly on April 6 after years of failed attempts from current and former lawmakers, including HB 126 sponsor Rep. **Derek Merrin** (R-Monclova Township), who has sponsored the legislation three separate times. Gov. **Mike DeWine** was still reviewing the legislation as of April 17.

In Ohio, the fair market value of real property, both residential and commercial, is determined by county auditors through an appraisal process that occurs every six years. It's called the sexennial appraisal. Updates to property values occur in the third year after the initial appraisal, referred to as the triennial update. A subset of Ohio's counties is reappraised each year.

The board of revision (BOR), which is a three-member, quasi-judicial public body, exists to hear complaints on those values and to determine the fair market value. Each county has a BOR, which is composed of the county auditor,

county treasurer and president of the board of county commissioners, or their designee.

The debate on HB 126 closed when the House and Senate agreed in March to convene a conference committee to reconcile the differences between the House and Senate versions of the bill. House Speaker **Robert R. Cupp** (R-Lima) appointed the following individuals to serve on the six-person committee: Reps. **Merrin**, **Jason Stephens** (R-Kitts Hill) and **Beth Liston** (D-Dublin). Meanwhile, Senate President **Matt Huffman** (R-Lima) appointed Sens. **Louis W. Blessing III** (R-Colerain Township), **Kristina D. Roegner** (R-Hudson) and **Sandra R. Williams** (D-Cleveland).

The conference committee met on April 6. Stephens, a former Lawrence County auditor, introduced an amendment containing the compromise between House and Senate leadership. The amendment was approved by the committee on a party-line 4-2 vote. After discussing the amendment and a failed attempt by Democrats to further revise the bill, the committee passed the conference committee report, again by a party-line 4-2 vote.

Later that day, the Ohio House

and Senate met to consider the conference committee report, among other legislation. The House approved the report by a 61-35 vote, with Rep. **Adam C. Bird** (R-New Richmond) as the lone Republican voting in opposition. The Senate approved the report by a 24-8 vote along party lines.

Under the enrolled version of HB 126, school districts and other local governments will be prohibited from challenging county auditors' assessed values of residential and agricultural properties. Challenges on commercial properties will be allowed to continue but with strict limitations.

Beginning in tax year 2022, schools and local governments can only file challenges on commercial properties that were sold in the year prior to the tax year for which the complaint was filed and the sale price was at least 10% and \$500,000 more than the auditor's value. The \$500,000 value will be increased with inflation beginning in tax year 2023.

Analysis by the nonpartisan Legislative Service Commission (LSC) indicates that these restrictions "will tend to result in lower taxable values and tax revenues than under current law."

LSC further explained that these changes will result in higher effective tax rates, a decline in tax revenues from inside millage and a tendency to “shift tax payment obligations to taxpayers other than those whose taxes could go up as a result of complaints by school districts and other non-owners under current law.”

The bill also requires boards of education to adopt a resolution authorizing the filing of commercial complaints at a public meeting.

The resolution must include the following:

- the basis for the complaint relative to each parcel, which could include a challenge of the property’s value or the property’s tax classification;
- the tax year for which the complaint will be filed;
- identification of the parcel or parcels subject to the complaint by street address and permanent parcel number;

- the name of at least one of the record owners of the parcel or parcels.

No resolution may identify more than one parcel unless it has the same record owner. Boards of education can adopt multiple resolutions containing complaints by a single vote, provided the vote is separate from the question of whether to adopt other non-valuation resolutions. This likely means these resolutions cannot appear in a consent agenda, which is a tool for boards to group multiple items together for approval via a single vote.

Prior to adopting a resolution authorizing the complaint, the board of education must mail a written notice to at least one of the record owners of the parcel or parcels identified in the resolution, stating the following:

- that the board of education intends to adopt the resolution challenging the value, the tax

classification of the property, among other items;


- the proposed date of the board of education meeting;
- the basis for the board of education’s complaint relative to each parcel identified in the resolution.

The notice must be sent at least seven calendar days prior to adopting the resolution and must be delivered by certified mail or, if certain records exist, by regular mail to the applicable property owner.

BORs are restricted under HB 126 from considering complaints filed by boards of education only if a board of education notifies the BOR with a complaint form that acknowledges the board of education authorized the complaint in accordance with the above requirements and notice was sent prior to adoption of the resolution.

HB 126 also modifies the

## Owls deliver project-based learning to Coshocton students

Ohio's smallest and largest owl species visited **Coshocton City's** Coshocton Elementary School, where students were working on a unit on using owl pellets to determine what the animals ate.

The lesson was for fourth-graders in teacher **Tami Jaynes'** class, along with talented and gifted students in kindergarten through fourth grade. Students dissected the owl's excrement to look for undigested bones, then pieced the bones together to form skeletons to get an

idea of what the owls last ate.

**Shane and Angie Pyle**, who operate Airmid Place and are licensed by the state to rescue and rehabilitate injured wild animals, brought a screech owl and great horned owl to class and explained how owls hunt and process food. Students also got to see a baby rabbit and squirrel.

Coshocton Elementary School has a focus on project-based learning with hands-on activities and a drive to share projects with

the community. Recently, community members served as a jury for a mock trial by a fifth-grade class. Talented and gifted instructor **Barbara Breen** said that sharing what the students learned with local experts was an important component of the lesson.

"Being able to show the skeletons the kids made to actual members of the community, who understand this, was just phenomenal," Breen said.

counter-complaint process under which boards of education counter-challenge complaints filed by property owners who often allege reductions in their valuation. Currently, boards of education may file counter-complaints if the property owner's initial complaint alleges a change of more than \$50,000 in fair market value. Such a counter-complaint must be filed within 30 days of the initial complaint's filing. The bill maintains this ability to file counter-complaints but repeals a requirement for county auditors to notify boards of education within 30 days when an initial complaint is filed. The 30-day deadline for

filing counter-complaints is maintained under the bill.

The conference committee included a provision in its changes that did not appear in either the House or Senate version of the legislation. This provision requires a BOR to dismiss a complaint if the BOR has not rendered a decision on the complaint within one year of the complaint's filing. Continuing law already requires decisions to be rendered by a BOR within 180 days.

Private payment agreements between boards of education and property owners are now prohibited under HB 126. This prohibition extends to agreements between parties to refrain from

filing complaints or counter-complaints, dismissing complaints and resolving claims by a settlement agreement that includes monetary payments. This restriction applies to any agreement entered on or after the effective date of the bill.

HB 126 also would repeal the authority for boards of education and other local governments to appeal the BOR decision to the Ohio Board of Tax Appeals. LSC reports that this "prohibition may tend to result in lower taxable values and tax revenues."
