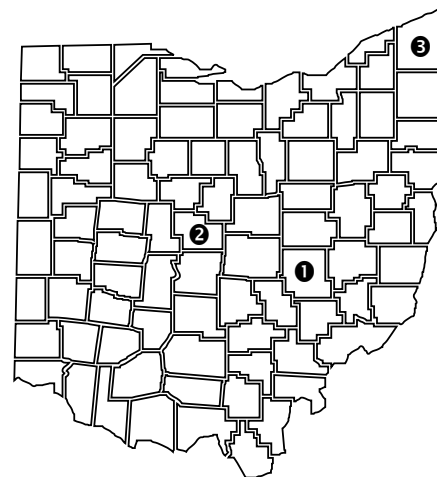

The Federal Motor Carrier Safety Administration (FMCSA) Drug and Alcohol Clearinghouse that began in January 2020 has a requirement that all employees perform a limited query (testing history background check) on their commercial driver's license (CDL) drivers before Jan. 6, 2021. This session is designed to educate administrators who are unfamiliar or as a refresher course for those who manage the FMCSA Department of Transportation drug and alcohol testing requirements.

This training session covers the following topics:

- Clearinghouse basics registering-to-reporting
- Registering as an employer
- Purchasing queries
- Identifying when CDL holders need to register
- Obtaining driver consent for limited or full queries
- Illustrating the electronic consent process for a full query for a CDL holder

Workshop dates and descriptions

Feb. 3 — The transportation handbook (virtual or in-person)

Transportation administrators cannot afford to “fly by the seat of their pants” or to be inconsistent in management practices. Guidelines and procedures are essential and can be the manager’s best friend. Other issues that are related include board policy, administrative guidelines, labor agreements and other local resources. We will discuss the handbook development process as well as what to include in the handbook and how to keep it current.

March 3 — Public relations and working with the media (virtual or in-person)

We will have two related focus points for this session. First, we will experience a live interview process to refine our skills in developing talking points and staying on target in an interview about a real event. Second, after focusing on reactive news responses, we will shift focus to proactive news relationships to inform your community about the resources your transportation department offers.

April 7 — Designing your operational plan and building keys for success (virtual or in-person)

We will start this final class of the year by looking at how to put the operational plan together. What is your work calendar? When do you need to do what, and how do you schedule or delegate that project? Much of what we do has a critical work path, and unless you plan your work in advance it is easy to get “behind the curve” and feel like you are trying to catch up. After that, we will focus on building support networks, identifying friends and foes and how to recognize where you need allies to succeed. Building your stakeholders’ group and support network is key to your success and helps broaden your potential for positive impact.

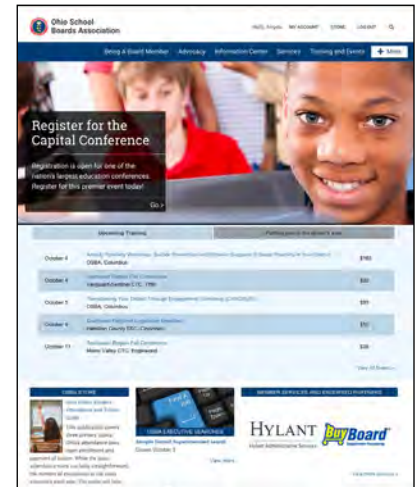

Changes to eligibility for EdChoice voucher program in lame-duck session

In November, Gov. **Mike DeWine** signed Senate Bill (SB) 89, a bill that changes the student eligibility criteria for the Educational Choice Scholarship Program (EdChoice). The new criteria, which were amended in

the bill during a conference committee, requires two factors for a student to be eligible. First, the school building must be in the lowest 20% of buildings based upon the Performance Index rankings for the 2017-18 and 2018-

19 school years. Second, the school building is operated by a school district that has an enrollment of at least 20% Title I-eligible students.

Based upon those two factors, the number of eligible school

buildings for performance-based vouchers for the 2021-22 school year would be 473. This is a reduction from the 1,227 school building eligibility list for fiscal year 2021. The bill also increases the poverty threshold from 200% to 250% for the income-based voucher program eligibility. OSBA joined with the Ohio Association of School Business Officials and the Buckeye Association of School Administrators to express concerns with the legislation, available at <http://links.ohioschoolboards.org/76425>. House passes Fair School Funding Plan to House floor

On Dec. 3, the Ohio House passed House Bill (HB) 305, the Fair School Funding Plan, by a vote of 87-9. The bill creates a new school-funding formula. The House Finance Committee amended the bill on Dec. 1 to make several changes, including transportation modifications and revamping the makeup of the School Funding Oversight Commission to now include three school board members. Senate committee passes bill providing additional flexibility to school districts

The Senate Education Committee

finalized its work on SB 358, a bill that provides school districts flexibility and relief into the 2020-21 school year amid the COVID-19 pandemic. Those flexibilities pertain to graduation requirements, third-grade reading guarantee mandates, an exemption from administering state assessments and the prohibition of the Ohio Department of Education from issuing report card grades. The bill also extends a safe harbor from sanctions and penalties from report card grades and provides a process for a school to transition out of academic distress commission control. Open meeting flexibility extended before deadline expires

DeWine signed HB 404, which will extend the ability of public bodies, including boards of education, to hold and attend meetings or hearings via electronic technology. The bill was signed with an emergency clause that went into effect immediately upon DeWine's signature on Nov. 23. The language in HB 197 that originally provided this flexibility was set to expire on Dec. 1, 2020. The new deadline provided in HB 404 extends this flexibility to July 1, 2021.

The bill also includes education provisions such as an exemption for districts from penalties for not administering to a student the fall administration of any diagnostic

assessment, kindergarten readiness assessment or third-grade English language arts assessment if certain conditions are met. It also provides flexibility and exemptions regarding state-required health screenings for kindergarten and first-grade students. Finally, for the 2020-21 school year, it prohibits the use of student growth measures in evaluations, allows a board of education to determine if evaluations are impossible or impracticable and extends license and certificate deadlines to July 1, 2021. Recently introduced legislation

● HB 789, introduced by Rep. Joseph A. Miller III (D-Amherst), to extend the temporary authority for public bodies, including boards of education, to meet via electronic technology until June 30, 2021.

● HB 790, introduced by Rep. Ron Hood (R-Ashville), to require the State Board of Education to conduct an annual audit of school districts compliance with venereal disease instruction requirements; allows a parent or guardian to bring civil action to a school district for noncompliance; and requires notification and written permission from a parent or guardian to provide additional instruction in venereal disease or sexual education that is not specified in current law.

JVSD students assist with elementary school renovations

Students at **Jefferson County Vocational School (JVS)** are using their talents as part of the \$10 million plan to renovate an area elementary school.

About 30 students in the vocational school's auto collision, welding and carpentry classes are restoring shelves and constructing a waterwheel for upgrades at **Indian Creek Local's (Jefferson) Hills Elementary School**. The shelves were recently removed from Wintersville Elementary

School in the district.

The connection was made through an idea by **Todd Rainsberg**, senior project manager with Canton-based Sol-Harris/Day. The project not only involves local students but also helps keep the upgrades within budget, Indian Creek Local Assistant Superintendent **John Belt** told a local newspaper.

"We're really excited to work in collaboration with the JVS on the Hills renovation," Belt said. "We

believe it expands the overall sense of community for our area, and we plan on putting a plaque in the Hills building, recognizing the JVS students who contributed to this project."

Carpentry students are creating the wooden waterwheel to incorporate into the design. Both projects should be finished by the end of the school year, with installation set for this summer, Rainsberg said.

- HB 791, introduced by Reps. **Al Cutrona** (R-Canfield) and **Timothy E. Ginter** (R-Salem), to extend the temporary authority for public bodies, including boards of education, to hold and attend meetings or hearings via electronic technology during the period of the current state health emergency.
- HB 793, introduced by Rep. **Michael Sheehy** (D-Toledo), to extend certain state license deadlines and allow licenses to remain valid until Dec. 1, 2021.
- SB 376, introduced by Sens. **Vernon Sykes** (D-Akron) and **Peggy Lehner** (R-Kettering), to create a new school-funding formula.

- SB 384, introduced by Sen. **Bob D. Hackett** (R-London), to amend compensation, medical benefits and disability retirement for peace officers, among others, diagnosed with post-traumatic stress disorder arising from employment without an accompanying physical injury.

These written reviews serve as a critique of current contract provisions, suggest potential pitfalls regarding legal compliance and provide specific recommendations as you go into your next round of collective bargaining.
