ODE unveils cybersecurity resources website for school districts

The Ohio Department of Education (ODE) Cyber Security Steering Committee has launched a webpage dedicated to supporting school districts and all members of the Ohio Education Computer Network (OECN) with cybersecurity resources. The site was developed by a number of statewide agencies and Ohio school districts. It is designed to improve the information security posture of all school districts in Ohio by providing information and resources to develop security programs addressing five major components: identify, protect, detect, respond and recover. The website also provides information from the Center for Internet Security, which includes real-time news, advisories and security tips to help understand and mitigate current threats. The OSBA Capital Conference App continues to be a valuable tool for conference attendees, with nearly 3,000 users this year. Although conference attendance was lower in 2021 compared to the last in-person event in 2019, the engagement with the app was higher in most areas. There was a 40% increase in users creating an account in the app; a 13% increase in attendees creating personalized schedules; a 35% increase in the number of attendees who used the app to check in to sessions to record their credits for certificates of attendance: and a 33% increase of those completing some of their certificate of attendance information through the app.





LEGISLATIVE REPORT

Bill would ban districts from initiating valuation challenges

As of this writing, House Bill (HB) 126, sponsored by Rep. Derek Merrin (R-Monclova), was one vote away from reaching the desk of Gov. Mike DeWine. After two failed efforts, Merrin, who chairs the House Ways and Means Committee, may soon be able to claim victory in curtailing school districts' and other local governments' ability to ensure accurate property values in their communities. This time, however, the credit appears to be due Senate President Matt Huffman (R-Lima), who led the charge to further restrict the process, more than any proposal ever offered by Merrin.

Under HB 126, school districts and other local governments would be prohibited from filing initial complaints to challenge a property's valuation. Initial complaints could only be filed by a property owner on property they own. The bill also prohibits

complaints from being filed to challenge:

- the tax classification for property as residential/agricultural or commercial/industrial for House Bill 920 tax reduction purposes;
- the tax classification for property as agricultural property eligible for current agricultural use valuation (CAUV);
- the tax classification for property as nonbusiness property eligible for the state's 10% property tax rollback.

Complaints by property owners and local governments are heard before a county board of revision, which is chaired by the county auditor, county treasurer and a county commissioner.

According to the nonpartisan Legislative Service Commission (LSC), the effect of HB 126 "will tend to shift tax payment obligations to taxpayers other than those whose taxes could go up as a result of initial complaints by school districts and other nonowners under current law." LSC adds that HB 126 will "tend to result in lower taxable values and tax revenues" for school districts and local governments.

School districts' ability to file counter-complaints will be curtailed under the bill as well. Districts will only be allowed to file counter-complaints that were initially filed by a property owner if all of the following conditions are met:

- the board of education must first adopt a resolution approving the action;
- the resolution must include evidence supporting a higher valuation if the counter-complaint alleges that the property's value should be higher than the county auditor's valuation;
- the board of education must adopt a single resolution for each

Pioneer CTC students refurbish jungle gym for local park

Students at **Pioneer Career & Technology Center** (CTC) in
Shelby have helped save a piece of nostalgia at a local park.

A jungle gym shaped like a steam locomotive had entertained children for years in Crestline's Kelly Park, but time had produced rust and ruin, including the rotted wooden seat of the train.

Welding students spent hours giving the train new life and making it a focal point of the park.

"It was a good project,"

instructor **Kip Stevens** told a local newspaper. "We like to have community service projects."

The students sanded the train down, then welded the troubled areas. They quickly learned the smokestack was too rusted to salvage, so they put in an order to have a new one fabricated.

Finally, students primed the train and painted it. The final step was to get a set of decals to add to the train before it is taken back to Crestline.

Pioneer students work on freelance welding projects every school year. Without them, they would have no way of getting realworld experience in their future trade, according to Stevens.

Recently, they refabricated a football sled, cutting it apart and then welding it back together. Students will present the completed jungle gym to Crestline officials in May with a ceremony and ribbon-cutting.

counter-complaint, with a separate vote occurring on each such resolution;

• the board of education must certify each resolution to the county board of revision.

LSC estimates that this provision will "tend to increase costs of school boards for such filings."

The bill also prohibits boards of education from appealing a decision of a county board of revision if it decides against the school board's counter-complaint. Ordinarily, such an appeal would be filed with the Ohio Board of Tax Appeals.

The bill also prohibits districts from entering into a private

payment agreement with an individual who has filed a property tax complaint. Such an agreement is one in which the property owner agrees to make one or more payments to the district in exchange for the district dismissing a counter-complaint, refraining from filing a counter-complaint or settling a claim. Finally, the bill would apply to any complaint or counter-complaint filed for tax year 2022 or thereafter.

HB 126 received five hearings in the Senate Ways and Means Committee, chaired by Sen. **Louis W. Blessing III** (R-Colerain Township). Instead of producing a previously approved compromise proposal by the Senate from the last legislative session — House Bill 75 of the 133rd General Assembly — the committee proposed revising the bill to outright prohibit all complaints and counter-complaints. After consideration, the committee maintained its desire to prohibit initial complaints by local governments and allow countercomplaints with new guardrails.

HB 126 awaits a concurrence vote in the Ohio House of Representatives. Should that occur, the bill will advance to DeWine for his signature.
