The Ohio Department of Education announced that the fall end-ofcourse test window has been extended by one week to provide more time for testing in January. It now runs from Nov. 30, 2020, to Jan. 15, 2021. Districts must administer the exams within 15 consecutive school days, including makeups. 

## OSBA trustees approve association 2021 budget, resolution to honor education advocate

During its final meeting of the year, the OSBA Board of Trustees approved the association's preliminary 2021 budget as well as a resolution honoring Dr. **R. Kirk Hamilton**, executive director of Buckeye Association of School Administrators (BASA), and heard updates on the association's 2020 activities.

The trustees met virtually on Nov. 21. OSBA President **Lee Schreiner, South-Western City**, led the meeting, expressing his appreciation for all that the association has done this year. "I'm so proud of what we've done in a different world," he said.

Chief Financial Officer Allison Morris provided an update on the association's finances. She also presented the association's preliminary 2021 budget, which was approved by the trustees. OSBA Audit Committee Chair Susie Lawson, Tri-County ESC and Wayne County Schools Career Center, updated trustees on OSBA's completed 2019 financial audit.

The trustees also approved a resolution for Hamilton, who is retiring Dec. 31 after nearly 40

years of service in public education. He has served as BASA's executive director for 10 years and previously served as superintendent for South-Western City and **Batavia Local (Clermont)**, among other positions.

Later in the meeting, BASA Deputy Executive Director **David Axner** and Ohio Association of School Business Officials (OASBO) Executive Director **Jim Rowan** briefed trustees on the activities of their respective associations, which frequently collaborate with OSBA. *Continued on page 5*

Although each association works distinctly, Axner, Rowan and OSBA Chief Executive Officer **Rick Lewis** pointed out how effective the three organizations and their members are when they work together.

"OSBA, BASA and OASBO have a long tradition of working together on legislative issues and other partnerships, including endorsed programs that will benefit Ohio's school districts," Lewis said. "We appreciate the value each association and its members bring to the table in our discussions, and look forward to continued partnerships."

OSBA Deputy Executive Director Dr. **Kathy McFarland** highlighted several projects completed in 2020 that contributed to the Visionary Initiative for Strategic Action (VISA), OSBA's strategic plan. Currently, the association is in year three of its five-year strategic plan, and 20 of the 30 of the strategies outlined have been completed.

In light of the change in business activities the association faced due to the COVID-19 pandemic, the OSBA directors provided a review of the association's 2020 activities, outlining the continuity of business as well as the new activities staff initiated to support members.

OSBA Director of Communication Services Jeff Chambers and Director of Board and Management Services Cheryl W. Ryan provided a summary of the virtual 2020 OSBA Capital Conference. The conference featured more than 60 learning sessions and four Spotlight Sessions; two General Sessions and a Monday Town Hall, each with a keynote speaker; a Trade Show with more than 150 booths: and a Student Achievement Fair and Student Performing Arts. More than 2,800 people attended the conference, representing 372 OSBA-member districts.

"We're proud of our first virtual conference," Chambers said. "We were able to continue to provide our members with cost-effective professional development, networking opportunities and access to companies offering products and services to help their districts run efficiently."

Director of Legislative Services Jennifer Hogue reviewed recently passed legislation, including House Bill (HB) 404, which includes COVID-19-related education items; HB 123, which requires schools to implement certain programs on and provide instruction in suicide awareness and prevention and violence prevention; and Senate Bill (SB) 89, which changes the eligibility criteria for the Educational Choice Scholarship Program (EdChoice) and expands the number of eligible school buildings for performance-based vouchers to 473 for the 2021-22 school year. The bill also increases the poverty threshold from 200% to 250% for the income-based voucher program eligibility.

Hogue told trustees that the House and Senate finance committees were holding hearings on HB 305 and SB 376, respectively, which address the Fair School Funding Plan. The goal, she said, is to get the plan passed and enacted during this General Assembly so it can serve as framework for the next biennial budget.

"We need you to discuss this plan with your board members, community and neighboring board members," said Hogue. "This funding plan answers the charges from the *DeRolph* court cases and takes into account equity, which we need desperately."

In other business:

• Ryan reviewed the 2020 board self-assessment survey, which is the board's assessment of its work.

• President-elect **Scott E. Huddle**, **Mad River Local (Montgomery)**, gave a report on the activities of OSBA's Legislative Platform Committee.

• Chief Legal Counsel **Sara C**. **Clark** provided an update on the work of the OSBA Governance Review Committee. Recommendations will be presented to the trustees next year.

• Trustees approved an update to eligibility for OSBA products and services to allow agents or representatives of a member district to attend and directly pay for an OSBA workshop if approved in writing by the district prior to the workshop.

• OSBA Past President John W. Halkias, Plain Local (Stark), who serves on the National School Boards Association's Board of Directors, provided an update on the association's activities.

The next OSBA Board of Trustees meeting is Feb. 27.

## LEGISLATIVE REPORT

#### Education bills signed, pending as lame-duck session nears end

The Ohio House of Representatives and Senate worked late into the night on Dec. 17 as lawmakers hoped to conclude their legislative work, adjourn sine die and head home early to enjoy the Christmas holiday. However, a bevy of unfinished business, including farewell speeches, overrides of governor vetoes and reduced attendance due to coronavirus illnesses. forced lawmakers to schedule additional session days to wrap up the 133rd General Assembly. Leading up to the lame-duck session, lawmakers sent many bills to Gov. Mike **DeWine** for his signature, several of which he signed.

Senate Bill (SB) 89 was signed into law on Nov. 27 and substantially revises the Educational Choice (EdChoice) Scholarship Program. It revises student eligibility for the program's performance-based option and increases the poverty threshold from 200% to 250% for the program's income-based option. Eligibility for performancebased vouchers applies if at least 20% of a student's school district is composed of Title I-eligible students for the three most recent years and the student's building was ranked in the lowest 20% of buildings according to the

Performance Index rankings for the 2017-18 and 2018-19 school years. SB 89 would designate 473 buildings as EdChoice eligible, 110 of which most recently received an A, B or C grade on their state report card. Forty-three buildings that had never before been on the list were added to it.

DeWine signed House Bill (HB) 404 on Nov. 23, which was amended late in the legislative process to include certain pandemic-related flexibility and relief measures from SB 358. Those provisions include permitting boards of education and other public bodies to hold and conduct their meetings electronically through July 1, 2021, and exempting districts from penalties for not administering the fall administration of any diagnostic assessment, kindergarten readiness assessment or third-grade English language arts assessment if a student is quarantined, medically compromised, remote learning or subject to a stay-at-home order. The act also extends the temporary teacher and administrator evaluation flexibilities to the 2020-21 school year and provides flexibility and exemptions regarding routine, state-required health screenings for kindergarten and first-grade students that must

normally be completed annually by Nov. 1.

Awaiting DeWine's signature are HB 123, HB 450 and HB 231. HB 123 requires public schools to implement certain programs on and provide instruction in suicide awareness and prevention and violence prevention and provides \$2.5 million in payments to dropout prevention and recovery e-schools that meet certain standards. HB 450 requires certificates of transition for outgoing school treasurers, among other similar local government officers, that must include a prescribed inventory of documents, accounts, books, maps and other information. Finally, HB 231 requires the Ohio Department of Education (ODE) to annually compile a list of entities that offer free and reduced-cost epinephrine autoinjectors and make that list available to school districts and others. It also allows districts to create and implement training for staff and students on food allergies and permits them to procure and administer glucagon without a license for use in emergency situations for individuals with diabetes.

The following education-related bills are in the final stages of the legislative process, needing either *Continued on page 8*

one or two votes to send them to the governor:

• HB 409, which added provisions of SB 358, including prohibiting the issuing of the state report card for the 2020-21 school year, implementing an accompanying safe harbor, exempting districts from retaining a student under the third-grade reading guarantee for the 2020-21 school year and authorizing the superintendent of public instruction to temporarily adjust certain deadlines, including the filling of a vacancy on a board of education. A House concurrence vote will send the bill to DeWine. • SB 310, which contains the capital appropriations bill provisions, including appropriating \$385 million in debt-financed spending for the Ohio Facilities Construction Commission. The bill also temporarily adjusts the starting application date for the EdChoice Scholarship program to March 2, 2021, appropriates \$3 million to fund required studies on components of the school-funding formula and authorizes the redistribution of any unused Student Wellness and Success

funds, among other changes. A Senate concurrence vote will send the bill to the governor.

 HB 436, which requires districts, by the 2022-23 school year, to administer annual dyslexia screenings and establish a multisensory structured literacy certification process for teachers employed by the district or school providing instruction in grades K-three; and requires all K-three teachers and special education teachers in grades four-12 to complete between six and 18 hours of professional development over a set time frame. A House concurrence vote will send the bill to DeWine.

• SB 68, which requires a state model curriculum for high school students on proper interactions with peace officers during traffic stops and other encounters and requires districts to incorporate this curriculum into at least one course required for high school graduation. A Senate concurrence vote will send the bill to the governor.

• SB 259, which prescribes minimum drinking fountain and water bottle-filling station

requirements for new classroom facility construction projects and requires districts to ensure that each drinking fountain and water bottlefilling station installed as part of a project is regularly cleaned and maintained. A Senate concurrence vote will send the bill to DeWine. • HB 75, which requires school districts, before filing a property tax complaint, to pass a resolution approving the complaint at a public meeting; limits the circumstances under which initial, residential property tax complaints may be filed; and limits countercomplaint filings only when that initial complaint alleges a change in fair market value of \$75,000 or more. Two votes — a Senate vote and House concurrence vote will send the bill to the governor. • SB 212, which provides a full or partial tax exemption to developers and owners of newly constructed homes within specified municipal or township areas during the construction period and for 10 years after the home is occupied. Two votes — a House vote and Senate concurrence

#### River View Local senior's volunteerism is cut above

Zach Balo, a senior at River View Local's (Coshocton) River View High School, always thinks he can do more.

He's been helping his grandparents clear trees from the family farm since the summer, selling the cords of wood and keeping the money.

"I thought maybe I can find a way to incorporate this into my senior project," Balo told a local newspaper.

So, instead of keeping all the

money, Balo kept cutting and offered the firewood for sale to help benefit the Coshocton County Handicapped Society, which advocates for residents with disabilities and provides equipment to those in need.

Balo has sold wood before, but it never went this fast. In less than 12 hours, he sold three cords of wood and raised \$420 for the organization.

**Candy Angle**, president of the handicapped society, described

Balo as a great volunteer.

"He's an amazing young man," she said. "He has a heart of gold. He'll do whatever you need. If he's available, he's there."

vote — will send the bill to DeWine. • HB 210, which requires ODElicensed preschool programs and other entities to screen and test prospective employees for tuberculosis. Two votes — a Senate vote and House concurrence vote — will send the bill to the governor. • HB 425, which exempts the requirement that peace officer basic training be obtained by certain employees whom a board of education authorizes to be armed in a school safety zone. Two votes — a Senate vote and House concurrence vote — will send the bill to DeWine. • HB 38, which provides a reduced property valuation for tax years 2020, 2021 and 2022 for businesses

and eligible individuals as a result of the COVID-19 pandemic. Two votes — a Senate vote and House concurrence vote — will send the bill to the governor.

• SB 95, which requires the tax commissioner's biennial report on state tax expenditures to include information on property tax exemptions, requires a periodic review of each property tax exemption and creates a property tax exemption for certain housing used by individuals diagnosed with mental illness or substance use disorder. Two votes — a House vote and Senate concurrence vote — will send the bill to DeWine

Despite the fury of activity as the

legislative session nears its end, HB 305, the much-discussed schoolfunding proposal jointly sponsored by House Speaker Robert R. Cupp (R-Lima) and John Patterson (D-Jefferson) failed to gain approval in the Senate. Although the House voted Dec. 3 to approve the measure by an overwhelming 87-9 margin, top legislators in the upper chamber, including Sens. Matt Huffman (R-Lima) and Matt Dolan (R-Chagrin Falls), stressed their desire to consider the proposal during the state's upcoming budget process.
