The Community

Norwayne Local School District is a school district serving portions of north central Wayne County and a small portion of southern Medina County. The Norwayne Local School District campus is located in the village of Creston, a rural community 15 miles north of Wooster where life is safe and relaxed. The district is known for being a close knit, faith-based community that is very family oriented.

Formerly North Central Local, the district was consolidated in 1949 when the communities of Burbank, Creston and Sterling combined to provide improved educational opportunities for its young people. The school climate is reflective of a very caring community that supports both the schools and school programs by voting for needed revenue when called upon to do so, and by its volunteerism in the schools. The district has an active community that supports and raises funds to help meet the needs of various educational and student activity programs.

Wayne County has direct access to major interstate highways affording easy access to cultural activities, sporting events, shopping, and several state and private colleges and universities. The County has access to urban areas such as: Wooster, Cleveland, Akron, Canton, Ashland and Mansfield.

The District

Thanks to voter approval of funding in 2006, Norwayne Local was able to construct a new elementary school and high school, and to renovate the old high school into a middle school in partnership with the Ohio Schools Facilities Commission. This allowed the elementary, middle school and high school to be consolidated onto a centralized campus within the district with all schools opened by 2011.

In 2019, the Norwayne Middle School was awarded the distinction of "National Blue Ribbon Schools," one of 14 in the state of Ohio. Also in 2019, the school report card from the Ohio Department of Education ranked Norwayne Local School District as one of the overall top performing districts in Wayne County. This was accomplished while maintaining one of the lowest cost per student amounts for education in the state of Ohio. Strong family values throughout the community, work ethic from the students, dedicated teachers and staff, and diligence from present and past administrations have all contributed to this achievement.

Norwayne also continues to be successful in extracurricular activities including sports, FFA, and performing arts, and has been awarded the "Best Community For Music Education," award, one of only 47 districts in the state of Ohio.
