### 2. **Budget and Appropriations Wrap-Up**

Last week, the House was in recess while the Senate was in Washington. Most of the news from the Nation’s Capital was speculation around this week’s expected meeting between House GOP leadership and the White House to discuss how to address the country’s debt ceiling and Republican demands for spending cuts. House Speaker Kevin McCarthy (R-CA) will meet with President Joe Biden on Tuesday, May 9. The meeting will end a three-month stall in negotiations and comes just three weeks before the country is projected to run out of money to pay its bills, according to Treasury Secretary Janet Yellen. President Biden invited the Speaker and his colleagues in leadership from both parties and chambers: House Minority Leader Hakeem Jeffries (D-NY); Senate Majority Leader Chuck Schumer (D-NY); and Senate Minority Leader Mitch McConnell (R-KY). All eyes and ears will be on that meeting and what Congress might do before the end of the month.

Meanwhile, House Appropriations Committee Chairwoman Kay Granger (R-TX) told her committee members the dates they will mark up FY 2024 spending bills, without listing the bills that would be marked up on each date. There will be subcommittee markups on May 17 and 18, with full committee action following on May 23, 24, and 25. In June, there will be subcommittee markups of remaining bills on the 7<sup>th</sup> and 8<sup>th</sup>, with full committee action coming on June 13, 14, and 15. The Labor, Health and Human Services and Education spending bill will almost certainly be subject to June action, assuming it is marked up at all.

When the House returns tomorrow, the House Education and the Workforce Committee Subcommittee on Higher Education and Workforce Development will hold [a hearing](#) titled, “Examining America’s Workforce Challenges: Looking for Ways to Improve Skills Development.” The hearing signals Committee Chairwoman Virginia Foxx’s (R-NC) intention to pursue updating the Workforce Innovation and Opportunity Act this year. She and her colleague, Ranking Member Bobby Scott (D-VA) reportedly are trying for a bipartisan approach to the rewrite.

### **How does this impact State School Board Associations?**

While Chairwoman Granger provided a schedule for action, she hasn’t shared when subcommittee leaders might know how much money they have to allocate to the agencies and programs under their purview. Even so, it is presumed that the discretionary total for all the bills will be the \$1.471 trillion level set in the [debt ceiling and spending cut bill](#) House Republicans passed last week. The cut to most non-defense funding, including money dispersed by the Department of Education, would be 22%. House Labor, Health and Human Services and Education Appropriations Subcommittee Chairman Robert Aderholt (R-AL) commented directly on the bill that will fund the Department of Education, reportedly saying there is “speculation that there could be a double-digit cut,” yet details of such cuts are unknown.

### **3. In Brief – Last Week in Washington**

#### **EIGHTH-GRADERS’ UNDERTSANDING OF US HISTORY, CIVICS WORSENING**

On Wednesday, May 3, the National Center for Education Statistics (NCES) released results from the spring 2022 National Assessment of Educational Progress (NAEP) exams measuring student academic performance in 4<sup>th</sup> and 8<sup>th</sup> grade in the subjects of history and civics. Overall, knowledge of civics among the nation's eighth graders fell for the first time since the federal government began testing children under the current framework in 1998. The average scores in history also show a five-point drop. For context, average history marks have fallen for nearly a decade with scores dropping nine points since 2014. Performance is now back to the 1994 score level when the exam was first distributed in its current form. In civics, the two-point downturn puts the average score in 2022 at the same level as 1998 (150 out of a possible 300). For both history and civics, there were widespread declines in scores across most races and ethnicities, and lower-performing students had larger score declines than higher-performing students. In history, students who scored in the bottom tenth percentile had a seven-point drop between 2018 and 2022 and students in the ninetieth percentile had no significant score drop at all. “The latest data from the National Assessment of Educational Progress further affirms the profound impact the pandemic had on student learning in subjects beyond math and reading,” Secretary of Education Miguel Cardona said in a [statement](#), also pointing to the math and reading NAEP scores published last fall. Peggy Carr, Commissioner, NCES [pointed](#) to the lack of dedicated classroom time spent on these subjects. “Teachers, practitioners need to get this content in front of students. When you look at what they don't know, and it's not just about reading, it's about content, facts, information about our constitutional system. Students don't know this information,” Carr said. “That is why they're scoring so low on this assessment.” The results can be viewed [here](#).
