HB 51

- HB 51 is nearly identical to the language that appeared in HB 197 and HB 404.
- HB 51 was passed by the General Assembly with an emergency clause, meaning the effective date was February 17, 2022.



HB 51

- School board members may hold and attend meetings and may conduct and attend hearings by means of teleconference, video conference or any other similar electronic technology.
- Expires June 30, 2022.

- Must provide notification of their virtual meetings and hearings to the public, to the media that have requested notification, and to the parties required to be notified of a hearing.
- Must provide the public with access to their virtual meetings

Ohio laws set forth a number of ethical standards for most public officials, including school board members, school district employees and members of school district financial planning and supervision commissions. There are three primary sources of ethical standards that apply to school officials. Ohio Revised Code (RC) Chapter 102 is the Ohio Ethics Law that applies to all public officials. A second source is criminal statutes, such as RC 2921.42 and 2921.43, which are also of general applicability. Finally, there are two statutes, RC 3319.21 and 3313.33 that apply specifically to school board members.

Boards of education are not required to allow public participation, but most boards do.

- If they allow it, boards of education may regulate the time, place, and manner of public participation.
- The board cannot regulate the identity of speakers or the content of speech.
- Many boards use their minutes to list the names of those who spoke during public participation and the nature of their comments.



Examples of common time, place and manner restrictions:

- When members of the public will be allowed to address the board in the meeting
- Regulating the time period for comments
- Requiring public speakers to sign up before speaking
- Requiring comments be confined to agenda items



Be cautious of the following restrictions:

- Negative viewpoints about school district business (viewpoint)
- Mentioning names of employees or board members (content)
- Restricting certain speakers with a track record (identity)
- OSBA has a sample public participation policy (KD/BDDH)
