Doug Ute, executive director of the Ohio High School Athletic Association will be the keynote speaker at the March 9 Central Region Spring Conference. Ute is no stranger to the region as a former superintendent in **Elgin Local (Marion)** and **Newark City** Schools. Throughout his career, his focus has always been on helping students become better people.



At Newark, Ute helped create the Social, Emotional and Academic Success (SEAS) program that included counselors, teachers and staff to discuss ways to help students succeed in life. He expanded the free lunch program, made free breakfast available to all students and put a strong emphasis on student and

family social and emotional health. The school district responded with its highest-ever graduation rate and a renewed sense of pride in the city and school district.

A standout student-athlete at Clear Fork High School, Ute graduated in 1980 and played basketball at Ashland University, where he earned a bachelor's degree in business administration and marketing. He would later return to Ashland to earn a master's degree in school administration, graduate teaching degree in business, principal's license and superintendent's license.

Ute and his wife, **Kory**, have four children and eight grandchildren.

OHIO BOARDS OF DISTINCTION AWARD

The Ohio Boards of Distinction Award honors school boards that have engaged in activities and modeled behaviors that lead to excellence in local school district governance in support of quality education. The qualifications include requirements for each member of the board to participate in training or service as well as a commitment by the full board to engage in activities such as strategic planning and board self-assessment to help guide the direction of the district.

The cycle for the Ohio Boards of Distinction Award begins every two years in January immediately following board of education elections as school boards form new leadership teams. The current cycle begins in January 2022 and culminates at the 2023 OSBA Capital Conference. The award will be presented at the end of the cycle and districts may receive the award only once during the period.

WHITNEY AWARDED CHAMPION OF PUBLIC EDUCATION

2016 marked the creation of the Central Region's Champion of Public Education Award. The Central Region

Executive Committee established the award to recognize public servants who have a demonstrated career history of supporting and advocating for public education. This award marks our region's third recognition honoring individuals.

A practicing criminal law attorney, **Robert Whitney** is the board president of **Lexington Local** (Richland). Appointed to the board of education in April 1964, Whitney has served on the board for 58 consecutive years, and his influence on the district has been significant. He has proven to be a fierce advocate for students during this tenure. Whitney serves with passion for the Lexington community.

While his time on the board has been a long journey, he says it's also been a great one. Most proud of the district's success and its improvement over the years, Whitney attributes this success to students and families, staff and administration, and board members who serve for the right reasons.

Whitney said, "It's been fun – especially when you have good board companions and leaders." Through the years, he's has had the occasion to serve with his older son for several terms and now with his grandson. He's served with the former superintendent of Lexington who was the superintendent of schools when he graduated from high school and his high school history teacher.

OSBA STAR Award Winners

Each year the Ohio School Boards
Association presents awards to board
members across the state who
demonstrate dedication to selfimprovement, service to their
association and work on behalf of
their own board. 2021 marked the
first year that OSBA recognized board
members who earned points towards
service and training in our new STAR
Awards Program—
Service, Training, Aptitude
and Recognition.



The OSBA Service Award was presented to a very select group. Of the more than 3,400 board members in Ohio, only 28 received the honor in 2021 and six of those recipients were from the Central Region. The following members received their Aptitude Award: Lee Schreiner, South-Western City; Dick Smith, Sue Devine and Nan Savidge, Marysville EV; and former board member Rick Weininger, Dublin City.

Only five members in the state received the STAR Recognition award in 2021 and two of these members hail from the Central Region: **Lee Schreiner**, South-Western City, and **Dick Smith**, Marysville EV.

STAR AWARDS

To recognize school board members for the time they spend improving their boardmanship and leadership skills, the STAR recognition program was developed.

Four awards comprise the program: service, training, aptitude and recognition. Previously, points for activities related to service and training were used for the Award of Achievement and Master Board Member honors. Now, the Service and Training awards have been separated based on the type of activity.

Service: Points for the Service Award accrue from local school board, district, region and state leadership, including service on OSBA committees and local board offices and committees. The Service Award requires 150 points to be earned within a three-year period. This award does not require an application; the board member will be notified when he or she has earned the requisite points.

Training: Points for the Training Award are earned from professional development events and activities delivered by OSBA or the National School Boards Association (NSBA). The Training Award requires 200 points earned over a three-year period. This award does not require an application; the board member will be notified when he or she has earned the requisite points.

Aptitude: A new category, the Aptitude Award, requires a board member to demonstrate an understanding and comprehension of a variety of board governance skills based on six leadership areas: vision, accountability, policy, community engagement, relationships and advocacy. To receive this award, board members must receive an 80% passing score on an online assessment. The assessment will be offered in June and July and may be taken multiple times by a board member who does not receive an 80% score and wants to try again during the annual assessment period.

Recognition: A board member may be nominated for the Recognition Award by his or her own school board by a majority vote of the board. This award replaces the previous Outstanding Board Member Award and honors board members most dedicated to the craft of being a model board member.
