# Treasurer Search

## Application deadline: August 30, 2025

The Board of Education will be accepting application materials until August 30, 2025, with plans to have a candidate in place by November 30, 2025, if not earlier.

Norwood City Schools has embraced and benefited from stability in our top ranks, bolstered by the long-term contracts that have led to the current combined 15 years of service between the Treasurer and Superintendent.

Other facts, features and attractions for Norwood and our schools:

- The District includes three square miles, all of that is within the City of Norwood in Hamilton County, Southwest Ohio.
- The district has four elementary schools, Norwood View, Williams Avenue, Sharpsburg Elementary and Norwood Montessori, one middle school and one high school.
- Three of the district's elementary schools and the middle school are historical buildings that have been completely updated and are the pride of Norwood.
- 40% of school staffers are also residents they have chosen to both work and live here.
- Norwood honors its legacy many of our students are third of fourth generation
- Norwood welcomes the new 70% of the city's residents have arrived since 2010.
- Norwood supports its schools, with passage of the last three levies.



#### **Qualifications:**

The Norwood City School Board of Education encourages qualified applicants who have experience in the position of either Treasurer or Assistant Treasurer for a minimum of three years to apply for this position. We welcome applicants that could collaborate with the Superintendent and other administrative team members, form strong partnerships with the Board of Education, to teach, advocate, guide, supervise, and delegate as necessary for the success of the district. The Board of Education believes in fiscal stability and transparency.

The new treasurer should hold a treasurer's license from the State of Ohio or be able to obtain one by the January 1, 2026, deadline.

The new treasurer should be able to demonstrate accomplishments in the following areas:

- Understanding of Ohio school law and public-school financing
- Maintain fiscal credibility and serve as the district's fiscal expert
- Must have demonstrated experience in sound financial management practices.
- Must have excellent analytical skills and good communication skills.
- Must be able to explain/teach complicated fiscal terms, revenue complexities, and budget issues.
- Organizational skills, collaboration, integrity, enthusiasm, energy and positivity are character traits that will serve well the new treasurer.
- The district offers a competitive wage and benefits package.
