- Can embrace a role requiring high levels of visibility, engagement and outreach with committee members and district stakeholders and is an articulate communicator with distinct groups as well as with individuals who have questions or desire information from the treasurer's office.
- Can articulate the district's financial position to board members, staff, and to the public, and to alter presentation details to the audience.
- Has a commitment to strong, positive board/treasurer relations, and to a similar partnership with the superintendent.

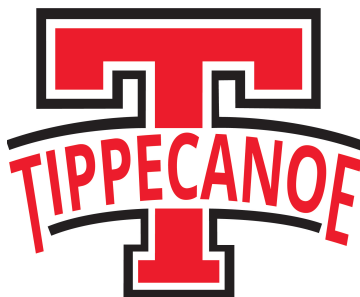
